## **Abstract**

### ORDER

M/s. Yesoraminfra Developers Private Limited submitted a proposal to Government for giving clearances to the Yesoram Skycity project at Kochi, Ernakulam District as per the letter read above.

- 2. Government have examined the proposal in detail and are pleased to give clearance to the Yesoram Skycity Project subject to the following conditions:
  - i. The company will fully comply with all Laws, Rules and Regulations in force such as Coastal Regulation Zone, Kerala Municipality Building Rules etc and obtain necessary licences, No Objection Certificates and clearances as per rules.
  - ii. For permitting the use of extremely valuable water body in the city, Government will have 26% equity in the project. Out of this 11 % of the equity will come as free equity to Government. Balance 15% will be subscribed by Government and Government related agencies such as Greater Cochin Development Authority (GCDA), Goshree Islands Development Authority (GIDA), the Corporation, other Local Self Governments, Kerala State Industrial Development Corporation (KSIDC), Kerala Industrial Infrastructure Development Corporation (KINFRA), Infrastructures Kerala Limited (INKEL), Cochin International Airport Limited (CIAL) etc. 23% of the Shares will be offered to general public, especially small investors with a cut off date, preference being given to the people of Cochin City and surrounding areas. The Company will be a public limited company.
  - iii. In order to improve the attractiveness of the proposal to the public, walkways, running tracks, cycle tracks and public gardens will be created preferably on the top of the building roof by interconnecting the buildings.
  - iv. Government will constitute a multi disciplinary team to advise on the project.

- v. After commissioning the project, a small portion of revenue will be set apart for cleaning the water body and improving the ecology and environment of the surroundings.
- vi. The Company will provide its own facilities for power, air conditioning, rain water harvesting etc. It will incorporate use of solar power and other green concepts in the building.
- vii. The promoter will execute an agreement with Government agreeing to the terms and conditions.
- viii. In order to facilitate the construction, Government will issue an order giving the minimum land required over the water body to construct the pillars of the bridge and landing for structures on lease for a period of 99 years. At the end of the concession period, the agreement will be renegotiated.
  - ix. After Government grants all clearances, the promoter should achieve financial closure within 2 years. In the event of any failure by the firm to do so, Government will reserve the right to modify, cancel or find another promoter for the project.
  - x. Government will constitute a senior level committee for the constant monitoring of the project.
  - xi. A Single Window Clearance mechanism will also be constituted to give clearances on a time bound basis for the project.
