(എ)&(ബി) വ്യവസായ വകുപ്പിന്റെ അധീനതയിലുള്ള പൊതുമേഖലാ സ്ഥാപനങ്ങളുടെ പ്രവർത്തനം മെച്ചപ്പെടുത്തുന്നതിനായുള്ള പദ്ധതികൾക്കായി 2011-12 സാമ്പത്തിക വർഷത്തിൽ ബഡ്ജറ്റിൽ അനുവദിച്ച 54.10 കോടി രൂപയിൽ മുഴുവൻ തുകയും കമ്പനികളുടെ വിവിധ പദ്ധതികൾക്കായി അനുവദിച്ചുകഴിഞ്ഞു. ഇതിൽ നിന്നും 30.78 കോടി രൂപ ഇതിനോടകം സ്ഥാപനങ്ങൾക്ക് വിതരണം നടത്തിക്കഴിഞ്ഞു. ബാക്കിയുള്ള തുകയും കമ്പനികൾക്ക് വിതരണം ചെയ്യുന്നതിനുള്ള നടപടിക്രമങ്ങൾ സ്വീകരിച്ചിട്ടുണ്ട്.
