I am to invite your attention to the references cited, and to inform you that Co-operative Medical Colleges and all Self financing Medical Colleges, except those who comes under the Inter Church Council, have executed agreement with the Government to make admission to 50% Medical PG seats from the Government Merit list. As per letter referred 3rd above, Academy of Medical Sciences, Pariyaram has surrendered 4 seats to Government Merit Quota with specification of fee structure for the courses (Copy enclosed). In addition to the above you are requested to take one seat each in MS General Surgery, MD Physiology and DGO courses in Government Merit Quota from the Academy of Medical Sciences, Pariyaram with the fee suggested by the management, after giving prior information to the management.

You are also requested to take 50% of the PG seats sanctioned to other Self financing Medical Colleges (Except the colleges under Inter

Church Council) by the Medical Council of India. You are requested to prepare and publish a separate distribution chart of the seats taken from Self financing and Co-operative Medical Colleges by observing norms for community reservation rotation as being done for Government Medical College seats. The allotment shall be made to these seats only after obtaining confirmation from the Kerala University of Health Sciences to the effect that the University has granted affiliation to these courses. The fee of the above said seats shall be applicable as suggested by the Managements.

The above said instructions shall be done immediately under intimation to Government.

ORDER

As per Clause 9 of the Postgraduate Medical Education Regulations, 2000 of Medical Council India, in non-Governmental institutions fifty percent of the total seats shall be filled by the competent authority and the remaining fifty percent by the management of the institution on the basis of merit. Hence 50% seats of the Self Financing Colleges (Medical and Dental) have to be surrendered to Government merit quota candidates.

In the past, 2nd round allotment of Government merit seats in Government/Self Financing Institutions was done after All India Quota was finalised so as to include the seats surrendered from All India Quota in the pool available for allotment to merit candidates. The cut off date for the PG admission was fixed as 31st May of every year by the Hon'ble Supreme Court. However, the Hon'ble Supreme Court vide Order in WP(C) No.197/2011 dated 13.05.2011 has extended the period of 2nd round Counseling of All India Quota by 19.06.2011 this academic year. The entire process has to be completed before 30.06.2011.

The Counseling cannot be delayed till the All India Quota left over seats are available as it may not be possible to complete Counseling for all the eligible candidates as no time would be left to call candidates for seats for which short listed candidates do not join. It is the interest of the State and students to ensure that all the seats available for allotment by Government are filled with general merit candidates. Hence the Director of Medical Education is hereby directed to commence the process of the counseling and allotment to the remaining seats in Government Medical Colleges and the seats surrendered by the Self-Financing QW

Institutions to Government. The seats that are left unfilled after the 2nd round of Counseling will be taken up in the subsequent rounds as and when the seats surrendered from All India Quota is available for allotment. Mop-up counseling should be done to ensure that no seats are lost to General Merit candidates.

Methodology for sharing of seats between Self Financing Colleges and Government will be as follows

All subjects shall be ranked alphabetically and the seats allotted in each discipline for that college shall be listed against that subject. The first seat available on the first subject shall be allotted to the college and the next seat to Government. If there are odd number of seats in one subject, allotment of the first seat in the next subject will go to the agency (College or Government), who has not been allotted the last seat in the previous subject. To illustrate, if Anesthesia and Biochemistry are the consecutive subjects in the list and if there are three seats in both the subjects the first seat in Anesthesia will be allotted to the College, second to Government and third to the College. The First seat in Biochemistry will be allotted to Government, second to the College and the third to the Government.

After allotment in all the subjects have been done the total number of seats for Degree and Diploma courses (to be calculated separately), the first seat in next year's allotment will go to the agency that did not get the last seat in the last year.
