Sub: Complaint against the highhanded / atrocious actions of the Sub Inspector of Police, Ernakulam Central Station (Sri Ananthalal and Police the Constables accompanied him)

Sir.

We are residing in Apartment No. 14A, Ivory Heights, Parambithara Cross Road, Panampilly Nagar, Kochi - 682 036 along with our children - daughters - Ms. Zuhara Mehrin Rassi Mather, aged 15 years, and Khadija Mehnaz Rassi Mather, aged 9 years. Our children are studying in classes X and V respectively in Choice School. We are leading peaceful and decent life without any way involving in any illegal and illicit deals.

No. 1 amongst us was formerly a Director of Mather Projects Pvt. Ltd. Mr. Siraj Mather who is the first cousin of No. 1 amongst us (father's brother's son) was also a Director. These Directors were managing the affairs of the Company upon the instructions and guidance of the Chairman (Sri. K.M. Ibrahimkutty Mather), who is none other than the father of No. 1 amongst us. Another Director is brother of No. 1 amongst us i.e. Sri. Shaffi Mather. The Company and its sister concerns have got 12 cars. All of them were purchased with the financial assistance of banks. In all such financial facilities, Mr. Siraj Mather who was then a Director stood as the guarantor. The details of these cars are as under:

Of these cars KL-7-BL 8586, KL-7 BQ 8877, KL-7 BP-8877, KL-7-BR 4345 are retained in the possession of No. 1 amongst us and Mr. Siraj Mather. There occurred a rift between the Directors of Mather Projects Pvt. Ltd. and consequently we (Raffi Mather and Mr. Siraj Mather) resigned from the company on 20.6.2012.

Since then, we (Rassi Mather and Mr. Siraj Mather) have been doing business separately with the company that they have soated in the name and style – Asten Realtors Pvt. Ltd. After the resignation of No. 1 amongst us and Mr. Siraj Mather, the Chairman and Directors of Mather Projects Pvt. Ltd. started causing all sorts of harassments towards us.

The Chairman (Sri. K.M. Ibrahimkutty Mather) and the Directors of Mather Projects Pvt. Ltd. are propagating false propaganda against us and Mr. Siraj Mather by sending e-mails to customers and to the common relatives solely with the oblique motive to malign and tarnish our image and reputation in the public as well as in the circle of relatives.

Sri. K.M. Ibrahimkutty Mather and Mr. Shaffi Mather even openly proclaimed that No. 1 amongst us and Mr. Siraj Mather will be put under bars at any cost. Such an information was conveyed to our close relatives viz. Sri. Noorudheen Mather, Babu Mather, Mr. Noufal, ..., etc. and all of them are prepared to give solemn affirmation before Police or any authorities.

Sri. K.M. Ibrahimkutty Mather is the General Secretary of Kerala Pradesh Congress Committee and he is in charge of co-ordination of Congress Party with the Ministry. Mr. Shaffi Mather is the Economic Advisor of the Chief Minister of the State. Mrs. Jebi Mather is the newly elected Secretary of Youth Congress. These persons taking undue advantage of their positions started instigating the Police officials to implicate us (No. I amongst us, Mr. Siraj Mather and the colleagues in our office). Considering their attitude hither to experienced since the resignation of No. I amongst us and Mr. Siraj Mather from Mather Projects Pvt. Ltd. is really inhumane and unfair. They did not even consider the blood relation that No. I amongst us and Mr. Siraj Mather have with them.

Mr. N. Asokan, Executive Director of Mather Projects Pvt. Ltd. appears to have lodged a complaint against us (No. 1 amongst us and Mr. Siraj Mather) stating that the vehicles - KL-7-BL 8526, KL-7 BQ 8877, KL-7 BP-8877, KL-7-BR 4345 are retained by its unauthorizedly. The

complaint itself will show that there is no serious allegations or disclosure of any controversial aspects therein.

In response to the complaint, when No. 1 amongst us was informed about the complaint, gave a written reply stating that of course the registered owner of the vehicles is Mather Projects Pvt. Ltd., to which we [No. 1 amongst us and Mr. Siraj Mather) were also Directors and they have been using these cars i.e. KL-7-BL 8586 and KL-7 BR 4345 by Mr. Siraj Mather and the other two cars viz. KL-7 BQ 8877 and KL-7 BP 8877 are being used by No. 1 amongst us only in that capacity. That there were mediation and conciliation proceedings due to the intervention of relatives and in the process of such conciliation (of course not concluded), the aforesaid cars were permitted to be retained by us (No. 1 amongst us and Mr. Siraj Mathers. Substantial amounts are due to Rassi Mather and Mr. Siraj Mather and only to wriggle out of such liabilities that the Executive Director - Mr. N. Assican had chosen to file a frivolous complaint against Mr. Siraj Mather and Raffi Mather. Absolutely no criminal offence was committed by them warranting investigation or criminal proceedings against us. The dispute between the current directors and the erstwhile directors (us) is essentially a civil dispute and consequently there is no justification to implicate Raffi Mather and Mr. Siraj Mather with any criminal difence with reference to the vehicles retained by them. A copy of the reply given to the Circle Inspector of Police, Ernakulam is attached herewith for reference. The receipt of reply was also acknowledged by the Circle Inspector of Police, Ernakulam Central.

No. I amongst us has recently cancelled the power of attorney taken from him by his father Mr. K.M. Ibrahimkutty Mather, when he was aged hardly 20 years. It was so cancelled by him noticing the malpractices and execution of various documents done by Mr. K.M. Ibrahimkutty Mather. No. I amongst us also gave a public notice about the cancellation of his power of attorney on 7.6.2013. Such safeguards and precautions taken by No. I amongst us appear to have annoyed Sri. K.M. Ibrahimkutty Mather and Shaffi Mather.

While matters stood so, Sub Inspector of Police, Ernakulam Central Station, who introduced his name as Mr. Ananthalal along with few Police constables evidently at the instance and undue influence exerted by Mr. K.M. Ibrahimkutty Mather and Mr. Shaffi Mather came to our residence (Apartment No. 14A, Ivory Heights, Parambithara Cross Road, Panampilly Nagar, Kochi - 682 036) by about 9 P.M. under the guise of serving a notice under Section 91 Cr. P.C. in Crime No. 1154/2013 in two jeeps. When the police group (in mufty) came at the downstairs of the apartment complex, the security personal of the Apartment Complex over phone informed about the arrival of the police team and we requested the police to come to our apartment. We were constrained to make such a request when the security personal informed us that the police party came at the downstairs created all sorts of nuisance and utterances to the security personal conveying him that they have come to arrest and took No. 1 amongst us into custody.

The police party came to our apartment and handed over a copy of undated notice purported to be under Section 91 Cr. P.C. addressed to No. 1 amongst us in his office address. The leader of the Police party introduced his name as Ananthalal, Sub Inspector of Police, Central Station. On seeing the police party at the odd hours, our children got perplexed and the neibouring residents started coming to our apartment and enquiring about the matter. No. 1 amongst us pleaded to the Sub Inspector of Police about the impropriety in coming to the house in the late hours of the day to serve a notice under Section 91, which is addressed to his office address. The Sub Inspector of Police on hearing the plea of No. 1 amongst us raised his voice and hand to beat him with the comment that they (police party) came to arrest him as well as Mr. Siraj Mather. He has been using filthin and applisive language towards us. The Sub Inspector of Police even uttered against No. 2 amongst us when she started enquiring about the matter. The reighbouring residents who have come to the scene also questioned the highhanded acts of the police and even conveyed to the police that they are not supposed to come to a house in odd hours that too upon a too trivial complaint. By the time our children started crying especially on account of the arrival of their friends from the neighbouring flats to witness the scene.

The attitude of the police party is really atrocious and clearly amounts to infringement of human rights as well as the civil rights of the citizens of the country. But for the interference of the neighbouring residents, the police party would have manhandled and taken No. 1 amongst us into custody.

We respectfully submit the police party indulged in such highhanded acts only on account of the undue influence exerted by Mr. K.M. Ibrahimkutty Mather and Mr. Shaffi Mather taking advantage of their political positions. We have all apprehensions that they may go to any extent to achieve their agenda to harass us and Mr. Siraj Mather by all possible mean methods. We have all reasons to apprehend that the police party may again come to our apartment or to the office to arrest us (No. I amongst us and Mr. Siraj Mather). The Sub Inspector of Police left the place with the threat that he will come again with a search warrant and that there are large number of cases against us filed by Mather Projects Pvt. Ltd. and its Directors and therefore he can come every day to our residence under the guise of investigation and enquiry on such cases.

We (No. 1 amongst us and Mr. Siraj Mather) desire to make it clear that they are prepared to return the cars - KL-7-BL 8586, KL-7 BQ 8877, KL-7 BP-8877, KL-7-BR 4345 to Mather Projects Pvt. Ltd. if the company gives us a clearance that no liability would be fastened with reference to these vehicles either on us or on Mr. Siraj Mather and that Mr. Siraj Mather should be exonerated / released from the guaranteeship given to the banks.

The aforesaid grievances of ours being essentially against the police atrocities, we humbly request your good office to look into the matter and take appropriate action against the Sub Inspector of Police and the police constables referred to above.

We also request your good office to ensure that such highhanded actions should not be repeated hereafter and also afford us adequate police protection for our life and property from the hands of Mr. K.M. Ibrahimkutty Mather and Mr. Shaffi Mather as they may stoop to any level to harass us.

Please oblige.
