ORDER

As per the Government order read as paper 2 above, sanction was accorded to replicate the Akshaya Project in the remaining Six Districts of the State, thereby covering the whole State.

2. Director, Kerala State IT Mission vide letter read as paper first above, based on the experiences of rollout in seven districts, has requested for modifications in the procedures and criteria for selection of capable Entrepreneurs having entrepreneurial aptitude and social commitments.

3. Government have examined the request in detail and are pleased to approve the modified selection process, revised application form and criteria for evaluation as appended to this Order as Annexure I, II, & III respectively.

4. Director, Kerala State IT Mission shall forward the revised format to all Local Self Government Institutions and District Collectors concerned.

State wide roll out of Akshaya project - Entrepreneur selection process

As the entrepreneurs are the backbone for the successful implementation of Akshaya Project in the State, due care is to be taken to ascertain the selection of suitable hands to set up Akshaya e-centres. Therefore a three tier process, as detailed below, may be undertaken for their selection.

It is proposed that after a preliminary screening of applicants based on the information furnished in the applications, may be called for a test followed by interviews at concerned LSGIs. The weightage proposed for different levels are given below.

Sl.No	Level	weightage
1	Screening of application based on the objective information about the applicant (Criteria attached as Annexure-1)	30%
2	Test to measure social entrepreneurship	40%
3	Interview	30%

The District Level Implementation Committee will be made the Appeal Committee regarding all matters pertaining to selection of entrepreneurs in a district.

It is proposed that the following Selection Committees shall be constituted by Government to interview and select the entrepreneurs. Individual Selection Committees at Grama panchayath/Municipality/ Corporation levels shall be set up by District Collectors as soon as the Government order constituting the Committees is issued. Conveners of the selection committees shall complete the interview process within the time frame stipulated by District Collectors.

Selection Committees

A. Grama Panchayaths

1. Grama Panchayath President - Chairman
2. District panchayath member representing the Grama Panchayath area.
3. Block Panchayath members representing the Grama Panchayath area.
4. Grama Panchayath Secretary - Convener.
5. Representative of lead bank /Service area Bank Manager
6. Representative of DIC/Akshaya Project Office

B. Corporation/Municipality

1. Corporation Mayor/Municipal Chairperson - Chairman
2. Councillor responsible for the implementation of Akshaya

3. Municipal Secretary/Corporation Secretary - Convenor.
 4. Representative of lead bank /Service area Bank Manager
 5. General Manager, District Industries Centre/Representative from Akshaya Project Office

Units that can be considered as Akshaya centres without going through the entrepreneur selection process

1. **Kudumbasree units:** If in any of the identified locations where Akshaya centres are proposed to be set up there exist a Kudumbasree IT unit having the specified hardware, software & space and also willing to operate as an Akshaya centre, then they may be selected to set up the Akshaya centre in that location. The District Mission Coordinators of Kudumbasree may identify those Kudumbasree IT units that can be converted into Akshaya centres against identified locations. The District Mission Coordinator shall ensure successful implementation of the Project in such locations including time bound completion of e-literacy training and rolling out of second level services/courses.
2. **Computer centres under LSGIs:** If in any of the identified locations where Akshaya centres are proposed to be set up there exist a computer centre under LSGIs having the specified hardware, software & space for operating an Akshaya centre, then the centre can be selected as an Akshaya centre by the LSGIs. Local bodies willing to convert their computer centres as Akshaya centres may inform the District Collector (Secretary DPC & Chief Coordinator Akshaya) for approval. The Secretary of the local body shall ensure smooth functioning of such centres including time bound completion of e-literacy training and rolling out of second level services/courses.

Selection Procedure for entrepreneurs

Level 1 :- Application processing

1. Issue of district level advertisement inviting application from entrepreneurs indicating the locations for starting Akshaya centres (details of preliminary Akshaya briefing to be included).
(Action - Kerala State IT Mission (KSITM)).
2. An official poster will be displayed in every LSGIs indicating the locations under the LSGIs. Notices with details of Akshaya and date and time of preliminary briefing will be made available in the local body office (with Akshaya Nodal Officer).
(Action - Akshaya District Office)
3. Announcement of dates for preliminary briefing on the website and through press releases in all papers through DIO (PRD) and district wise preliminary briefing to prospective Akshaya entrepreneurs.
(Action - KSITM)
4. Online applications from prospective entrepreneurs (after briefing). The applications will be entered online by the entrepreneurs at available kiosks or at the Akshaya helpdesk in Akshaya District

Offices/FRIENDS Countors etc. After submitting the application online, a printout of the same should be taken. The printout, duly signed, should be forwarded to *The Director, Akshaya State Project Office, Hill View, Near BSNL Office, Althatra Junction, Vellayambalam (P O), Thiruvananthapuram - 10* along with a non-refundable DD for Rs. 250/- in the name of Director, Kerala State IT Mission payable at Trivandrum on or before the last date announced. An individual can apply for maximum three different locations, however he/she shall be granted only one location for setting up Akshaya centre.

5. Preliminary screening will be done on prefixed criteria. A minimum of 30 marks out of a total of 100 marks would be required for passing the preliminary screening.
(Action - KSITM)

Level 2:- Test

6. All candidates selected after preliminary screening will be called for the test at selected centres to assess their social entrepreneurship aptitude.
(Action - KSITM)
7. Based on the weightage on preliminary screening and written test, candidates would be short listed for interview. However, the number of short listed candidates for any one centre will be restricted to ten¹.
(Action - KSITM)
8. List of short listed candidates along with their marks and application forms will be forwarded to Selection Committee convenors by District Collectors.
(Action - District Collector)

Level 3 :- Interview

9. District Collectors shall announce through a press release that the short listing is completed and the location wise final lists for interview shall publish in all the local body offices. District Coordinator shall also publish the list in the District Akshaya Office.
(Action - District Collector/ District Coordinator)
10. The Selection Committee convenors have to ensure that all the Committee members are informed about the interview and that the selection interviews are conducted on the scheduled dates itself. The Convenors shall verify all relevant certificates and records of the candidates to validate his/her claim in the application form. Discrepancies of any nature or lack of supporting certificates & documents regarding the information provided by the candidate in the application will make his candidature null and void.
(Action - Selection Committee Convenor)

¹ In case many candidates have the highest marks, then all of them will be included and in case this number exceeds ten, no others with lesser marks will be short listed. If there is more than one candidate with second highest marks and if the short listed candidates on account of highest mark has not equalled or exceed ten candidates, then all of them will be included. Same rule will hold true for others up to the tenth highest marks.

11. The Selection Committees shall consider the following:

- Entrepreneur's general ability to run the centre; especially evaluating their managerial, marketing, administration and financial skills etc and his/her relationship with local communities, local acceptance and social commitments etc.

(Attention – Selection Committee Convenor).

12. The Selection Committee shall rank the entrepreneurs immediately after the interview and the convenor shall get the list signed by all members of the Committee there itself. Convenors of selection Committees shall forward LSGI wise – centre wise list of selected entrepreneurs along with interview marks to District Collectors latest by the day after the interview.
(Action – Selection Committee Convenor).

13. District Collectors shall take steps to recheck the list based on the marks provided during interview and publish the provisional rank list of successful candidates immediately at the office of DPO and Akshaya District Office. The list may also be forwarded to the Kerala State IT Mission for next level activities.
(Action – District Collector)

14. The provisional rank list can be checked by the candidates and in the case of any difference of opinion or disputes, appeal can be filed before the Appeal Committee within seven days from the date of publishing of provisional rank list by the District Collector.

15. On receiving any appeal from the candidates, the Appeal Committee shall take appropriate decision on the appeal by considering all aspects within two weeks time. The decisions of the Appeal Committee shall be final and binding for all parties concerned.
(Action – District Collector)

16. Location wise rank list of selected candidates shall be finalised after the period stipulated for appeal and shall be published in local bodies as well as in District Planning Office and Akshaya District Office.
(Action – District Collector)

Norms for selecting Akshaya entrepreneurs in Locations where entrepreneurs are not identified through first phase selection process

17. If in any location/s suitable entrepreneur are not identified through the above selection process or if the selected entrepreneur/s are terminated due to valid reasons, then a new selection process to identify suitable entrepreneur/s is to be initiated at local body level. For the purpose, following steps shall be followed.

- As soon as the first level selection process is completed or as and when such a situation arises, the Akshaya District Office shall prepare a list of such locations citing valid reasons for second level selection process.
- The list shall be submitted to District Collector for approval and shall be forwarded to concerned local bodies.
- The local bodies shall give sufficient publicity inviting applications from prospective entrepreneurs to start Akshaya e-centres in the locations.
- Entrepreneurs shall submit application/s as per the procedures stipulated above under section: 4.
- The applicants shall be short listed as per the criteria prescribed under section: 5 above and shall be called for a test at a convenient location as fixed by District Office of Akshaya on consultation with State Office.
- All other norms prescribed above for the selection of entrepreneurs such as weightage for application, test & interview and selection committee, appeal committee etc shall be valid for the second level selection process also.
- After interview the provisional rank list shall be submitted to District Collector for approval and shall be published at concerned local bodies and Akshaya District Office.
- Akshaya District Office shall prepare the final rank list after considering appeal and shall publish at concerned local bodies and Akshaya District Office.
