



POLICE DEPARTMENT - OPENING OF NEENDAKARA COASTAL POLICE STATION- PROVIDING  
MANPOWER-CREATION OF POSTS OF ASIs- SANCTIONED-ORDERS ISSUED.

ORDER

The Government of India (Ministry of Home Affairs) have accorded sanction for the setting up of 8 coastal police stations in Kerala at Vizhinjam, Neendakara, Thottappally, Fort Kochi, Kodungalloor, Beypoor, Azhikkal and Bekkal.

2. The coastal police are required to handle crime in every form in the territorial waters in their jurisdiction including infiltration, illegal cross border activities, piracy, armed robbery etc. They will have jurisdiction over the territorial waters up to 12 nautical miles from the coastline and also over a small extent of coastal land.

3. The Director General of Police has informed that Jeeps, Motor Cycles, Computers and other infrastructure facilities required for the Neendakara Police Station have already been procured by utilizing the grant from the Government of India. Manpower for the Coastal Police Station has been trained at the Coast Guard Training Center, Fort Kochi and is ready for posting and the coastal police Station is now ready for opening. The required strength of Neendakara Police Station is One Circle Inspector of Police, 3 SIs, 3 ASIs, 9 HCs, 30 PCs, 6 Boat Drivers, 6 Lascars, 6 Syrangs, 2 Jeep Drivers and one part time sweeper. To meet this requirement, he had proposed to re deploy the posts of 1 API, 3 APSIs, 9 HCs, 30 PCs, 2 Jeep drivers and 1 CF from the Kerala Rifles and 6 boat drivers, 6 Lascars and 6 syrangs from the Kerala Marines and to create the posts of 3 ASIs.

4. Government have examined the proposal in detail and are pleased to accord sanction for creating 3 posts of ASIs in addition to the redeployment from the Kerala Rifles and the Kerala Marines proposed above for providing the required manpower to the Neendakara Coastal Police Station.

5. The Expenditure in this regard will be met from the H/A "2055-00-112-98 Coastal Police Station"

Home Department - Police Establishment - Coastal Police Stations - Creation  
of posts of technical crew for the boats allotted to the Coastal Police Stations -  
Sanctioned - Orders issued.

2. Letter No.S1-43581/06 dated 6.2.2007 and No.S3/23391/09 dated 24.4.2009, 19.5.2009, 28.5.2009 and the letter dated 8.12.2009 from the Director General of Police, Thiruvananthapuram.

ORDER

Government of India had sanctioned 8 Coastal Police Stations for Kerala under the Coastal Security Scheme. Government of India will meet the non-recurring expenditure involved in buildings, vehicles, vessels, equipment, arms and other essential items and also recurring expenditure for a period of 5 years for fuel, maintenance and repairs of the vessels purchased under the scheme. The manpower component has to be provided by the State.

2. The manpower required for each Coastal Police Station is CI-1, SI-3, ASI-3, HC-9, PC-30, Boat Driver-6, Lascar-6, Syrang-6, Jeep Driver-2 and PTS-1. Thus the total number required for 8 Coastal Police Stations will be CIs-8, SIs-24, ASIs-24, HCs-72, PCs-240, Boat Drivers-48, Lascars-48, Syrangs-48, Jeep Drivers-16 and Part Time Sweepers-8.

3. For providing the manpower to all the 8 Coastal Police Stations, the DGP had made the following proposal.

i. By merging the posts available in the 4 range offices of the Kerala Marines SIs-12, HCs-24, PCs-48, Boat Drivers-24, Boat Lascar-24, Syrang-24, Jeep Driver-4.

ii. By merging the posts available in the Marine Enforcement Department. Chief Guard (DySP)-1, Inspector of Guard-3, SIs of Guard-6, Head Guard (HC)-12, Fisheries Guard (PC)-38.

iii. Redeploying the posts of APIs-5, APSIs-6, HCs-36, PCs-154, Driver PCs-12 and CF-18 available in the Kerala Rifles.

iv. By creating the balance requirement of ASIs - 24, Boat Driver -24, Lascar -24 and Syrang -24.

4. Meanwhile the Neendakara Coastal Police Station was made functional and the required manpower was provided by creating 3 posts of ASIs vide GO read as 1<sup>st</sup> paper above and the balance of CI-1, SI-3, HC-9, PC-30, Boat Driver-6, Lascar-6, Syrang-6, Jeep Driver-2 and Part Time Sweeper-1 by redeploying from the posts available in Kerala Rifles and Kerala Marines.

5. The Director General of Police has further proposed to create 21 posts of Master Drivers (ASI rank) deducting the ASI posts already proposed and also requested to redesignate the 3 ASI posts created for Neendakara Coastal Police Station as Master Drivers (ASI rank).

6. The Director General of Police has now reported that one Boat each has been received by the Neendakara and Beypore Stations and 2 Boats are ready for the Fort Kochi Station. According to the schedule provided by the Ministry of Home Affairs, the delivery of the boats are expected shortly. The recruitment process after receipt of the Boats would be a self-defeating exercise since it would take sometime for selecting qualified persons and during that time the stations would remain non-operational compromising the security of the Coast. For the purpose he has proposed for the creation of 21 posts of Master Drivers (ASI rank) and 24 posts each of Boat Drivers, Syrangs and Lascars by meeting the expenditure from the Head of Account "2055-112-98- Coastal Police Stations" and the balance requirement by merging the posts available in the Kerala Marines & Marine Enforcement Department and by redeploying the posts available in the Kerala Rifles and also to re-designate the 3 posts of ASIs created for Neendakara Coastal Police Station vide Government Order read as 1<sup>st</sup> paper above as Master Drivers.

7. Government had examined the proposal in detail and are pleased to accord sanction for the creation of 21 posts of Master Drivers in the rank of Additional Sub Inspectors of Police and 24 posts of Boat Drivers, 24 Lascars and 24 Syrangs for meeting the balance requirement of Technical crew for the boats of the Coastal Police Stations after merging the available posts in Kerala Marines, Marine Enforcement and Kerala Rifles, subject to the condition that the manpower so provided will be utilized as per the requirement of each

Coastal Police Station at required time only. Sanction is also accorded for the re-designating the 3 posts of Additional Sub Inspectors created as per Government Order read as T paper above as Master Drivers (ASIRank).
