വിദ്യാഭ്യാസ നിധാനങ്ങളിലെ വാഹനങ്ങളിൽ ധാരാ ചെയ്യുന്ന കൂട്ടികൾക്ക് സുരക്ഷ ഉറപ്പാക്കാൻ നടപടികൾ സ്വീകരിക്കാത്തവർക്കെതിരെ എന്നു നടപടികളാണ് സ്വീകരിച്ചുവരുന്നത് ; വിശദമാക്കാമോ ?

വിദ്യാഭ്യാസ നിധാനങ്ങളിലെ വാഹനങ്ങളിൽ ധാരാ ചെയ്യുന്ന കൂട്ടികൾക്ക് സുരക്ഷ ഉറപ്പ് വരുത്തുന്നുണ്ടോ എന്ന് പരിശോധിക്കുന്നതിനുള്ള നിർദ്ദേശങ്ങൾ ഉൾക്കൊള്ളിച്ചുകൊണ്ട് സംശയാന പോലീസ് മേധാവി നം. 6/11 പ്രകാരം സർക്കുലർ പുരാപ്പെടുവിച്ചിട്ടുണ്ട്. (അനുബന്ധമായി ചേർക്കുന്നു.) പ്രസ്തുത സർക്കുലർ നിർദ്ദേശമനുസരിച്ച് ബന്ധപ്പെട്ട പോലീസുദ്ദോഗമർ സ്കൂൾ വാഹനങ്ങളെ പരിശോധന വിധേയമാക്കി സ്കൂൾക്കാർക്കെതിരെ കേസുകൾ രജിസ്ട്രി ചെയ്യുന്നതിനുള്ള നിയമമനുസരിച്ച് കർശന നടപടികൾ സ്വീകരിച്ചുവരുന്നു. സ്കൂൾ കൂട്ടികളുടെ സുരക്ഷ ഉറപ്പ് വരുത്തുന്നതിനായി വിദ്യാഭ്യാസ നിധാനങ്ങളിലെ വാഹനങ്ങൾ ഗതാഗതവകുപ്പും കർശനമായി പരിശോധിക്കുന്നുണ്ട്.

സ്കൂളിന്റെ സ്വന്തം വാഹനങ്ങളിൽ ഉള്ള ജീവനക്കാരുടെ കൃത്യവിലോപം ശ്രദ്ധയിൽപ്പെട്ടാണ് സ്കൂൾ അധികൃതർ നടപടി എടുക്കേണ്ടതാണ് എന്ന് നിർദ്ദേശം നൽകിയിട്ടുണ്ട്.

Sub: Safety measures to be taken to prevent accidents of vehicles carrying school children - Reg.

- 1) Vehicles carrying school children to and from school are involved in accidents frequently, resulting in deaths and serious injuries. One such incident is one which occurred at Karikkakom in Thiruvananthapuram city in which 14 nursery students died. The following instructions are issued as part of its efforts to avert the recurrence of such incidents.
- 2) All SHOs are directed to take adequate and proper steps to conduct checks, in coordination with Motor Vehicle Department to see the compliance of the following instructions issued by the State Transport Authority with regard to buses of Educational Institutions:-
 - (i) The bus belonging to or hired by an Educational Institution shall be driven by a driver who has more than 10 years of driving experience.
 - (ii) The driver should not have been punished at any time for rash and negligent driving or drunken driving.
 - (iii) Omni Buses used as buses of Educational Institution shall be fitted with Speed Governor conforming to the prescribed standards for restricting speed to 40 km/hr.
 - (iv) An able bodied attendant for each door should be available for the safe boarding, carriage and alighting of the students.
 - (v) The number of passengers carried shall not exceed the limitation prescribed in rule 7.1 of E47 Rules.
 - (vi) The buses shall be provided with shutter for each door.
- 3) It is noticed that a large number of vehicles which are actually engaged in carrying children to School are not having the license plates required by the Schools and do not fall within the purview of the laws and conditions applicable to School buses. They include Mini Buses, Vans, Light vehicles and Auto Rickshaws. They are being engaged by the parents independently and there is no effective control over these vehicles regarding over-loading, conduct of drivers etc. It is highly essential to regulate the vehicles carrying schoolchildren to school and back.

- 4) SHOs of all Police Stations shall identify all the schools within their jurisdiction where classes from Kindergarten to 10th Standard are held and thereafter convene the meeting of the Principals/Headmasters at the end of the month of April/May every year and brief them about security aspects relating to traffic safety especially with regard to very young children. The S.H.O. shall also be present at such a meeting.
- 5) Each School may nominate one or more persons to be known as the "School Safety Officer". They shall be responsible for the safety of students to the school and back. They shall, if necessary, take steps to ensure that no vehicle used for collective transportation of children exceeds the maximum number of the vehicles and the names of drivers of the vehicles shall be communicated by such officer and entered in a register. The S.H.C. shall visit the Police stations regularly and get a copy of the list and verify the names of drivers and the qualifications of drivers. This is important not only from the traffic safety point of view, but also from the point of view other crimes involving children.
- 6) The Principals/Headmasters may also be requested to advise the parents about the risks to which their wards are exposed. They may be advised to avoid sending children in vehicles which are over-crowded or with drivers who are not mature and who are total strangers.
- 7) The School Safety Officer shall also be advised to report to the Police about any violation of traffic safety regulations or misconduct by the drivers of the vehicles carrying children. His contact telephone number must be known to the S.H.O. and the Station Staff.
- 8) SHOs shall frequently conduct surprise checks in front of the Schools during the arrival and departure times of students to detect any instances of overcrowding or rash driving. But at the same time, care should be taken to avoid the students being stranded on the roads while taking action against the drivers of vehicles.
- 9) Senior Officers visiting / inspecting the Police Stations shall verify and ensure that adequate steps are taken by the S.H.C. to prevent accidents of vehicles carrying school children.
- 10) The above instructions are issued in order to enable police to effectively discharge functions necessitated by section 38, 39 and 61 of Kerala Police Act 2010.
