## ORDER

In supersession of all the previous orders issued on the subject, Government prescribe the following rates of rent for occupation of rooms in the Kerala House, New Delhi.

——1. The allotments in Kerala House shall be made on bed basis. For family members one room alone will be allotted irrespective of number of members.

 $\Box$ 

"Family" for the purpose of this order will means spouse, children, dependant parents and dependant brother and sister.

- 3. The family of the guests under category A (i) whether accompanying them or not, shall be accommodated free of charges. The family of the guests coming under categories A (ii) to (v) when accompanying the guests shall be charged Rs.50 per bed if the guests are on official visits. In case of the guests being on private visits, the accompanying family will have to pay at the same rates as the guests themselves. The family unaccompanied by guests falling under categories A. (ii) to (iv) shall be clarged at the same rates as applicable to the officers on private visits. Children below the age of 12 years when accompanying their parents will be accommodated free of rent.
- 4. 5 days accommodation alone will be allowed for private visits.
- 6. Officers coming on Central deputation to the Central Government and its Offices/Organizations in New Delhi and Officers/Officials of Covernment of Kerala coming to Kerala House, New Delhi on posting in any office of Government of Kerala by transfer or deputation will not be permitted to stay for more than 90 days. The rate charged would be same as applicable to State Government officers on duty. Full rent will be charged beyond the period of 90 days.
- The VIP rooms will be allotted only to the Governor, Chief Minister, Chief Justice and Judges of Supreme Court and the High Court of Kerala, Ministers, Leader of Opposition. Speaker, Deputy Speaker. G vernment Chief Whip, Vice Chairman of State Planning Board, "hicf Secretary, Ex-Chief Ministers of Kerala and Vice Chairman, CAT, Fruel-ulm.
- 7. Accommodation in Main Block of Kerala House will be given to categories A, B & C, subject to availability.
- Freedom Fighters from Kerala will be provided accommodation at 50% of the prevailing rate of category C.
- 9. The eligible dignitaries (when not provided with VIP rooms), sitting MLAs, Ex-Ministers, Advocate Generals, Chairperson and M-mbers of State Commissions, Vice Chancellors of various Universities of Kerala, Accountant Generals, Kerala, Secretaries to the Government and officers drawing basic pay equal to or more than the minimum of the scale of pay of the Additional Secretary to Government of Kerala will be provided with rooms on a non-sharing basis, without any additional charge.

- 10. One escent each accompanying the blind officers will be granted concession as eligible to the family members of the State Government Officers.
- and have to accommodate a companion with him/her, the companion may also be charged at the same rates applicable to the family members of MLAs/Ex. MLAs/Ex. MPs.
- 12. Candidates coming to Delhi from Kerala for attending interviews conducted by the Union Public Service Commission in Delhi will be allowed concessional rates applicable to the State Government officials up to a maximum period of 7 days. In case of Female candidates, the concession shall be extended to their Father/Mother/Brother/Husband. Persons accompanying other candidates will be charged private rates.
- TV charges is fixed as ₹ 10 per bed per day.
- 14. Two newspaper (one Malayalam and one English) will be provided for each bed and would be charged Rs.10 per bed. Additional newspaper would be charged extra € ₹ 5 per newspaper.
- (5. Telephone charge is fixed as ₹ 1 per call per minute for all categories except category A (i).
- 16. No modifications shall be made to the reservations made by General Administration (Political) Department for Dormitory, Additional Block and Main Block, under any circumstances.

- The check-involttime for Kerala House and Travancore House Dormitories shall be 6.00 pm.
- 18. No room rem shall be charged for stay for less than 4 hours for categories. A(ii) and A(iii). Short stay shall not be permitted to other categories.
- 19. Government reserves the right to modify or cancel any of the reservation without prior notice in the event of official exigencies, without stating the grounds.

## ORDER

Commissioner, Revala House, New Delhi vide order read as paper I above. The Essident Commissioner, Kerala House, New Delhi has experienced earlain difficulties regarding room allotment while making the new order into implementation phase and nave reported the same to Government vide his letter read as paper 2 above.

- 2. Government, after examining the matter in detail are pleased to make the following modifications in continuation to the prevailing Government Order read as paper 1 above.
- (i) The domnitary accommodation charges for private visits shall be 7 150/bed per day.
- (ii) Note 3 in the existing G.O. shall completely be modified and read as Children below the age of 12 years when accompanying their parents will be accommodated free of rent. Other provessing in Note 3 stands deleted.
- iii) One companion accompanying the MLAs/Ex. MLAs/Ex. Ml' shall be charged ₹ 500, that only in the absence of family members.

GCPT, 3/4875/2011/DTP.

- (iv) The Chief Justice, High Court of Kerala and Government Chief Whip will come under category A (i).
- (v) Private accommodations beyond the span of five days shall be charged double rent from the sixth day onwards.
- (vi) Officers on central government deputation shall pay an amount of ₹ 90 towards their accommodation charges at Keraja House during their official visits.
- (vii) The Chief Secretary to Government of Kerala and Vice Chairman, Kerala State Planning Board will come under category A (ii).
- (viii) Officers from CAPE and Regional Cancer Centre, Thirnvananthapurum will also be included under category B (i).
- (ix) The Chairmen, Members and officers of all the statutory bodies and the Deputy Accountant Generals, Kerala will come under category A (iii).
- (x) Officers from Deordarshan Kendra and All India Radio who are working in Kerala will come under category B (ii).
- (xi) Only one room will be allotted for visit with family on concessional rate and in exceptional cases a second room will be a allotted on demand @ ₹ 500 subject to availability of spare rooms. No farther rooms will be allotted beyond that limit.
- (xii) State Government Officers while on training at Delhi and are offered with accommodation by the training institute will have to pay the charges applicable to them on private visits, if they avail accommodation at Kerala House, New Delhi during training period.
- (xiii) The check out time for Kerala House, New Delhi will be calculated as 24 hours from the time of occupation or its multiples, as the case may be.
- 3. The above modifications will come into force from the 1st day of lanuary, 2012 onwards.

The Controller, Kerala House, New Delhi vide his letter read as 3rd paper above, requested Government to enhance the rate of rent of Travancore House Dormitory from the existing ₹150 (Rupees One hundred and fifty only) to ₹250 (Rupees Two hundred and fifty only), once the Air-Conditioning is provided in the Dormitory.

2. Government have examined the matter in detail and are pleased to enhance the rate of rent of Travancore House Dormitory from the existing ₹ 150 (Rupees One hundred and fifty only) to ₹ 250 (Rupees Two hundred and fifty only) per day for the stay of private persons (Category D). For other concessional categories from A to C as mentioned in the Government Order read as paper 1 above the rate of rent is re-fixed as ₹ 75 (Rupees Seventy five only) per day for their private stay.

## ORDER

Government have revised the rates of rent and other services of Kerala House, New Delhi vide order read as paper 1 above. The Resident Commissioner Kerala House, New Delhi has experienced certain difficulties regarding room allot tent while making the new order into implementation phase and have reported the same to Government and vide GO read as paper 2 above some modifications have been made in the original Order.

- 2. Now the Resident Commissioner points out some more discrepancies, after examining the matter in detail Government are pleased to rectify those defects too by modifying the GO read as paper 2 above as follows.
- (i) The dormitory accommodation rates for guests under category 'D' shall be Rs. 150/- per bed per day and for others it shall be Rs. 50/.
- (ii) Note 3 in the existing GO shall completely be modified and read as the family un accompanied by Guests falling under categories A(ii) to (iv) shall be charged at the same rates as applicable to the officers on private visits. Children below the age of 12 years when accompanying their parents will be accommodated free of rent.

- TV charges shall be fixed as Rs. 10/- day for a room. If the room is (iii) allotted on twin sharing basis for two different parties, the TV charges will be extracted @ Rs.5/- day per bed.
- 3. The above modifications will come into force from the Ist day of January, 2012 onwards.
