NOTIFICATION

KSE Board vide notification No.PSI/3146/83 dated 29.04.1985 issued regulations regarding the appointment of Dependants of Board Employees who die in harness or are permanently disabled and are retiring on invalid pension. The above regulations had been subsequently amended vide Notifications No.616 (PSI/3146/83) dated 01.04.1992 & No. PSI/3146/83 dated 01.07.1992. The Government vide notification No. G.O. (MS) No.9/2008/PD dated 28.04.2008 have made certain amendments in the Kerala Public Service Commission (Additional Functions) (Consultation) Rules, 1966 for specific application of the same in KSE Board. Accordingly, KSE Board hereby makes the following Regulations further to amend the conditions regarding the appointment of Dependants of Board Employees who die in harness or are permanently disabled and are retiring on invalid pension and notify the same.

Regulations

I. Short title and commencement

- (1) These Regulations may be called the KSE Board (Appointment of Dependants of Board Employees who die-in-harness or are permanently disabled and are retiring on invalid pension) Amendment Regulations 2011.
- (2) They shall come into force from the date of this Notification.

II. Amendment of the Regulations

For clause (I) of Regulation 4, the following Clause shall be substituted namely:-

"(I) in regard to the appointment in service to one of the posts in the Class III/Class IV posts in the subordinate services, last grade service and in part-time contingent service for which direct recruitment is made from the dependants of the Board employees, who died-in-harness or who availed of invalid pension out of 100% permanent disability from accidents that arise out of and in the course of employment while in service, within the maximum age fixed for direct employment for different categories, provided the person concerned possesses the minimum qualification prescribed for the post and the family income of the deceased/disabled Board employee shall not exceed ₹ 3,00,000 (Rupees three lakh only) per annum or the limit prescribed by Government from time to time to its employees. The following relatives of the employees deceased/disabled while in service of the Board will be considered as the dependants, who are eligible for the employment assistance in the order of priority as indicated below:

- 1. Widow/Widower
- 2. Son
- 3. Daughter

In the case of unmarried Board employee dying-in-harness, the following relatives will be considered as the dependants who are eligible for employment assistance.

- 1. Father/Mother
- 2. Unmarried Sister/Unmarried Brother
- Note 1: Son and Daughter shall include adopted son and adopted daughter respectively and will come after son/daughter.
- Note 2: Wherever there is a dispute between the claims of two dependants, the person recommended by the widow/widower of the deceased/disabled Board employee shall be preferred. In the case of dependants other than widow/widower the consent of the widow/widower shall invariably be obtained.
- Note 3: In the case of appointment to widow/widower and in the case of Father/Mother of Unmarried Board employee who die-in-harness and also in the case of appointment to part-time contingent posts, there shall be no upper age restriction ie., applicants shall be given appointment up to the age of retirement. In all other cases the upper age limit prescribed for direct recruitment to the post shall apply.
