ORDER

Government have approved the Prospectus KEAM 2015 for Admission to Professional Degree Courses (Medical, Agriculture, Veterinary, Fisheries, Engineering & Architecture Courses) for the year 2015, vide G.O read as first paper above.

As per letter read as fourth paper above , the Secretary ,Kerala Self Financing Engineering College Managements' Association has requested Government to change the eligibility criteria for admission under Management quota seats in Private Self Financing Engineering Colleges as per the AICTE norms .

Government have Examined the matter in detail and are pleased to change the eligibility criteria for admission under Management quota seats in Private Self Financing Engineering Colleges as per AICTE norms .Accordingly Clause 6.2.2 (a) of the Prospectus for the KEAM 2015 is modified as :

Candidates who have passed Higher Secondary Examination , Kerala , or Examinations recognized as equivalent thereto ,with 50 % marks in Mathematics separately ,and 50 % marks in Mathematics ,Physics and Chemistry put together are eligible for admission .However candidates who have passed Higher Secondary Examination ,Kerala , or Examinations recognized as equivalent thereto ,with 45 % marks in Mathematics ,Physics and Chemistry put together are eligible for admission

under Management Quota in Private Self Financing Engineering Colleges . In case ,the candidate has not studied Chemistry ,the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and Computer Science ,the marks obtained in Biotechnology shall be considered. In case , the candidate has not studied Chemistry ,Computer Science and Biotechnology , the marks obtained in Biology shall be considered .The marks as shown in the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility . This amendment can be made where ever applicable in the Prospectus.

There is no change in clause 6.2.2(i), (ii) & 6.2.2 (b) of the Prospectus KEAM 2015.
