Subject: -Withdrawal of NOC accorded for setting up of a New Greenfield Airport at Aranmula in Pathanamthitta District of Kerala by M/s KGS Aranmula Airport Ltd.

This is in continuation to letter of even number dt. 24.08.2011 wherein NOC for setting up of a New Greenfield Airport at Aranmula in Pathanamthitta District of Kerala by M/s KGS Aranmula Airport Ltd. was accorded.

- The above mentioned NOC was granted by this Ministry subject to the condition that 2. no objection/ clearance from other Government Organizations/ agencies/ local bodies concerned, as may be required will also be obtained prior to setting up of a New Greenfield Airport at Aranmula in Pathanamthitta District of Kerala by M/s KGS Aranmula Airport Ltd. However, the National Green Tribunal has cancelled the Environment Clearance accorded by the Ministry of Environment and Forest and the Hon'ble Supreme Court has also dismissed the appeals of M/s Aranmula Airport Ltd. against the judgment of NGT. M/s Aranmula Airport Ltd. has already got fair opportunity of being heard before the National Green Tribunal & Supreme Court.
- Thus, there is non-compliance with the conditions that were imposed while issuing the Therefore, on account of non-compliance of the conditions, the NOC accorded vide letter of even number dt. 24.08.2011by Ministry of Defence for setting up of a New Greenfield Airport at Aranmula in Pathanamthitta District of Kerala by M/s KGS Aranmula Airport Ltd. is hereby withdrawan with immediate effect.
