C&MD KPHCC Ltd vide letter 3rd cited has put for the suggestion for changing of allocated units of Residential and Non Residential buildings based on the hike of unit cost on the Plinth area rate. The above suggestions of C&MD KPHCC have been examined in detailed and reply was furnished to KPHCC vide PHQ letter 4th cited. Since MHA has already been approved the scheme, changing are not possible on the same now. Therefore, KPHCC has again requested to utilize the available funds and by building the maximum area possible as per PWD norms by strictly follow the expenditure norms approved by Government for PWD and you may please adjust the size of the building within the allotted amount.

Therefore, it has been decided/sanction is hereby accorded to utilize an amount of ₹80,00,000/-(Rupees Eighty Lakhs Only)[@ ₹ 6.67 Lakhs (Approx.) each] for the construction of 12 Nos. of Police Circle Offices/Sub Divisional Police Offices as follows.
