

ORDER

In the Government Order read as 1st paper above, Government have appointed the 10th Pay Revision Commission to study and make recommendations on revising the pay and allowances and other benefits of Government employees, staff of educational institutions, local bodies etc and the tenure was fixed for a period of six months. 28 temporary posts were created for a tenure of six months for the functioning of the Commission vide the Government Order read as 2nd above, which expired on 16.11.2014. Later as per the Government Orders read as 3rd and 4th above, the tenure of the Commission was extended up to 04.12.2014 and up to 30.06.2015 respectively. Now the Member Secretary, 10th Pay Revision Commission, in the letter read above, has requested to extend the tenure of the Commission for a further period of five months up to 30.11.2015 to complete its assignment and to extend the term of the following staff upto the expiry of the tenure of the Commission.
