- iv) To channelise the subsidies from State Government as well as Central Government for Infrastructure projects.
- v) To liaison with Financial Institutions, Bankers, Venture Capitalists and negotiate speedy disbursements of the financial assistance.
- vi) To liaison with various departments in the State Government as well as Central Government clearances, permissions such as CRZ, Pollution Control Board, Revenue Authorities etc.
- vii) To rationalize the investment opportunities and finalise the locations and destinations investments.
- viii) To market the new projects at National and International level aggressively as part of Tourism Promotion.
