Government, as per the references cited, have issued orders revising pay and allowances of State Government Employees, Staff of Educational Institutions, Teachers, University Employees etc. For the first time, new scales of pay have been sanctioned to part-time contingent employees. A large number of representations/enquiries have been received from individuals, service organizations and Heads of Departments seeking clarification regarding the pay fixation of part-time contingent employees. In view of this, Government are pleased to issue the following clarifications in this regard.

2. As per para 9 of Pay Revision Order cited above, three scales of pay have been newly introduced for different categories of Part-time Contingent Employees. The categories, rate of remuneration during 2004 Pay Revision and the new scales of pay eligible for each category are as follows:

- 3. The existing Part-time Contingent Employees will come over to the newly introduced scales of pay and the pay will be fixed at the minimum of the scale of pay eligible for each category w.e.f. 1-7-2009. In the case of those who have been drawing the basic remuneration and an additional increase of Rs. 150, Rs. 150, Rs. 100 for completed years of 8, 16 and 23 years respectively as per the 2004 pay revision, such quantum of increase will be added to the minimum of the scale of pay of the respective categories and pay will be fixed at the next stage in the newly introduced scales of pay. Even if it is a stage in the new scale, next stage will be allowed. By the above fixation, a minimum benefit of Rs. 300 should be ensured. The minimum benefit of Rs. 300 may be calculated by deducting the remuneration which the employee was eligible during 2004 Pay Revision, from the revised pay as on 1-7-2009 calculated as above.
- 4. The next increment falls on completion of one year from the date of fixation of pay and in successive years accordingly. The revised scale of pay and allowances may be granted in cash from February, 2011. Arrears of salary on fixation of pay in the revised pay scale from 1-7-2009 till 31-1-2011 may be credited to the Provident Fund account of the employee.
- 5. A ready reckoner for the fixation of pay of all the three categories of Part-time Contingent Employees is appended.

In the letter read as 1st paper above, the Accountant General (A&E), Kerala, Thiruvananthapuram has raised a doubt as to whether an officer who got promotion prior to 1-7-2009 but opted fixation under Rule 28 A Part I KSRs on the date of the increments in the lower post which fell due on or after 1-7-2009 can opt beyond that for coming over to the revised scale.

2. Government have examined the matter in detail. Promotions involving change of duties take effect from the date of assumption of charge in the higher post and those, which do not involve a change of duty, take effect from the date of occurrence of vacancy, and so the date of accrual of increment in the lower post opted for fixation of pay under Rule 28 A Part I KSRs cannot be taken as the effective date of promotion. Hence, Government are pleased to clarify that an officer promoted prior to 1-7-2009, who opted fixation of pay under Rule 28A Part I KSRs on the date of increment in the lower post which fell due on or after 1-7-2009 will not be treated as having promoted on or after 1-7-2009 and he can exercise option to come over to the revised scale

O. read above. After having examined the matter, the Government are pleased to incorporate the following note under para 15 (page 5) of the G. O. cited since the criteria for consideration of B2 Class cities for the purpose of HRA and CCA is the same.
