#### ORDER

As per Government Order read as first paper above, the minimum salary of the employees of recognised Unaided Schools, in Kerala has been fixed. The Recognised School Teachers Union requested Government to issue orders to revise the service conditions and salary of teachers in the unaided sector of the State. Considering their request, Government have appointed a two member committee to study the problems in this sector including revision of salary as per Government Order read as 2<sup>nd</sup> paper above.

2. The committee submitted their report to Government. A meeting of the representatives of the organizations and the Managers' Associations were held. But a unanimous opinion cannot be taken in the matter of service, salary and fee in the unaided structure. Government have examined the report further and found that all the recommendations cannot be accepted, except the recommendation in regard to the revision of salary of teaching & non-teaching staff.

- 3. Mean while the Hon'ble High Court in their Judgment dated 30-3-2009 in W.P. © No. 2287/09 directed the Government to consider the report submitted by the committee appointed as per G.O. (Ms.) No. 117/2007/G.Edn. dated 22-6-2007 and take a decision in the matter after notice to the service organizations representing the teaching and non-teaching staff of recognized unaided schools and also the representatives of the management.
- 4. Considering the request of the R.S.T.U., and in compliance of the Judgment Hon'ble High Court read as 3<sup>rd</sup> paper above Government have decided to revise the salary of teaching/non-teaching staff of the unsided sector w.e.f. 1-1-2011 as follows:
