ORDER

In the revised Budget Speech for 2011-12, it was announced that Kerala State Housing Development Finance Corporation (KSHDFC) will be formed for the State by mobilizing resources from agencies like National Housing Banks, for providing financial assistance to various house construction agencies and individuals, at a reasonable rate of interest and ₹1 Crore will be allocated for the formation of this Corporation.

2) On the basis of this, Shri. V. Unnikrishnan, Executive Engineer of Kerala State Housing Board was appointed as nodal officer to prepare a project report for the formation of the Corporation. He submitted the project report to Government.

3) After examining the project report in detail, Government have decided to approve the formation of the Corporation and order as follows:-

- a) The company/corporation shall be registered in the name as "Kerala State Housing Development Finance Corporation Limited" (KSHDFC) with its Headquarters at Thiruvananthapuram.
- b) The corporation shall have an initial paid up capital of ₹ 1 Crore announced in the revised budget 2011-12 and an authorized capital of ₹10 Crore.
- c) The Corporation shall be incorporated as a Public Limited Company with 100% holding by Government in the beginning and further to the incorporation, 74% can be allotted to public/private corporates/entrepreneurs retaining 26% equity by Government.
- d) There shall be seven (7) promoters for the corporation of which three shall be Directors. The following officers are nominated as promoters of the corporation:-

- 1) Chief Secretary
- 2) Secretary, Housing
- 3) Secretary, Finance
- 4) Secretary, Finance (Expenditure )
- 5) Secretary, Law
- 6) Secretary, Local Self Government
- 7) Housing Commissioner

Of the above officers the Chief Secretary, Secretary, Housing and Secretary, Finance are nominated as the Directors of the Company.

- 3) A practicing Company Secretary will be engaged for filing applications with the Registrar of Companies under Ministry of Corporate Affairs for incorporation of the Company and allied matters.
- 4) The share holding patterns of the Corporation will be finalized at the time of preparation of Memorandum and Articles of Association and necessary further orders in this regard will be issued separately.
- 5) The Special Officer will initiate further action in this matter.


