#### ORDER

The Ministry of Health and Family Welfare, Government of India has notified the National Board of Examinations (NBE) for conducting National Eligibility -cum -Entrance Test for Post Graduate Medical Courses and the National Board of Examinations (NBE) has issued Notification for conducting National Eligibility -cum-Entrance Test-PG (NEET-PG) for admission to various MD/MS and Post Graduate Diploma Courses for the year 2013. As per the Notification, NEET-PG is a mandatory test for obtaining admission to Post Graduate Medical Courses at Medical Colleges/institutions running under the ambit of Post Graduate Medical Regulations 2000 of the Medical Council of India.

The State Government have already expressed the willingness to participate in the NEET-PG for the year 2013 to the Central Government and the Medical Council of India.

In the circumstances, Government are pleased to issue the following guidelines.

 The admission to Post Graduate Medical courses in the Medical Colleges/Institutions in the State from the academic year 2013 will be on the basis of the National Eligibility-cum-Entrance Test-PG (NEET-PG). The PG Medical aspirant candidates from the State shall have to

- participate in NEET-PG and obtain minimum eligibility marks as prescribed, for getting admission to Post Graduate Medical Courses.
- The Prospectus for admission to Post Graduate Medical courses shall be issued by the Director of Medical Education with the approval of the Government every year.
- The Commissioner for Entrance Examinations shall be the authority for conducting the admission and allotment in the State Quota seats in P.G. Degree / Diploma courses from the year 2013 onwards, observing the prevalling reservation principles for admissions. The Director of Medical Education shall furnish the necessary details regarding admission to the Commissioner for Entrance Examinations, if required any.
- The Commissioner for Entrance Examinations shall give wide publicity regarding the schedule of application/examination of NEET-PG and NEET-UG as prescribed by the National Board of Examinations/Central Board of Secondary Education and the necessary instructions to the PG/UG Medical aspirant candidates, through the Official Website, Print and Visual Media.

### <u>ORDER</u>

The Ministry of Health and Family Welfare, Government of India has notified the Central Board of Secondary Education (CBSE) for conducting National Eligibility -cum -Entrance Test for Under Graduate Medical Courses (MBBS &BDS) and the Central Board of Secondary Education (CBSE) has issued Notification for conducting National Eligibility -cum- Entrance Test-UG (NEET-UG) for admission to MBBS and BDS Courses for the year 2013. As per the Notification, NEET-UG is a mandatory test for obtaining admission to Under Graduate Medical Courses at Medical Colleges/institutions.

- 2. The State Government have already expressed the willingness to participate in the NEET-UG for the year 2013 to the Central Government and the Medical Council of India.
- 3. In the circumstances, Government are pleased to issue the following Orders.
  - The admission to Under Graduate Medical courses (MBBS and BDS) in the Medical Colleges/Institutions in the State from the academic year 2013 will be on the basis of the National Eligibility-cum-Entrance Test-UG (NEET-UG). The students who wish to get admission for MBBS/BDS

- courses in Kerala shall have to participate in NEET-UG and obtain. minimum eligibility marks as prescribed, for getting admission to MBBS/BDS Courses.
- The Commissioner for Entrance Examinations shall be the authority for conducting the admission and allotment in the State Quota seats in MBBS/BDS courses from the year 2013 onwards, observing the prevailing reservation principles for admissions. The Commissioner for Entrance Examinations will issue Prospectus for admission to MBBS and BDS Courses in consultation with the Director of Medical Education and with the approval of Government.
- All the candidates who seek admission for MBBS/BDS Courses 2013 under NEET (UG)-2013, should also apply for allotment/admission to the
- Commissioner for Entrance Examinations indicating their Application Number and other available particulars of NEET (UG)-2013.
- Only one application needs to be submitted by the students for applying for the Common Entrance Examination under KEAM-2013 and for allotment/admission for MBBS/BDS Courses under NEET (UG)-2013.
- A separate Centralized Allotment Process will be conducted by the Commissioner for Entrance Examinations for MBBS/BDS Courses as per the rank list of NEET (UG)=2013.
- The students who are included in the rank list of NEET (UG)-2013 for the State of Kerala, furnished by the CBSE, will only be considered for the allotment of seats in MBBS/BDS Courses. Such candidates should prove their nativity status as per the KEAM Prospectus 2013.
- Students who claim Kerala nativity status in the NEET (UG)-2013, should furnish community, income and nativity certificates in original along with the application for KEAM-2013 for admission to MBBS/BDS Courses for claiming various community/category reservations. Self attested photocopies of other certificates, if any, need be furnished for other purposes.
- A copy of the confirmation page' which can be downloaded from the Website of the CBSE while submitting the application for NEET (UG)-2013 should be enclosed along with the application submitted to the
