ORD<u>ER</u>

In exercise of the powers conferred by Section 3 of University Grants Commission Act 1956, the Central Government, on the advice of the University Grants Commission as per notification read as first paper above declared Kerala Kalamandalam, Thrissur, Kerala as Deemed to be University for the purpose of the aforesaid Act, provisionally for a period of 5 years, Memorandum Of Association and Rules by Kerala Kalamandalam and their approval by Central Govt and granting UGC's pay scales to its employees with effect from the date of submission of application for deemed to be University status. Government of Kerala had approved the MOA and Rules of Kerala Kalamandalam Deemed University for Arts and Culture, Thrissur as per Government Order read as second paper above.

- 2. The Vice Chancellor, KKMDU vide letters read second paper above had submitted proposal for implementing the UGC scales clearly identifying the posts which are required for running Under graduate, Post Graduate and research programmes. He had also communicated its norms approved by the Executive Committee based on which the staff eligible for UGC scales were to be identified. There is also a proposal for creating more additional posts for running Graduate, Post graduate and creation of non teaching staff.
- 3. Government have examined the matter in detail and are pleased to approve the criteria for placing the existing Teaching staff of Deemed University for Arts and Culture, Thrissur on UGC Scale of pay which is appended as Annexure I.
- 33 (thirty three) 4. In accordance with the norms, fixed in Annexure I, only teachers (list appended as Annexure II). are eligible for U.G.C Scale as on

1/6/2007. Sanction is accorded to pay UGC scale from 1.6.2007 to the eligible teachers noted in Annexure II.

5. Although 7 posts of lecturers are proposed to be created for Degree Courses there is no urgency to create the posts for the subjects of Chutti, Kutiyattam (male), Thullal and Mizhavu. One post of lecturer has to be created in each of the general subjects (English, Malayalam and Sanskrit) as there are no language teachers at present, therefore, sanction is accorded for creating the following posts to meet the requirements of the degree courses.

8. The above 14 posts will be filled by deputation or with internal candidates for which appropriate orders will be issued in due course.

9. Other allowances like HRA, CCA etc shall be as applicable to that of the

State employees.

10. The pay in the UGC scale shall be paid in cash with effect from Ist March 2011. The arrears of pay with effect from 1.6.2007 will be remitted in the Provident Fund.

11. The Registrar, Kerala Kalamandalam Deemed University must ensure that the newly appointing teachers should have the qualifications as per the UGC norms.
