- Affithe State Governments and union ferritories are due ted to depute plain clothed female police officers in the precincts of busstands and stops, railway stations, metro stations, cinema theatrey shopping mails parks beached public service vehicles planet of worship eaclisp as to monitor and supervise incidents of everteasing
- 2. There will be a further direction to the State Government and Union Territories to install CCTV in strategic positions which itself would be a deterrent and if detected, the offender could be caught
- 3. Persons in-charge of the educational institutions, places of worship, cinema theatres, railway stational bus-stands have to take steps as they deem fit to prevent eve-teasing, within their precincts and, on a complaint being made, they must pass on the information to the nearest police station or the Women's Help Centre.
- 4. Where any incident of eve-teasing is committed in a public service vehicle either by the passengers or the persons in charge of the vehicle, the crew of such vehicle shall, on a complaint made by the aggrieved person, take such vehicle to the nearest police station and give information to the police Failure to do so should lead to cancellation of the permit to piy
- 5. State Governments and Union Territories are directed to establish Women' Helpline in various cities and towns so as to curb eve-teasing within three months.
- Suitable boards cautioning such act of eve-teasing be exhibited in all public places including precincts of educational institutions, our stands, railway stations, cinema theatres, parties, beaches, public service vehicles, places of worship etc.
- 7. Responsibility is also on the passers-by and on noticing such incident, they should also report the same to the nearest police station or to Women Helpline to save the victims from such crimes.
- 8. The State Governments and Union Territories of India would take adequate and effective measures by issuing suitable instructions to the concerned authorities including the District Collectors and the District Superintendent of Police so as to take effective and proper measures to curb such incidents of everteasing.

This is in continuation with PHQ letter cited 3°. Judgment of Hon'ble Supreme Court of India dated, 30.11.12 in Civil Appeal No. 8513/12 received vide the reference Z^d cited has been communicated to all District Police Chiefs for strict compliance of Hon'ble Court directives. They have been directed to issue necessary instructions to their subordinates and ensure that the directions of the Hon'ble Supreme Court are enforced in the State, in letter and spirit. District Police Chiefs have reported that the Judgment has been communicated to their subordinate staff and directed them to comply with the Hon'ble Court directions. Based on the reports received from the District Police Chiefs, the compliance report on the judgment of Hon'ble Supreme Court is furnished below.

male Police Personnel were deputed in plain clothes in the precincts of Bus Stand Railway Standas conems theatres shopping belief parks worship places and other crowded places to monitor and present the incidents of eve teasing

- Closen Circuit Security Cameras have been installed in some important functions to observe and take necessary steps to patch the offenders Measures are taken to install more OCTV Cameras in all important junctions in each Police Circles
- 3. Notices along with copies of Hon'ble Supreme Court Judgment has been issued to persons in charge of Educational Institutions, Worship places, Bus Stands and Cinema Theatres by SHOs with a direction to report the incidents or complaints immediately to the nearest Police Station.
- 4. Notices and guidelines have been issued by SHOs to all the owners of Public Transport vehicles, Bus drivers and conductors to report any incident in this regard without delay.
- 5. Women Help Desk are now functioning in all Police Stations for the help of women victims.
- 6. Instructions have been given to all Police Inspectors and SHOs for rerecting boards cautioning such act of eve teasing at educational institutions, bus stands, Rail way stations, cinema theaters etc.
- 7. Awareness classes are being conducted to the public also in this regard. Instructions given to all SHOs to conduct awareness programmes and huge publicity through 'Janamythri' and Jagratha Samithies'.
