



ORDER

Sri. N. Venugopalan Nair was superseded from the select list of Deputy Tahsildars earlier due to the reason that criminal case and disciplinary action were pending against him. He submitted a representation dated 02.03.2013 before the Commissioner of Land Revenue (Annexure A3) to include his name in the select list of Deputy Tahsildars since he was acquitted from the criminal case registered against him and also the disciplinary action initiated against him had been cancelled. The Commissioner of Land Revenue's order had cumulative affect. He also filed O.A. No. 540/2013 before Hon'ble Kerala Administrative Tribunal with the same prayer. The Hon'ble Kerala Administrative Tribunal, as per Order read as 1st paper above, directed the 2nd respondent (the Commissioner of Land Revenue) to consider and pass orders on Annexure A3 representation in accordance with law after affording an opportunity of being heard to the applicant within 2 months from the date of receipt of copy of the order. It is also ordered that even if the applicant retired in the meantime, his claim for retrospective promotion as Tahsildar and consequential further promotion shall not be denied on the ground that he has retired from service, if he is otherwise eligible for the same.

Consequently the adhoc DPC (Lower) held on 29.04.2013 at 11 am had decided to restore his original seniority position in the select list of eligible Deputy Tahsildars for promotion to the cadre of Tahsildars for the year 2007 as Serial No. 73 A (Rank No.3089) in between Sri. M.K. Sreedharan Nair (serial No. 73) and Sri. Jayakumar (Serial No. 74). Notification in this regard was published vide proceedings read as 2nd paper above. As per this notification, Sri. N. Venugopalan Nair is eligible for retrospective promotion to the cadre of Tahsildar.

The DPC (Higher) meeting in the Land Revenue Department was held on 29.04.2013 at 03.30 pm in the chamber of the Chairman, for drawing the select list of eligible Tahsildars for 'by transfer appointment' to the cadre of

Deputy Collector. The name of Sri. N. Venugopalan Nair was not considered by the DPC (Higher) since he was not included in the field of choice of eligible officers for by transfer appointment to the cadre of Deputy Collector, because his original seniority position in the cadre of Tahsildar has not been restored and his probation in the Tahsildar cadre has not been declared by the Commissioner of Land Revenue. Accordingly the select list of eligible Tahsildars for 'by transfer appointment' to the cadre of Deputy Collector was published as per Notification read as 3rd paper above excluding Sri. N. Venugopalan Nair and promotions were ordered as per Government Order read as 4th paper above.

Sri. N. Venugopalan Nair, Tahsildar has submitted representation read as 5th paper above stating that it is not his fault that his probation in the cadre of Tahsildar is not declared yet. So he requested to promote him to the cadre of Deputy Collector since he due to retire from service on 31.05.2013.

Government have considered the representation for non declaration of probation in the cadre of Tahsildar. His junior Sri. Jayakumaran was promoted to the cadre of Deputy Collector as per Government Order read as 4th paper above. The probation of Sri. N. Venugopalan Nair in the cadre of Tahsildar is not declared for no fault of him but for the lapse on the part of the Commissioner of Land Revenue to regularize his temporary promotions based on the select lists. He is to retire from service on 31.05.2013 and is eligible to be included in the select list of Tahsildar for the year 2013. There is no sufficient time to convene an adhoc DPC (Higher) meeting before his retirement.


In the circumstances, Government are pleased to order that Sri. N. Venugopalan Nair, Tahsildar is temporarily promoted to the cadre of Deputy Collector in the cadre of Deputy Collector (with C/L) vide Government Order No. 38840 (revised) under Rule 10(a) part II KS&SSRs as a special case. He is posted as Deputy Collector (Election), Wayanad in the existing vacancy.






