ORDER

In the Government Order read as 1st paper above, Government have laid down guidelines on implementation of the scheme of Special Development Fund for MLAs (MLA-SDF). These guidelines permit, among other things, purchase of Audio Visual equipments of educational nature for Government recognised Aided and Unaided Educational Institutions using the MLA-SDF.

- 2. As per the instructions issued in the Circular 2rd read above, Government have permitted utilization of the funds for providing library books to Government and Aided Educational Institutions.
- 3. As per G.O. 3rd cited, Government have also permitted utilization of the MLA-SDF for providing computers to all Government and Aided Educational Institutions.
- 4. The Public Accounts Committee (2011-14) which reviewed with implementation of the MLA-SDF Scheme, has, in its 25th Report, recommended to Government to dispense with the practice of allocating funds to Aided/Un-Aided Educational Institutions under the MLA-SDF Scheme.
- 5. Government having considered the recommendations of the PAC, order that the Special Development Fund for MLAs (MLA-SDF) shall not hereafter be allocated to the Aided/Un-aided Educational Institutions for any purpose other than providing computers for Aided Educational Institutions ordered as per G.O. 3^{rc} cited.
- 6. The Orders/instructions in the Government Orders 1^{st} and 3^{rd} read above and Circular 2^{nd} read above will stand modified to the above extent.
