- 1. Examination fee to be paid is  $\stackrel{?}{_{\sim}} 400^\circ$  for 4 papers at the rate of  $\stackrel{?}{_{\sim}} 100$ /- for each paper .
- Late fee to be paid is ₹ 100 for 4 papers at the rate of ₹ 25/- for each paper.
- 3. Fees and Fines are to be remitted by way of DD from any nationalised bank drawn in favour of "The Secretary, Kerala Legislative Assembly" payable at Thiruvananthapuram or directly at Vikas bhavan branch of the State Bank of India in the Account No.37005174195 or by online transfer to the same account number with IFSC-SBIN0070415
- 4. Fees & Fines once paid shall not be refunded.
- 5. Application for examination has to be sent by Registered post with DD/Pay-in-slip/Online Transfer Receipt in original.
- Applications without DD/Pay-in-slip/Online transfer receipt towards examination fee and fines will be rejected.
- 7. Option for Centre of Examination shall be final and change of Examination Centre will not be permitted.
- Incomplete applications will be rejected.
- 9. Permission to appear for examination is subject to verification of all the certificates in original.
- 10. Examination can be written either in English or in Malayalam and the duration of Examination is two and a half hours.
