This report contains the observations, comments and recommendations of the Committee on SROs issued under the provisions of the Act.

This Report was finalised by the Committee at its meetings held on 6th September 2016.

## REPORT

### The Kerala Ground Water (Control and Regulation) Act, 2002

(Act 19 of 2002)

S.R.O. No. 116/2007 dated 6-2-2007

[G. O. (P) No. 10/2007/WRD dated 2-2-2007]

By this S.R.O., Government have extended the time-limit to apply for registration as a user of ground water for one year from the date of notification.

2. The Committee finds that in the fifth line of the S.R.O. the word 'Gazette' is omitted and wants the Department to correct the words 'the Kerala Government Extraordinary No.1333' as 'the Kerala Government Gazette Extraordinary No. 1333' and to issue an erratum accordingly.

3. The Committee observes Rule 17 of the Kerala Ground Water (Control and Regulation) Rules, 2004 (S.R.O. No. 256/2004) is not mentioned in this S.R.O. along with sub-section (1) of section 9 of the Act. The Committee is of the opinion that the relevant rules with which a user of the ground water need to apply for registration shall also be referred in the notification. Hence the Committee recommends that while issuing similar notifications, the relevant rules along with the section of the Act by which notification is published need be mentioned in the S.R.O.

4. The Committee finds that sub-section (1) of Section 9 of the Act which deals with the registration for every user of ground water was amended vide Act 22 of 2005. In the Act of 2002, the time limit for registration of user of ground water has been fixed as within 120 days from the date of the constitution of the State Ground Water Authority. By the amendment of 2005, the time limit for registration was provided as within such limit as may be notified by the Government.

5. The Committee finds that Section 8 deals with the registration of owners of the wells in the notified areas has to be registered within 120 days from the date of establishment of the State Ground Water Authority and the time limit had expired years back. The Committee observes the need for an amendment similar to the amendment Act 22 of 2005 for Section 8 also. The Committee feels irony for not amending Section 8 of the Act since new users of ground water in notified areas need to apply for registration or there is a chance of getting more areas to be notified in the future as 'notified areas'. Hence the Committee wants the Government to amend Section 8 of the Act in the same lines with which Section 9 has been amended.

6. During witness examination the Committee enquired whether any of the areas notified vide S.R.O. No. 1021/2005 has been denotified after noticing that the ground water level in those areas have improved due to various measures undertaken to recharge the Ground Water. The witness replied that of the five notified areas listed as per S.R.O. No. 1021/2005, the Ground Water level has improved in all areas except Chittoor Block. The Committee enquired the steps taken to denotify those areas and the witness replied according to the latest reports on Ground Water estimates received, steps had been initiated to denotify those areas which have improved the ground water level. The Committee needs the Department to take urgent steps to denotify areas other than Chittoor Block of Palakkad District. The Committee wants to be furnished with a report on the above matter and the copies of S.R.Os of the notification to that effect at the earliest.

7. By this S.R.O., Government has reconstituted the State Ground Water Authority in exercise of powers conferred by section 3 of the Act.

8. The Committee notices that most of the members nominated other than from state civil service are from the district of Kollam. The Committee further notes that no member has been nominated from Chittoor Block which is already a notified area under the Act. The Committee is of the opinion that the induction of a member representing the interests of the people belonging to the places where the misuse of ground water is rampant, would have been more appropriate in this context. Hence the Committee recommends to include members from the notified areas in the State Ground Water Authority when it is reconstituted.

9. By these notifications, Government has fixed the time limit for the registration as a user of ground water.

10. The Committee is of the opinion that the relevant rule shall also be quoted along with sub-section (1) of section 9 of the Act, by which the notification is issued. Hence the Committee recommends to include the relevant rule also while issuing notifications in future.

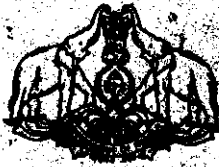
