## THE KERALA VETERINARY AND ANIMAL SCIENCES UNIVERSITY (AMENDMENT) BILL, 2019

(Report of the Subject Committee)

## THE KERALA VETERINARY AND ANIMAL SCIENCES UNIVERSITY (AMENDMENT) BILL, 2019

(As reported by the Subject Committee)

#### BILL

further to amend the Kerala Veterinary and Animal Sciences University Act, 2010.

Preamble.—WHEREAS, it is expedient further to amend the Kerala Veterinary and Animal Sciences University Act, 2010 (3 of 2011) for the purposes hereinafter appearing;

BE it enacted in the Seventieth Year of the Republic of India as follows:-

- 1. Short title and commencement.—(1) This Act may be called the Kerala Veterinary and Animal Sciences University (Amendment) Act, 2019.
- (2) It shall be deemed to have come into force on the 27th day of December, 2018.
- 2. Amendment of section 12.—In the Kerala Veterinary and Animal Sciences University Act, 2010 (3 of 2011), (hereinafter referred to as the principal Act) in sub-section (2) of section 12, item (iv) shall be omitted.
- 3. Repeal and saving.—(1) The Kerala Veterinary and Animal Sciences University (Amendment) Ordinance, 2019 (27 of 2019) is hereby repealed.
- (2) Notwithstanding such repeal, anything done or deemed to have been done or any action taken or deemed to have been taken under the principal Act, as amended by the said Ordinance shall be deemed to have been done or taken under the principal Act as amended by this Act.
