കേരള നിയമസഭയുടെ നടപടിക്രമവും കാര്യനിർവ്വഹണവും സംബന്ധിച്ച ചട്ടങ്ങൾക്ക് ഭേദഗതികൾ ശുപാർശ ചെയ്തുകൊണ്ടുള്ള ചട്ടങ്ങൾ സംബന്ധിച്ച സമിതിയുടെ മൂന്നാമത് റിപ്പോർട്ട് 2021 ജനുവരി 14-ാം തീയതി സഭയുടെ മേശപ്പുറത്ത് വെച്ചു. കേരള നിയമസഭയുടെ നടപടിക്രമവും കാര്യനിർവ്വഹണവും സംബന്ധിച്ച ചട്ടങ്ങളിലെ ചട്ടം 264 ഉപചട്ടം (1) പ്രകാരം റിപ്പോർട്ട് സഭയുടെ മേശപ്പുറത്ത് വെച്ചു തീയതി മുതൽ ഏഴ് ദിവസത്തിനുള്ളിൽ ഭേദഗതി നോട്ടീസുകൾ ലഭിച്ചിട്ടില്ല എന്നതിനാൽ ചട്ടം 264 ഉപചട്ടം (3) പ്രകാരം കമ്മിറ്റിയുടെ ശുപാർശകൾ സഭ അംഗീകരിച്ചതായി കരുതാവുന്നതാണ്.

## AMENDMENTS

### AMENDMENTS PROPOSED TO THE RULES OF PROCEDURE AND CONDUCT OF BUSINESS IN THE KERALA LEGISLATIVE ASSEMBLY BY THE RULES COMMITTEE (2019-2021) VIDE ITS THIRD REPORT

#### 1. Amendment to Rule 2

In sub-rule (1) of rule 2, after the definition of "Minister", the following definition shall be inserted, namely:-

" "Online" means the information/documents submitted or retrieved anywhere anytime using the login credentials through the digital platform provided by the Kerala Legislative Assembly; "

#### 2. Amendment to Rule 5

In rule 5, after the word "writing" the words "or online" shall be inserted.

#### 3. Amendment to Rule 15

In sub-rule (3) of rule 15, after the word "given" the words "in writing or online" shall be inserted.

#### 4. Amendment to Rule 40

In sub-rule (2) of rule 40, for the word "printed" the word "included" shall be substituted.

#### 5. Amendment to Rule 46

In rule 46, for the word "printed" the word "included" shall be substituted.

#### 6. Amendment to Rule 48

In sub-rule (1) of rule 48, the following proviso shall be inserted, namely:-

" Provided that more than one Member shall not give a single notice."

#### 7. Amendment to Rule 48

The sub-rule (5) of rule 48 shall be deleted.

#### 8. Amendment to Rule 49

In sub-rule (2) of rule 49, after the word " writing" the words " or online" shall be inserted.

9. Amendment to Rule 52

In item (x) of rule 52, after the word " writing" the words " or online" shall be inserted.

10. Amendment to Rule 58

In sub-rule (1) of rule 58, after the word " writing" the words " or online" shall be inserted.

11. Amendment to Rule 63

In item (b) to sub-rule (1) of rule 63, for the words "written notice" the words "notice in writing or online" shall be substituted.

12. Amendment to Rule 65

In sub-rule (1) of rule 65, after the word " writing" the words " or online" shall be inserted.

13. Amendment to Rule 131

In rule 131, after the word " writing" the words " or online" shall be inserted.

14. Amendment to Rule 168

In rule 168, the words "as per the provisions in rule 166 A" shall be added at the end.

15. Amendment to Rule 170

In sub-rule (1) of rule 170, after the word "writing" the words " or online" shall be inserted.

16. Amendment to Rule 185

In sub-rule (1) of rule 185, after the words "Members of the Committee" the words " including those who participate through video conferencing" shall be inserted.

17. Amendment to Rule 192

In rule 192, the following proviso shall be added, namely:-

" Provided that the venue of the sitting of a Committee held through video conferencing facility of the Kerala Legislative Assembly is deemed to have been held within the precincts of Legislature Secretariat."

18. Amendment to Rule 194

In sub-rule (1) of rule 194, the following shall be added at the end, namely:-  
"In exceptional circumstances, if the Committee permits, a witness can attend a meeting through video conferencing. "

19. Amendment to Rule 224

In sub-rule (4) of rule 224, for the word "telegrams" the words "electronic communications" shall be substituted.

20. Amendment to Rule 236

In sub-rule (6) of rule 236, for the word "lay" the word "furnish" shall be substituted.

21. Amendment to Rule 238

In the second proviso to item (b) to sub-rule (1) of rule 238, delete the word "simultaneously" and insert the words "within thirty days" after the word "transmitted".

22. Amendment to Rule 301

In sub-rule (2) of rule 301, after the word "electronic" the words "or biometric" shall be inserted.

23. Amendment to Rule 304

In sub-rule (1) of rule 304, after the word "writing" the words "or online" shall be inserted.

24. Amendment to Fourth Schedule

In the Fourth Schedule, LIST OF PUBLIC UNDERTAKING,

(1) In Category C. **Subsidiary Companies of Fully owned Government Companies**,-

(i) For the entry no.71 "Tourist Resorts (Kerala) Limited, Thiruvananthapuram" the entry "Kerala Tourism Infrastructure Limited" shall be substituted.

(ii) For the entry no.77 "Steel Complex Limited Kozhikode" the entry "SAIL-SCL Kerala Limited" shall be substituted.
