

Dated, Thiruvananthapuram, 1st March 2016.

In exercise of the powers conferred by clause (bb) of sub-section (1) of section 69 of the Registration Act, 1908 (Central Act XVI of 1908), the Inspector General of Registration hereby makes the following rules further to amend the Kerala Document Writers' License Rules, 1960 issued in Notification No. L.2103/57 dated 16th May, 1960 and published in the Kerala Gazette Extraordinary No. 22 dated 31st May, 1960, with the approval of the Government of Kerala, as required by sub-section (2) of the said section, namely:—

#### RULES

##### 1. Short title and commencement:—

- (1) These rules may be called the Kerala Document Writers' License (Amendment) Rules, 2016.
- (2) They shall come into force at once.

##### 2. Amendment of rules:—

In the Kerala Document Writers' License Rules, 1960,—

In rule 6, after the proviso to sub-rule (2) the following proviso and an explanation shall be added, namely:—

"provided further that the provisions of this rule shall not apply to documents prepared by executants themselves or claimant himself."

**Explanation**—For the purpose of this rule, 'Executant' means any person who affixes his signature in a document as a token of his assent to the terms of the document and 'Claimant' means any person who has a right to claim the document as per the terms of the document."

#### RULES

##### 1. Short title and commencement:—

- (1) These rules may be called the Registration (Amendment) Rules (Kerala), 2016.
- (2) They shall come into force at once.

##### 2. Amendment of rules:—

In the Registration Rules (Kerala), 1958, in the proviso to sub-rule (i) of rule 30, after the word 'Government', the following words and explanation shall be added, namely:—

"or documents prepared by executant or claimant himself."

**Explanation**—For the purpose of this rule, 'Executant' means any person who affixes his signature in a document as a token of his assent to the terms of the document and 'Claimant' means any person who has a right to claim the document as per the terms of the document."
