ORDER

Government have enacted the Kerala Rules for payment of Compensation to the victims of attack by wild animals, 1980 (read as 1st paper above) with a view to provide assistance to the affected parties for death, injury and loss of crops houses etc. due to the attack by wild animals. The Rules were amended from time to time making sufficient increase in the rates of compensation payable to victims. However, the Forest Department have not issued separate orders for calculating the value of lost crops individually, instead, the value of loss of individual crops were calculated based on the Government orders issued by the Agriculture Department from time to time. The latest order issued by the Agriculture Department in this regard is read as 2nd paper above.

After the year 2004 Agriculture Department have not issued any orders fixing the rates of compensation for loss of crops. Agriculture Department now follows the rates fixed the Revenue Disaster Management Department for calculating the compensation for loss of crops. (order read as 3rd paper above).

- 2) As per G.O read as 4th paper above Government have revised the total compensation payable for loss of crops due attack of Wildanimals from Rs. 50,000/- to Rs.75,000/- and the payment to a particular individual for loss has been restricted to 4 times a year.
- 3) In the G.O read as 5th paper above an undertaking was given by the Government for preparing a comprehensive proposal for payment of compensation considering not only the cultivated area of the lost crops but also the age of destroyed crops. In the meantime Smt Laissy Thomas, a resident of Idukki District has filed Writ Petition read as 6th paper above requesting to direct the Government to issue orders for fixing compensation for crops considering age of the destroyed crops also. The Hon Human Rights Commission vide orders read as 7th paper above has also directed the Government to revise the compensation payable for loss of individual crops considering the present conditions.
- A meeting regarding the issue was held on 31.10.2014 and it was decided to fix compensation for loss of crops individually with a 10% increase on the rates fixed by the Disaster Management (Revenue-K) Department vide G.O read as 3rd paper above as detailed below:
