Whereas the Second Party has remitted an amount of Rs.7,57,200/-(Rupees Seven lakh fifty seven thousand two hundred only) towards payment of Security deposit, by RTGS payment on 29/06/2016 to DTPC's account in Punjab National Bank, Durbar Hall Road, Ernakulam, and which is receipted vide No.2369, dated, 29/06/2016.

And Whereas It is necessary to enter in to an agreement for the fulfillment of the right, duties and responsibilities of each party executed according to the conditions of the Tender Notice and Work Order vide No.632/16/DTPC/EKM Dated 22/06/2016, as referred above.

NOW THEREFORE IN CONSIDERATION OF THE PRMESIS AND MUTUAL COVENANTS HEREIN AFTER CONTAINED THE PARTIES HERETO HEREBY AGREE AND THIS AGREEMENT WITNESSTH AS UNDER:

- 1. The date of commencement of the licensed operation by the Second Party shall be w.e.f 01/7/2016 and the period of licensed operation shall be two years in from 01/7/2016 to 30/06/2019.
- The Second Party shall pay the Advance monthly License Fee after signing the agreement for the licensed operation on or before 10<sup>th</sup> of every month, by cash or DD in favor of Secretary, DTPC, Ernakulam without fail.

- 3. The First Party reserves the right to collect the penal interest @18% per annu an along with a fixed monthly charge of Rs.500/-towards the delayed payment notice & process ing charge from the Second Party, in case of delayed payment of license fee.
- 4. The Second Party shall be liable to abide by all the conditions (Sl. No. 1 to 15) as s Eipulated in the Tender Notice vide No.1278/14/DTPC/EKM Dated 23/05/2016 and also the Work Order vide No. 632/16/DTPC/EKM Dated 22/06/2016.
- 5. The security deposit of Rs.7,57,200/- (Seven lakhs Fifty thousand and two hun cired only )(12 months license fees) made by the Second Party to the First Party shall be re-turned to the Second Party, without any interest only after the satisfactory compliance of the terms and conditions of the Licensed Operation of the Cherai Beach Pay & Park and upon expiry of the Licensed operation or termination or subject to the final decision by the District Collector and Chairman DTPC, only after deducting any loss, damages, compensation, sustained etc. to the First Party, from the part of actions by Second Party.
- 6. The Second Party will have the right to submit representation for revision of parking fees charges etc., before the First Party and the decision taken by the First Party shall be binding and final. The approved rate at present shall be the following rates. Two Wheeler Rs. -5/- for 5 hours.

Rs.10/- for 5 hours

Car

Rs.15/- for 5 hours

Tempo Traveller/Mini Bus -- Rs.40/-for 5 hours

-Rs.60/- for 5 hours.

- 7. The Second Party shall not undertake or execute any modernization work at the premises
- 8. The Second Party shall be liable to comply all statutory rules and regulations in force with
- In case of violation of all or any of the above clauses shall be treated as breach of the license agreement by the Second party and in such case First Party will have the liberty to take any legal action as well as termination of the license agreement by giving 15 days notice time, at the risk
- 10. The First Party reserves the right to forfeit the loss, compensation etc from the security deposit by the Second Party, in case of any loss, damages, and compensation etc sustained to the First Party, on account of the event either international or unintentional from the part of the Second
- 11. The right for the licensed operation is not transferable without the prior written consent of the
- 12. The second party will have to arrange necessary security services for the safety and security of movable and immovable properties, the lamps etc. at the project .

- 3. The tickets for the collection of fees should be printed at the cost of Second Party in the form approved by the First Party and the same shall be in a consecutive serial number starting from 1 and the same has to be get it sealed from the First Party.
- 14. The Second party shall do necessary arrangements to make premises clean and hygieni⊂ always.
- 15. All permissions and licenses as statutory if any required for carrying out the licensed Operation should be arranged by the Second Party by himself at his risk.
- 16. Any violation of the above conditions will attract cancellation of the Licensed Operatio En without prior notice and loss if any sustained to the First Party, on such subsequent arranger ments for the fulfillment of the operation shall be recovered from the Second Party as in the case of tax
- 17. The First Party has the power to terminate or cancel the Agreement without assigning any reason after giving 15 days' notice time.
- 18. The Second Party is liable to abide by all the instructions issued by DTPC from time to time for safeguarding the interest subject to the transparent operation and management of the Parking area, as per this agreement.
- 19. The First Party reserves the right to amend, modify and append any clause which rmay deem appropriate for ensuring effective management and operation of the Recreation Pond and Pedal Boating Service.
- 20. This agreement together with the Annexure here to, with any instruments to be executed and delivered in pursuant to this agreement constitutes and entire agreement between the parties and supersede all prior understandings, undertakings and writings/correspondence.
- 21. In case of any disputes arises, the decision taken by the District Collector, Ernakularn shall be final and abiding for both the parties. In case of legal issues, jurisdiction shall be in the courts of Ernakulam.
- 22. The second party shall pay a maximum of Rs.5000/- as the cleaning charges to the First party in connection with the cleaning programme at the project.
- 23. If the second party makes license fee dues more than three consecutive months, the license agreement with the first pary will be automatically terminated.


