As per above cited reference, I may submit the following facts and suggestions for the modification regarding the recommendation of the committee on Haj Policy 2018-22

On Quota & Categories

Reducing the quota of HCOl cannot justify from 75% to 70% by providing a & b more seats to the private tour operators. It is a weapon against the poor aspirants for Haj as the private tour operators demands huge amount being the expense. So increase seats of HOCl up to 100% based on the application received is state.

Never abolish the quota reserved for 70 + and fourth timers so as to two the Lottery C System. for 70+ and four 12 timer.

Enhance the quota of HCOI from the existing position (75%) up to 100% (minima) Stage- I based on the demands and needs of states and reduce the seads for PTO' (

The ratio of KuH and Hai fill oring may be kept 1:200 State-II a)

Quota may be discributed based on the application received during the year

Same as shown in recommendation reports Statge-HII

2 Recommendation on Mehram

Ladies only be permitted for Haj with the relatives/kinship irrespective of age based on Shariat Rules and Laws

3 Accommodation in Mekkuh

- a) Include State's Nominees in the Buildings Selection Team
- b) The agreement made between the HCOI/CGI and building owner may be communicated to the states concerned before the departure of Haj pilgrims so us to know the provisions of facilities agreed between two parties. It will be highly useful for further actions if needed.

4) Accommodation in Madina

In this year (2017) the main complaint of the Haj pilgrims is about the accommodation at Madina (The very old building which has no any facility for residing in the room). So avoid such buildings

5) Staffing of CGI Jeddah

A Special Officer from each State Haj Committee may be deputed/appointed to look after the welfare of Haj pilgrims of the state concerned.

6) Air Transport and Charter Operation

b) Never reduce the existing embarkation point from the present position 21

The reducing of Embarkation Point will be affected financial

physically and mentally to the aspirants of the Haj

More over the constructed Haj Houses and premises will be spoilt and the amount spent for building construction and purchase of land will become useless.

Opening of training centre or other innovative programmes at Haj House will never cater the needs, intention, objectives and the demands of the donors who paid large amount only for the purpose of building constriction and purchase of land and in connection with Haj.

- We demand global tender for the Haj Charter
- 8) The Selected KuH should be given charge only to the Haj pilgrims from the State concerned itself for smooth communication and helps.

The flight wise accompanied KuH shall be given the full charge of Haj pilgrims in the same group who travelled in the same flight from the departure to the arrival. Never change the KuH from Saudi Arabia from one group to another.

11) Private Tour Operator

The amount regarding the expenses for Haj pilgrim should be regularised equal to the amount payable to the HCOl for Haj purpose.

- m) Enhance HCOI quota from 75% to 100% based on the demands and needs of the states.
- 12) 1) The Umrah and Ziyarat to other holy places may be permitted under the control of State Haj Committee.

Suggestions

- 1) Increase Haj Quota of HCOI from 75% to 100% consider. The needs of states based on the number of application received.
- 2) Re instate the reserved Categories' Quota (A) 70+ (b) 4th timers). The Fifth timer and 70+ applicatants may be selected without any restrictions as done previous years
- 3) Mehram: Ladies only be permitted for Haj if her mehram is a relative as per Shariat Rules/Law.
- 4) Embarkation Point: Never reduce the existing embarkation points and re instate Calicut International Airport, Karippur as the embarkation point of Kerala State.
- 5) Medical and Para-Medical Team may be selected from each states concerned to the Medical attention to Haj pilgrims of the state concerned.
- 6) Introduce Compulsory Online Application System to the States subject to the availability of such facilities

As per above cited reference, it is come to know that the Committee appointed by the Central Govt, has submitted the recommendations in connection with the New Haj Policy 2018-22.

Hence the Kerala State Haj Committee conducted "a discussion on 23-10-2017 at Calicut regarding the recommendations of the committee (New Haj Policy 2018-22)". All the leaders of Muslim organisations from Kerala and representatives of other states Haj Committees participated in the discussion session. Unanimously we strongly decided to submit the following suggestions and demands regarding the recommendations for necessary modifications and changes in the submitted recommendations.

Demands

1) On Quota

Reducing the existing quota of HCOI from 75% is not at all justifiable where enough number of applicants are waiting for the pilgrims under HCOI quota for the last many years.

Enhancing the Quota of PTO from 25% to 30% is apart from natural justice

- a) We demand to enhance the quota of HCOI from the existing 75% to 100% (at least 80%) subject to the demands of the states.
- b) Quota may be allotted to the states based on the number of application received (More application received more quota)
- c) Reduce the quota of PTOS from the existing 25% to 20%.

b) Category A & B

Keep the status quo of 70 + and fourth/fifth timer as the existing rules. Never abolish the quota reserved for 70 + and fourth timers/fifth timers. Keep the existing rules quota on 70 + & fourth/fifth timers. Both of them are waiting for the last many years.

2) Accommodation in Mckkah

Declare only one category for accommodation - Azeeziya

Accommodation in Madeena

Avoid old buildings for accommodation

- Include State representative in the Building Selection Team or give the authority to 4) the State Haj Committee concerned for selecting building (Accommodation)
- Air Transport and Charter Operation 5)
 - a) Embarkation Point:

Never reduce the existing embarkation points from the present position ie (21 Nos)-If the embarkation points is reduced it may cause very difficult to the Haj aspirants physically, mentally and financially.

- b) Declare Calicut International Airport as the Embarkation Point Re-instate Karippur as the embarkation point of Kerala State since 83% of total Haj pilgrims/applicants are from Malabar area especially from Malappuram and Calicut districts
- c) We demand global tender for the Haj Chater.
- 6) Umrah & Ziyarath Packages

State Haj Committe may be permitted to operate Umrah & Ziyarath Packages

7) Medical and Para-Medical Team Selection For Haj

Medical and Para-Medical Team may be selected from among the staff of the state concerned for the smooth communication and interaction.

8) Introduce Online Application System

Introduce Compulsory Online Application System to the States subject to the facilities available in the state

- Mehram It should be followed based on Shariat Laws/Rules
- 10) Utilise the return Haj Flight for travelling the other passengers from the nearest Airport to the airport (Destination). It will help to reduce the flight ticket charge (Air fair charge)

1 would like to convey my sincere regards for the meritorious services provided by the Government of India, Ministry, Departments, Airport Authority of India and such other agencies for the success of the Haj operations in the state of Kerala for the last many years.

I may submit the following facts for your kind attention and urgent favourable orders.

The embarkation point fixed for the Haj Pilgrims from the State of Kerala, Lakshadeep and Mahe(Part of Pondichery) was Calicut Airport for more than a decade.

Unfortunately the embarkation point was shifted from Calicut Airport to Cochin International Airport during the Haj 2015 due to maintenance works at Calicut Airport. Kerala state Haj committee held many meetings and passed resolutions for shifting of embarkation point from Cochin to Kozhikkode by using the narrow bodied Aircraft (AIRBUS 330 (SOUDI) and Boeing 787 (AIR INDIA). But the authorities was not ready to take any action in this regard due to the ongoing maintenance work at Calicut Airport.

Now it is come to know that the runway maintenance and electrification works are completed. The re carpeting work and strengthening of runway have been done recently. Now the Karippur Airport is in in full swing for servicing the aircrafts at any time....
