പൂർത്തിയായിട്ടില്ല. തിരുവനന്തപുരം, കൊല്ലം പത്തനംതിട്ട, ആലപ്പുഴ, കോട്ടയം, എറണാകുളം എന്നീ ജില്ലകളിലെ സി.ഡബ്ല്യു. സി കളിൽ പുതിയ അംഗങ്ങളെ ഉൾപ്പെടുത്തി പുനഃസംഘടിപ്പിക്കുന്നതിന്റെ ഭാഗമായി ആറ് ജില്ലകളിൽ സെലക്ഷൻ നടപടികൾ പൂർത്തിയാക്കി പാനൽ സർക്കാരിന് സമർപ്പിച്ചിരുന്നു. എന്നാൽ ഇത് 2000-ലെ ജൂവനൈൽ ജസ്റ്റീസ് ആക്ടിന്റെ അടിസ്ഥാനത്തിലായിരുന്നതിനാൽ ജൂവനൈൽ ജസ്റ്റീസ് ആക്ട് 2015-ന്റെ അടിസ്ഥാനത്തിൽ പ്രസ്തുത പാനലിൽ നിന്നും നിയമന നടപടികൾ സ്വീകരിച്ചിരുന്നില്ല. 21/08/2017-ലെ സ.ഉ(കൈ) 37/2017/സാ.നീ.വ ഉത്തരവനുസരിച്ച് 2000-ലെ പഴയ ആക്ട് അനുസരിച്ചുള്ള വിജ്ഞാപനങ്ങളും അവയോടനുബന്ധിച്ചുള്ള വിവിധ സെലക്ട് ലിസ്റ്റുകളും റദ്ദ് ചെയ്തുകൊണ്ടും എറണാകുളം ഒഴികെയുള്ള ജില്ലകളിലെ ചൈൽഡ് വെൽഫെയർ കമ്മിറ്റികളും 14 ജില്ലകളിലെ ജൂവനൈൽ ജസ്റ്റീസ് ബോർഡുകളും പുനഃസംഘടിപ്പിക്കുന്നതിനുള്ള അപേക്ഷ ക്ഷണിച്ചുകൊണ്ട് വിജ്ഞാപനം പുറപ്പെടുവിക്കാൻ സാമൂഹ്യനീതി ഡയറക്ടർക്ക് അനുമതി നൽകിക്കൊണ്ട് ഉത്തരവായിരുന്നു. 6 ജില്ലകളിലേയ്ക്കായി തയ്യാറാക്കിയ പാനലിൽ നിന്നും നിയമനം നടത്താത്തതിനാൽ ടി പാനലിൽ ഉൾപ്പെട്ടിരുന്ന അംഗങ്ങൾ ബഹു. കേരള ഹൈക്കോടതിയിൽ കേസ് ഫയൽ

ചെയ്തതിന്റെ അടിസ്ഥാനത്തിൽ കോടതി സെക്ഷൻ പ്രവർത്തനങ്ങൾ സ്റ്റേ ചെയ്യുകയുണ്ടായി. അതിനാലാണ് ചൈൽഡ് വെൽഫെയർ കമ്മിറ്റികളുടേയും ജൂവനൈൽ ജസ്റ്റിസ് ബോർഡിന്റെയും പുനഃസംഘടന പൂർത്തിയാക്കാൻ സാധിച്ചിരിക്കുന്നത്.
