

PUBLIC UNDERTAKINGS—COURTESIES TO BE EXTENDED TO MPs/MLAs—
MODIFIED—ORDERS ISSUED

GENERAL ADMINISTRATION (POLITICAL) DEPARTMENT

S. C. (Ms.) No. 141/2012/GAD. Dated, Thiruvananthapuram, 11th June, 2012.

ORDER

In the Circular's read 1st and 2nd paper above Government has issued necessary directions to the effect that in all public functions particularly those arranged under the auspices of Government Department/Undertakings in which the Government Servants participate it should be ensured that MP/MLA is to be accorded a due place of importance whether to preside over the function or to speak.

Instances of non-compliance of the instructions in the above circulars in the functions organized by Government Department's/Undertakings have come to the notice of the Government.

Government hereby order that in all functions arranged by the Government Department's/Undertakings, the following arrangements will be strictly and scrupulously complied with.

1. In all functions arranged by the Government Department's/Undertakings (Central and State), the local MP/MLA should be invited to the function.

GCPT. 3/4418/2012/DTP. (2)

2. In all functions arranged by the Government Department's/ Undertakings, MP representing the constituency where the function is arranged are to be given precedence in Central Government functions and the MLA representing the constituency where the function is arranged are to be given precedence in state Government functions.

3. (a) In all functions arranged by Government Departments/ undertakings in which a Minister participates, invariably the local MLA should be invited to preside over the function. In the absence of any Minister the local MLA should be given precedence over other speakers.

(b) Where two or more ministers participate the Minister in charge of concerned department will inaugurate the programme and the other minister will preside over the function. If two or more ministers participate in the function local MLA/MP should be invited to speak immediately after the Ministers.

(c) In case if Chief Minister is participating, Chief Minister will inaugurate the programme and the Minister in charge of concerned department will preside.

(d) If the Speaker of the Legislative Assembly participates in a function, then he should be given an important position next to the Chief Minister.

(e) In case if VVIP's (H.E. the President, H. E. the Vice president, Hon'ble Prime Minister) attending the programme, then the Chief Minister will preside over the function. The Union Cabinet Ministers should be accorded important position, as per the order of Precedence issued on 23-1-1996.

4. In all functions organized by the Local Self Government institutions with the funds of State/Union Government, the local MLA should invariably be invited and given precedence over others.

Any violation of the above instructions will be viewed seriously by Government.

These orders will take immediate effect.
