2. Minutes of the Meeting of the Selection Committee dated 27,7.06.

ORDER

Government have constituted a Selection Committee for selection of the Chief Executive Officers for Public Sector Undertakings under the Administrative Control of the Industries Department on merit as per G.O. read above.

The Committee has its first meeting on 27.7.06 and submitted the following proposals.

1. Only the Chief Executive Officer (not any post below that rank) will come under the purview of the Committee.

2. Permission of Government will be sought before making advertisement for selection to the post. It is preferable to advertise for Five Companies at a time.

3. The qualification, experience, scale of pay, age and other conditions of service are to be fixed by the Government before notification.

4. Advertisement will be made in two English Dailies having national coverage and two Malayalam Dailies having wide circulation.

The Committee considered whether reservation is necessary. Since there is only one post, reservation is not possible as per Supreme Court ruling.

6. Applications with the bio-data and proof of their credentials can be accepted for the selection process.

No application fee to be remitted.

8. All those candidates who are included in the short list and invited for interview will be paid T.A. for 2nd A.C in Train for candidates within the State or Air (Economic Class) for candidates outside the state but within India for their travel by shortest distance from residence to place of interview.

9. Appointment shall be for 3 years from the date of appointment which may be extended up to 5 years or till attaining the age of 58 years whichever is earlier.

10. The upper age limit for selection shall be 55 years as on date of selection.

11. Salary is negotiable and other perks as per the norms of the Company when posted.

identified from 12. Subject/Management experts Institutions/Departments/Boards under Government.

13. The Committee will submit a panel of 3 selected candidates for the consideration of Government.

14. Performance Assessment will be made every year.

15. The Company will pay T.A., D.A. Honorarium for the Subject Experts & Management Experts. The Committee is authorized to co-opt Subject Expert and Management Experts which vary from each post.

16. All the expenses of the Committee meeting will be borne by the respective companies.

17. The official Members of the committee will also decide Honorarium, T.A., D.A. for the Management and Subject Experts.

18. Selection will be sector based like Chemical, General Engineering etc.

Government have examined the proposals in detail and are pleased to approve the recommendations of the Selection Committee. Government are also pleased to authorise the Secretary, Public Sector Restructuring & Internal Audit Board (RIAB) to take follow up action based on the above recommendations.
