

NOTIFICATION

G. O. (P) No. 18/2010/ESGD. Dated, Thiruvananthapuram, 22nd January, 2010.

S. R. O. No. 62/2010.—In exercise of powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, and in supersession of all the existing rules and orders on the subject the Government of Kerala hereby make the following Special Rules for the posts in the Extension Training Centres of Kerala State Rural Development State and Subordinate Services, namely:

RULES

1. *Short title and commencement.*—(1) These rules may be called the Special Rules for the Extension Training Centres of Kerala State Rural Development State and Subordinate Services, 2010.
(2) They shall come into force at once.

2. *Composition.*—The service shall consist of the following categories of posts, namely:—

SUBORDINATE SERVICE

- Category I*—(a) Lecturer Grade II in Agriculture
 (b) Lecturer Grade II in Rural Economics
 (c) Lecturer Grade II in Social Education
 (d) Lecturer Grade II in Extension Education
 (e) Lecturer Grade II in Home Sciences

STATE SERVICE

- Category II (i)*—(a) Lecturer Grade I in Agriculture
 (b) Lecturer Grade I in Rural Economics
 (c) Lecturer Grade I in Social Education
 (d) Lecturer Grade I in Extension Education
 (e) Lecturer Grade I in Home Science
- Category II (ii)*—(a) Lecturer Grade I in Rural Industries
 (b) Lecturer Grade I in Animal Husbandry
 (c) Lecturer Grade I in Rural Engineering
 (d) Lecturer Grade I in Co-operation

3. *Method of appointment and qualifications.*—No person shall be eligible for appointment to the categories mentioned in column (1) of the table below by the method of appointment specified in column (2) unless he/she possesses the qualifications prescribed in the corresponding entry in column (3) thereof:

etc. Candidates from by transfer categories for appointment to the posts included in category I and category II (ii) will be selected by Kerala Public Service Commission.

4. Appointing Authority.—The appointing authority in the case of appointments by transfer from among Village Extension Officers/Extension Officers (Women's Welfare)/Extension Officers (Housing) Gr. II/General Extension Officers shall be the Commissioner for Rural Development. In the case of appointments from other Departments, the Secretary, Local Self Government Department shall be the appointing authority.

5. Reservation of Appointment.—The rules relating to reservation of appointment [General Rules 14 to 17 (B) Part II KS & SSR] shall apply to appointments by direct recruitment.

6. Age.—No person shall be eligible for appointment by direct recruitment to any of the posts if he/she has not completed 18 years of age or has completed 35 years of age on the first day of January of the year in which applications for appointment are invited with usual relaxation of upper age limit shall be allowed to the candidates belonging to SCs, STs and Other Backward Classes. In case of appointment by transfer the upper age limit will not exceed 45 years on the first day of January of the year in which applications for appointment are invited. No age relaxations will be allowed to any of the candidates in the by transfer categories.

7. Probation.—Every person appointed to any of the categories mentioned above shall be on probation from the date on which he joins duty.

- (a) If appointed by direct recruitment or by transfer through KPSC, for a total period of two years on duty within a continuous period of three years; and
- (b) If appointed by promotion for a total period of one year on duty within a continuous period of two years.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

There are no Special Rules at present for the post of Lecturers in the Extension Training Centres of the Department. The posts are proposed to be filled up both from the Kerala State Rural Development Department and other Departments. So the qualification and method of appointment have to be prescribed by framing the Special Rules for the Extension Training Centres of Kerala State Rural Development State and Subordinate Services.

This notification is intended to achieve the above object.
