ORDER

The Government of India have sanctioned a scheme for giving certain concessions to meritorious Sportsmen in the matter of recruitment to Class III and Class IV posts under that Government and have requested the State Governments to consider the extensions of similar concessions in the recruitment to the State Services. Government have examined the matter in consultation with the Kerala Sports Council and the Kerala Public Service commission and are pleased to issue the following orders:-

1. Concession to meritorious Sportsmen will be available in direct recruitment to be made through the Public Service Commission to all categories of Class III and Class IV posts in State Service.
2. A separate quota will not be reserved for the meritorious sportsmen under this scheme.
3. Extra marks will be awarded to the meritorious Sportsmen who possess the requisite qualification and who are within the prescribed age, in the selections conducted by the Public Service commission for recruitment to Class III and Class IV posts, subject to the condition that this will apply to selections finalized both by written test and interview.
4. Meritorious Sportsmen on the following items of sports will be eligible for the concession.

- i. Football
- ii. Athletics
- iii. Volleyball
- iv. Aquatics (Swimming, Diving, Waterpolo)
- v. Basket ball
- vi. Hockey
- vii. Badminton (Shuttle)
- viii. Table Tennis
- ix. Tennis
- x. Ball Badminton
- xi. Cricket
- xii. Kabaddi

- xiii. 15 Wrestling
- xiv. 14 Gymnastics
- xv. 15 Kho-kho
- xvi. 16 Weightlifting & Body building
- xvii. 17 Boxing
- xviii. 18 Chess
- xix. 19 Cycling
- xx. 20 Handball
- xxi. 21 Kalarippayat
- xxii. 22 Cycle Polo
- xxiii. 23 Billiards
- xxiv. 24 Rifle Shooting
- xxv. 25 Mountaineering

5. Suitable grades of extra marks will be fixed for the following categories
- (a) Sportsmen who have represented the State or the Country in a National or International competition;
 - (b) Sportsmen who have represented their Universities in the Inter-University Tournaments conducted by the Inter University Sports Board.
 - (c) Sportsmen who have represented the State Schools Teams in the National Sports/Games for schools conducted by the All India School Games Federation;
 - (d) Winners at State level competitions conducted under the auspices of the State Government/Universities in the State/ the Kerala Sports Council.
6. No relaxation of age or educational qualification will be given under this scheme.
7. Lady candidates will also be included in the term "Meritorious Sportsmen"
8. Selection under their scheme will be made by the Public Service Commission.
9. Selection of candidates under the scheme will be made subject to normal rules relating to recruitment including communal reservation.
10. Extra marks as noted against each category of sportsmen below under "Individual events" and "Team events" will be as follows:-

(a) INDIVIDUAL EVENTS

- 1. Representing the country in International competition Viz. World Olympics, Asian Games and Commonwealth Games -- 30 % extra
- 2. Representing the State in Nationals -- 20 % extra
- 3. Representing the University in All Indian University Games (Inter-Zone) -- 15% extra
- 4. Representing the State Schools in "all India School Games" -- 10 % extra
- 5. Representing State/University in South zonal events -- 7 1/2 % extra
- 6. Representing District (but not clubs) in State Championship and Colleges in Inter-Collegiate (Inter-zonal meets) -- 5 % extra

(b) TEAM EVENTS

- 1. Representing India in International Tournaments -- 20 % extra
- 2. Representing the State in Nationals -- 15% extra
- 3. Representing University in Inter University Tournaments (Inter Zonal) and representing State Schools in All India School games -- 10 % extra
- 4. Representing State/University in the South Zonal events -- 7 1/2 % extra

- 5 Representing colleges in Inter Collegiate (Inter Zonal) Championship and Districts (but not clubs) in the State Championship -- 4 % extra

C) In addition to the above, marks will be awarded to winners of the first, second and third places as follows:-

- i. In International events 30% for 1st place, 25% for 2nd place and 15% for 3rd place. In all other cases 10% more for individuals for securing the first place, 7 ½ for those who secure the 2nd place and 5 % for those who secure the 3rd place.
- ii. So far as team events are concerned such of those individuals who are in the winning team will be given additional 10% and those in the runner-up team will be given 5%. However, in International events members of the winning team will get 25% extra and members of the runner-up team will get 15 % extra.
- iii. If a candidate has participated in more than one event or in more than one game enumerated above the best performance in any one event of game which is to his advantage alone will be considered.

(11) The weightage of marks will be allowed only as among candidates who are called for interview or who are proposed to be included in a ranked list on the basis of a written examination.

(12) A candidate who has applied for a selection and who had enjoyed the benefit will not be disqualified for enjoying the same benefit in another selection.

(13) The maximum marks that can be awarded to a candidate for all the items but together should be 35% (Thirty five per cent) of the total marks.



ORDER

As per G. O. (Ms.) No. 21/78/GAD dated 11-1-1978 read as 1st paper above. Government had sanctioned a scheme for giving certain concessions to meritorious Sportsmen in the matter of recruitment to Class III and Class IV posts for appointment by the Kerala Public Service Commission. According to the existing orders in G. O. (Ms.) No. 21/78/GAD dated 11-1-1978, 25 items were considered for granting grace marks in respect of sportsmen writing the Public Service Commission examinations for recruitment to Class III and Class IV posts.

1. Football
2. Athletics
3. Volleyball
4. Aquatics

5. Basketball
6. Hockey
7. Badminton
8. Tennis
9. Ball Badminton
10. Table Tennis
11. Cricket
12. Kabaddi
13. Wrestling
14. Gymnastics
15. Kho-kho
16. Weight Lifting and Body Building
17. Boxing
18. Chess
19. Cycling
20. Handball
21. Kalaripayattu
22. Cycle Polo
23. Billiards
24. Rifle Shooting
25. Mountaineering.

The present proposal relates to the addition of 7 more events for the award of grace marks. The 7 more items to be included now are:

1. Power Lifting
2. Canoeing and Kayaking
3. Indian Style Wrestling
4. Women's Cricket
5. Women's Hockey
6. Rowing
7. Archery.

Meanwhile Sri Gokulnath in the letter read as 3rd paper above filed a WP (C) No. 5216/11 dated 8-2-2011, in the High Court requesting to include the discipline 'Archery' in the list of items for which extra marks will be awarded to the meritorious sportsmen. The Hon'ble High Court had directed the Government to consider the inclusion of event of 'Archery' amongst the list of events for granting weightage marks in PSC selection. As per the directions of the Hon'ble High Court the petitioner was heard and suggested that the matter may be referred to KPSC. In the letter read as 4th paper KPSC had agreed to include 'Archery' along with the 25 items already issued in G. O. (Ms.) No. 21-78/GAD dated 11-1-1978 as well as the 6 items already agreed as per the letter read as 2nd paper above.

In the circumstances, sanction is accorded to include the 7 items viz: Power Lifting, Canoeing and Kayaking, Indian Style Wrestling, Women's Cricket, Women's Hockey, Rowing and Archery along with the existing 25 items with a total number of events to 32 for awarding grace marks in the PSC Examinations for sportsmen to Class III and Class IV Posts.
