 - 3. The request of the Director, KITTS has been examined by Government in detail. It has been found that the existing three Lecturers in the KITTS possess the qualification and experience laid down by AICTE for granting the pay scales fixed by AICTE.
 - 4. In the circumstances Government are pleased to accord sanction to revise the scale of pay of the Lecturers in the KITTS to Rs. 8000-275-13500 and the Senior Lecturers to Rs. 10000-325-15200 on par with the scale of pay prescribed by the AICTE.

ORDER

As per G.O. read as 1st paper above, one post of Assistant Professor and four posts of lecturers were created in KITTS. Of this one post of lecturer was surrendered due to the closure of Kozhikkode chapter of KITTS. As such there were one post of Assistant Professor and 3 posts of Lecturers in KITTS when AICTE scheme was implemented in the institution.

2) KITTS got AICTE approval to start two year full time PGDBA in Travel and Tourism in the year 2005. As part of getting approval from AICTE, the Institute needed to fulfill certain mandatory requirements such as appointment of qualified staff as per AICTE norms. Accordingly Government as per the G.O read as 2nd paper above accorded sanction to revise the scale of pay of the Lecturer to 8000-275-13500 and the 2 Senior Lecturers to 10000-32545200 at par with the pay prescribed by the AICTE. But the post of Assistant Professor then existing in KITTS was omitted due to oversight. The reason that has been reported in this regard is that at the time of the proposal in this regard,

- Sri.Dileep.M.R., Senior Lecturer from Pazhassi Raja College was working in the post on deputation basis and that he was possessing qualification as mandated under the AICTE and was drawing the scale of pay at AICTE scale. When he left the institute to join his parent organisation on 13.09.2010 the post of Assistant Professor became vacant. As such the posts of Lecturers excluding the post of the Assistant Professor was brought under AICTE scheme.
 - 3) As per G.O. read as 3rd paper above, Government have accorded sanction to create a post of Principal in KITTS in the scale of pay of Rs.18400-500-22400 with qualification and pay as per the norms prescribed by AICTE.Government have further created two posts of Lecturer as per AICTE norms, (Lecturer Management and Lecturer-Tourism & Travel) as per the G.O. read as 4th paper above. Hence at present there are five sanctioned posts of Lecturers as per AICTE norms in KITTS. A post of Assistant Professor under State Scale also exists in KITTS.
- 4) Government accorded sanction to revise the scale of pay in respect of the Principal, two Assistant Professors, one Assistant Professor (Management) and one Assistant Professor (Tourism & Travel) under AICTE Scheme (total 5, including Principal) as per G.O. read as 5th paper above. Existing post of Lecturers were re-designated as Assistant Professors as per AICTE norms. The post of Assistant Professor existing in the KITTS in the State Scale has not been brought under the AICTE scale so far.
- 5)Pursuant to the repatriation of the person who was working on deputation in the post of Assistant Professor, held by Sri.Dileep.M.R., Senior Lecturer from Pazhassi Raja College and creation of two posts of lecturers as per G.O. read as 4th paper above, three posts of Lecturers were notified for filling up under AICTE norms (Lecturer in Travel and Tourism 2 Nos. and Lecturer in Management-One post) on 16.01.2011. Accordingly two persons were selected against the posts of Lecture in Travel and Tourism and in their appointment order also it was pointed out that the posts are in the AICTE scale. Lecturer in Management could not be filled as no qualified person could be selected. However the junior of the above two has not been extended the benefits of the G.O. read as 5th paper as the post of Assistant Professor existed in the state scale has not been brought to the AICTE scale so far.
- 6) As the academic staff with similar qualification and academic requisites as envisaged in AICTE scheme work in KITTS both in State Scale and AICTE Scale is not preferable, the Government had issued direction to the

- Director of KITTS to take necessary action to equate all the posts available in the academic section in AICTE scheme. Accordingly the Director, KITTS requested the Government to accord sanction to equate the post of Assistant Professor available in the institute in the state time scale with the corresponding AICTE scale.
 - 7) Government have considered the case in detail. In view of the reasons stated in the foregoing paras, Government thinks that it is only justifiable to consider equating the post of Assistant Professor (Travel & Tourism) existing in the KITTS in the state time scale to the corresponding post with the AICTE pay scale with effect from 16.01.2011. Government are pleased to issue orders accordingly. The Director of KITTS will take further necessary action to extend all the consequential benefits to the incumbent holding the post if he is found otherwise eligible as per AICTE and other relevant norms.

- 2. Government have examined the proposal in detail and are pleased to accord sanction to extend the benefits of the revision of the scales of pay and allowances in accordance with the orders issued in the Government Order read as 1st paper above to employees of Kerala Institute of Tourism and Travel Studies on to the following conditions.
 - i. All the extra benefits which are not allowable to the State Government employees should be stopped while implementing this order.
 - ii. The scales of pay shall be revised in accordance with revised pay scales mentioned at Annexure 1 of the Pay Revision order dated 25-3-2006. No stepping up of the scale of pay of any category will be allowed under any circumstances..

 - v. CCA should be limited to those employees who are working in the offices which are situated within city limits.

vi. No creation or up gradation of posts (even posts held on deputation from other departments) will be done without formal approval of Government.

vii. The terms and conditions of service of employees (including pay, allowances perquisites, leave rules promotion rules etc) will not be changed, with out prior approval of the State Government.

viii. Appointments (permanent, deputation, contract, provisional, causal, daily wages etc) will be only against posts which have been sanctioned with prior Government approval. Any deviation will require prior Government approval.

ix. The date of effect of the revision and payment of arrears on account of revision will be the date as per the orders in G.O dated 25.-3.2006.

x. In case of any doubt regarding pay scales, fixation etc prior concurrence of the Government shall be obtained before arriving at a decision.
