Er. K. L. Kumar and Dr. M. R. S. Nair had informed their inability to attend the meeting due to prior commitments and unavoidable reasons.

The meeting started at 1430 hours in the Conference Hall of Mascot Hotel, Thiruvananthapuram. The Member Secretary, Prof. V. K. Damodaran introduced the members to the new Chairman and to the new Vice Chairman of the Governing Body.

**Hon'ble Shri Kadavoor Sivadasan, Minister for Electricity
& Chairman of the Centre, presided.**

Item No: 6.5 :

Re-deployment of Qualified Personnel

Issue: On being referred by the EC, GB discussed the proposal on the re-deployment of personnel in EMC. The Director and PRO cum Secretary to Director are being relieved on 30.06.01 and the Finance Manager and the Head (Training and Consultancy) are also having their contracts to end in another three months. In the Centre, with only around 10 senior level officers as core staff, the absence of the seniormost four officers will seriously affect its working. There is a government restriction on new recruitment as well. In this circumstances, the EC decided that the work of the Centre can be continued uninterrupted by re-deploying the existing staff, if they are found qualified and fit.

In the light of the GB deciding on new levels of activities for the Centre, like establishing a South Asia Regional Centre on Small Hydro Power in EMC and aggressive energy conservation studies in public sector organizations etc, GB authorised the Director to arrange such re-deployment, as it is within the powers of the Director.

The Director suggested the following re-deployment proposal.

1. The establishment of the Regional Centre on SHP require that, apart from the International Expert who will guide technical matters, a responsible person who is recognized by the International Centre on SHP should be appointed as the home counterpart. EMC has only one engineer other than the Director himself who is leaving the Centre, viz., Er. K. M. Dhareesan Unnithan, an engineer with more than 17 years of experience with a post graduate MBA degree, and currently working for his part-time Ph. D. with Calicut University. He had training in IN-SHP in China on Small Hydro Equipment. So, the Director EMC has discussed with the Director General of IN-SHP Prof. Tong Jiandong, and Mr. Unnithan is acceptable to him for leading the counterpart team in EMC. He is currently the Registrar and Head of Information Services, according to the multi functional responsibility system in EMC. But, designation as Registrar denoting an administrative role and authority level will not suit for IN-SHP's acceptance.

Therefore, as there is a post of Joint Director, Er. K. M. Dhareesan Unnithan may be designated as Joint Director of EMC. The pay scale for the post is Rs.16300-450-19900 [revised Kerala govt. scale] (Grade F). He has the required qualifications and experience for holding the JD post, and he can be the head of the Regional Centre on SHP for administrative purposes. He can further look after the entire responsibilities of the administration as defined for the post of

Registrar and the post of Registrar may be kept in abeyance. This will ensure that the expenses are minimised.

2. Finance Manager will be leaving in another 3 months. The qualification for the post is ICWA. The Centre has on deputation from the Postal Accounts Department, a very dedicated and sincere person, Mr. S. Sathichandran, who is having the qualification of ICWA also. He has been here for about three years under the present FM and he can take over as Finance Manager. Being on deputation, no additional expenses are required. However, a new Accountant cum Cashier is required, may be taken on deputation, especially in view of the increasing number of projects and consultancy. The new person can occupy the post held now by Mr. Sathichandran.

3. The EC has already re-designated Mr. W. S. Suwil kumar as System Analyst. There is a post of System Manager (SM), a graduate engineer. It is impossible to get a computer qualified graduate to come for such low scales of pay, in view of the high remunerations available in the software industry, especially when the post is not permanent even. Therefore, the SM post may be filled up with the present incumbent Mr. Suwilkumar, in view of his 10 year long experience in independently managing systems and the excellent performance record of around 5 years in EMC, and entrusted to run the entire computer division independently with the two Word Processing Assistants available in the Centre. He may be remunerated at approved next higher scale of SM. The JSA post may be kept in abeyance.

4. The GB has decided to increase the activities of the consultancy division, and to urgently attempt energy conservation and audit studies in public sector organizations as well as study the possibilities of energy conservation in the KSEB distribution system as per methodology proposed by the Director, w.e.f. July itself. The Head (Training and Consultancy) Er. M. Udayabhanu, who is on contract for three years ending in September 2001, is in charge of the laboratory of EMC and his ability in organising a number of consultancy projects with least strength of staff, if discontinued immediately will result in disruption of planned training and consultancy activities. Therefore, It is recommended that as a special case, he be retained for one more year on the same consolidated honorarium basis.

Decision: GB after considering all aspects, decided to give one year extension of contract to Er. M. Udayabhanu, as a special case in the interest of continuity and for completing the consultancy projects. The Director was further directed to implement the re-deployment as above.

Filling up of the post of Energy Technologist E-II

The EC went through the report of the Sub-Committee constituted to filling up of the post of Energy Technologist Grade E-II through talent scouting. Director pointed out that the post of Energy Technologist -E II and Head of Division is vacant for the last 3 years; it is found difficult to co-ordinate various activities connected with SHP development.

Item No: 4 : Appointment of Energy Technologist B, Word Processing Assistants and filling up of the post of Energy Technologist -Grade C.

The EC noted the Director's report that the Energy Management Centre has an approved sanctioned staff strength of 26 posts as per GO(MS) No. 7/2001/PD dated 14-03-2001; out of these, 7 posts are lying vacant. Since the work load has increased, the Governing Body in its meeting held on 25.03.2010 had decided to fill up two sanctioned posts of Word Processing Assistant (WPA), one post of Energy Technologist Grade B (ET- B) and one post of Energy Technologist Grade C (ET -C). Government vide GO(MS)No.8/2008/PD dated 26-04-2008 has accorded sanction to fill up the vacancies in the higher post through promotion of the qualified and experienced persons in the lower posts and to fill up the vacancies in the lower post through direct recruitment.

Accordingly, the Centre has invited applications for the above posts of WPA and ET- B through advertisement dated 02-6-2010 in the dailies, The Hindu, Malayalam Manorama and Deshabhimani. An internal committee was constituted by the Centre for short-listing the

application based on the prescribed qualifications. The Committee shortlisted 17 applicants for the post of WPA and 25 applicants for the post Energy Technologist Grade B from the applications received.
