2) The 27<sup>th</sup> General Body Meeting of KIIFB held on November 7, 2016 has resolved to authorize the C.E.O to create necessary posts in the Office of KIIFB in accordance with the Staff Structure approved by Government.



Authority on contract basis at consolidated pay of Rs. 2.3 lakh per month for a period of three years with provision for 10% increase on the initial pay every year.




