

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling and in supersession of all existing rules and orders on the subject, the Government of Kerala hereby makes the following Special Rules, namely:-

Rules

1. Constitution.- The following categories of posts in the Community Development Department shall constitute a separate class in the Kerala General Subordinate Service:-

Category 1. (a) Child Welfare Organisers  
(b) Assistant Instructresses in the Home Science Wing in Gramsevak Training Centres.

Category 2. Artist-cum-photographer-cum-Cinema Operators Grade I

Category 3. (a) Mukhyasevikas  
(b) Gramsevaks Grade I  
(c) Gramsevaks Grade II  
(d) Gramsevikas.  
(e) Balwadi Teachers

Category 4. (a) Artist-cum-photographer-cum-Cinema Operator Grade II

(b) Drivers  
(c) Mechanics  
(d) Carpenter-cum-Blacksmith

2. Appointment.- Appointments to the categories of posts specified column (1) of the Table below shall be made by the method specified in the corresponding entry in Column (2) thereof

4. Reservation of appointment:- The rules of reservation of appointment (General Rules 14-17) shall apply to appointment by direct recruitment.

5. Qualifications:- No person shall be eligible for appointment to the post specified in column (1) of the table below by the methods specified in the corresponding entry in column (2) thereof unless he possesses the qualifications specified in the corresponding entry in column (3) of the table.

6. Qualifications as to age:- No person shall be eligible for appointment by direct recruitment to any of the posts if he has not completed or will not complete 19 years of age or in the case of appointment to the post of Driver or Mechanics if he has completed or will complete 30 years of age and in the case of appointments to any other posts if he has completed or will complete 25 years of age.

Note:- The age limits prescribed shall apply with reference to the 1st July of the year in which the selection is made.

7. Probation:- (1) Every person appointed to a category by direct recruitment or by transfer from other services shall, from the date on which he or she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

(2) Every person appointed to a category by promotion shall, from the date on which he or she joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Training:- Every person selected for appointment as Mukhya Sevika or Gramsevak or Gramsevika shall undergo training in one of the Gramsevak Training Centres in the State before appointment to the posts. The training of a candidate will be terminated in the event of his/her conduct being found unsatisfactory or in case he/she is found to be inefficient during the period of training. The candidates will be appointed to the posts only in case they satisfactorily complete the training course. The seniority of the persons appointed to the posts will be fixed on the basis of the Yank

obtained by them in the final examination conducted at the Training Centres on completion of the Training Course. The period of Training shall not count for probation and increments.

9. Term of appointment:- Every person to be appointed to the posts of Mukhyasevikas, Gramsevaks, Grade II and Gramsevika will be required to execute a bond agreeing to serve the State Govt. for a period of 5 years after training and reimburse liquidated damages to the extent of Rs.500/- in addition to the amount actually spent for the training in case they violate the terms of agreement.

S.R.O. NO. 647/77. -- In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Services Act, 1960 (19 of 1968) the Government of Kerala hereby make the following amendment, to the Special Rules issued in G.O. (P) 302/PD (Rules) dated 8.9.1967 published in Part I of the Kerala Gazette No.39 dated 3.10.1967 and the subsequent amendments thereto, namely:--

AMENDMENT

In the said rules, for Rule 8 the following shall be substituted namely : -

"8 Training : Every person selected for appointment as Village Extension Officer or Lady Village Extension Officer shall undergo training in one of the Extension Training Centres in the State before appointment to the post's. The training of a candidate will be terminated in the event of his/her conduct being found unsatisfactory or in case he/she is found to be inefficient during the period of training. The candidates will be appointed to the posts only in case they satisfactorily complete the training course. The rank and seniority of candidates selected for the posts of Village Extension Officers will be decided according to the order in which their names appear in the advice list given by the Public Service Commission. But in the case of those who fail to secure a pass after completion of the training in the first chance, their rank and seniority will be revised on the

basis of the chances and marks they obtain in the subsequent chances. The period of training shall however not count for probation."

#### EXPLANATORY NOTE

This explanatory note does not form part of the Notification.

According to the existing provision in the Special Rules, the seniority of the persons appointed as Gramasevaks and Gramasevaks will be fixed on the basis of the ranks obtained by them in the final examination conducted at the Extension Training Centres on completion of the pre-service training. This being the position, the ranks assigned by the Public Service Commission are subjected to change at the time of actual appointment after training. This is not in conformity with the provisions in General Rules 27(c) of the Kerala State & Subordinate Service Rules. The Public Service Commission has therefore advised that the relevant provision in the special rules may be amended. Hence this amendment.



(i) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following Rules further to amend the Special Rules published under notification

No. G.O. (P) 302 Public (Rules) Department dated 8th September, 1967 in Part I of the Kerala Gazette No. 39 dated 3rd October, 1967, namely:—

**RULES**

1. *Short title and commencement.*—(1) This rules may be called the Amendment to the Kerala General Subordinate Service posts in the Rural Development Department (Amendment) Special Rules, 2008.

(2) They shall come into force at once.

(iii) the entries relating to category of posts 3 item (d) to (f) shall be deleted.

4. In the table under rule 3,—

- (i) for the entries relating to category 1, in column (1) and the entries against them in column (2), the following entries shall respectively be substituted, namely:—

II and the entries against the post in column (2) and (3) the following entries shall be substituted, namely:—

6. Under Rules '8' 'Training' the following entries shall be substituted.

Every person selected for appointment as Village Extension Officer Gr. II, shall undergo pre-service training for six month in any one of the Extension Training Centres in the State before appointment to the post. The training of a candidate will be terminated in the event of his/her conduct and character being found unsatisfactory or if case he/she is found inefficient to the post. The rank and seniority of the candidate selected for the post will be according to the order in which their name appear in the advice list given by the Public Service Commission, if they completed the training satisfactorily, and pass the required examination at the end of the training in their first chance. In the event if the candidate does not complete the training within the stipulated period or does not pass in the first chance, the rank and seniority will be altered on the basis of the date of advice and the date of successful completion of training.

7. After rule 9 the following rule shall be added, namely:-

"10 (1) The integrated seniority list of the existing Joint Block Development Officers and Extension Officer (Women Welfare) Grade I, ITDP, Attappady shall be prepared according to the date of promotion of the incumbents to the respective post and commonly designated as Joint Block Development Officer.

(2) The integrated seniority list of the existing General Extension Officers, Extension Officers (Housing) Grade II, and Extension Officer (Women Welfare) shall be prepared according to the date of promotion of the incumbents to the respective post and commonly designated as Extension Officer.

(3) The integrated seniority list of the existing Village Extension Officer Grade I and Lady Village Extension Officer Grade I shall be prepared according to the date of promotion of the incumbents to the respective post and commonly designate as Village Extension Officer Grade I.

(4) Subject to the provisions under Rule 8, the integrated seniority list of Village Extension Officer Grade II and Lady Village Extension Officer Grade II shall be prepared according to the date of advice and if advised on the same day, their combined seniority shall be prepared by Kerala Public Service Commission.

(This does not form part of the notification, but it is intended to indicate its general purport.)

As per G.O. (Ms) No. 71/2006/LSGD dated 1-3-2006 the post of Extension Officer (Integrated Rural Development) and Extension Officer (Housing) Grade I were redesignated as Joint Block Development Officer (Rural Self Employment) and Joint Block Development Officer (Rural Housing). The post of Joint Block Development Officer has not been included in the Special Rules for the post in the Rural Development Department issued vide G.O. (P) 302 dated 8-9-1967. In order to integrate the post of Village Extension Officer and Lady Village Extension Officer through common Public Service Commission test amendment to the Special Rules becomes necessary. The Government have decided to amend the Special Rules

The notification is intended to achieve the above objective.
