**ORDER**

An Ex-cadre post of Excise Commissioner in the Pay Band HAG+ Rs. 75500-80000 is created for a period of one year and this post is declared equivalent in status and responsibility to the cadre post of Director (Vigilance & Anti Corruption Bureau) under Rule 11 of IPS (Pay) Rules 2007.

2. An ex-cadre post of Inspector General of Police, Ernakulam Range in the Pay Band Rs. 37,400-67,000 Plus Grade Pay Rs.10000 is created for a period of one year and the post is declared equivalent in status and responsibility to the cadre post of Inspector General of Police (Headquarters) under Rule 11 of IPS (Pay) Rules, 2007.
