This petition again coming on for orders upon perusing the petition and the affidavit filed in support of WP(C) and this Court's order dated 30/06/2015 and upon hearing the arguments of ART. ANCHAL C. VIJAYAN, Advocate for the petitioner, GOVERNMENT PLEADER, for R1 and R2, Standing Counsel for R3 and R4 and of SRI.ROY CHACKO, Standing Counsel for R5 and R6, the court passed the following:-

ORDER

An interim order was passed by this Court on 30/06/2015 in W.P.C.No.19522/2015 by which a direction was issued that the respondents shall not engage persons on deputation basis or from other sources in the service of third respondent without engaging persons from Ext.P11 select list. On 14/07/2015; the interim order was extended until further orders. Ext.P11 is the list prepared by the Kerala Abkari Workers Welfare Fund Board and the same had been forwarded to the Government by which the names of 75 persons have been mentioned as dependents of Abkari workers who have lost their employment on account of the policy of the Government in stopping arrack sale in the State.

- 2. Counter affidavit has been filed by respondents 3 and
- 4. I.A.No.13998/2015 has been filed by respondents 3 and 4

seeking to modify or vacating the interim order inter alia alleging that all appointments in the Corporation has to be kept in abeyance on account of the interim directions issued by this

- 3. Learned counsel for the petitioners submits that, by virtue of the directions issued by this Court, certain persons from Ext.P11 list has already been engaged as Abkari workers. According to the petitioners, Abkari workers have to be engaged only from Ext.P11 list.
- 4. Counter affidavit is filed by the Government in which it is stated that the Government is intending to engage about 292 employees from other Department/PSU on deputation basis. It stated that as per the policy of the Government, Corporation has to close down 10% outlets every year. In the light of the fact that the Corporation will be wound up within 10 years as per new Abkari policy, it is proper to depute employees from other Departments/Public Sector Undertakings other than making permanent employment. As far as the facts in issue are concerned, I do not intend to enter into the merits of the claims of the petitioners.
- 5. As matters stand now, petitioners' right is only based on Ext.P11 list. During the pendency of this writ petition, whether the Government should make appointment based on the list.

matter to be considered. Until such time, this Court will not be justified in directing that no person shall be engaged without engaging persons from Ext.P11 list.

6. Accordingly, this application is allowed and the interim order dated 30/06/2015, which is extended until further orders as per order dated 14/07/2015, is vacated and it is made clear that any appointment made by the 3rd respondent either regular or on deputation basis, shall be subject to the result of the writ petition.
