Explanatory Note

(This does not form part of the notification, but is intended to indicate the general purport.)

As per Section 4 (1) of the Kerala Infrastructure Investment Fund Act, 1999 (Act 4 of 2000) the Government may, by notification in the Gazette, constitute with effect from such date as may be specified therein, a Board to be called "the Kerala Infrastructure Investment Fund Board" for the administration of the fund and to supervise or carry out the activities financed from the fund. As per Extraordinary Gazette Notification No.1464 dated 19-8-2016 Government have notified the amendment of the said Act vide the Kerala Infrastructure Investment Fund (Amendment) Ordinance, 2016 (Ordinance No. 6 of 2016). Accordingly the General Body of the Kerala Infrastructure Investment Fund Board has been reconstituted with the Hon'ble Chief Minister as Chairperson of the Board and the same is required to be notified through the Gazette.

This notification is intended to achieve the above objective.
