Mananchira town square is the lung space of Kozhikode corporation urban area which was formed in 1995. This town square which is a Precious property of Calicut town preserved over two decades as a pride for every citizen, without any major changes. Now the square has suffered its own natural degradation, that calls for urgent cleaning and interventions to enhance the character and appeal of the property.

2.Considering the importance of the area in the tourism perspective, the Director, Department of Tourism as per the letter read above sought Administrative Sanction for the project, 'Renovation and Upgradation of Mananchira Square' at an estimated cost of '3 Crore.

Major Components of the Project are as below

i. Open Air Stage and Tiers with paved areas

ii. Additional paving Rough Granite Stone

iii. Unbreakable domes with clear polycarbonate sheets for lamps

iv. Repairs to damaged compound wall including CI Fencing

Government considered the proposal in detail and are pleased to accord Administrative Sanction for the implementation of the project 'Renovation and Upgradation of Mananchira Square' at an estimated cost of 1,70,00,000/- (Rupees One Crore Seventy lakh only) excluding the components, Providing fresh turfing for the main maidan area, Additional paved areas and cast iron Benches. Beatification and amenities for tourists at the RDO office complex and Unforeseen items of work.

ORDER Muttayitheru(S.M. Street) is an important commercial hub the heart of Kozhikode city. This is must to visit place in the iternery for every tourists visiting koznikkode. Series of fire incidents have occured in the street causing large scale damage to property and to people. Accordingly the need to have proper preventive

mechanism has been felt in the area.

2.Accordingly the Tourism Department had prepared a project for the beautification and preservation of S.M. Street. Government have accorded administrative sanction for Rs.2,65,00,000/- vide G.O. (Rt) No.9500/2014 dated 09.12 2014 for the implementation of this project. But due to the non-cooperation of shop owners the project is not implemented. Now the Director of Tourism as per the letter read above sought revised Administrative Sanction for the project. Renovation of Muttayitheru, Koznikode at an estimated cost of 3,64,50,000/- (Rupees Three Crores Sixty Four Lakhs Fifty Thousand only). Major Components of the Project are as below

Drainage, Fire ducts, KSEB cable ducts and provisions for water outlet and electrical connections for each and

ii. Drainage and ducts are covered with concrete slabs and finished with semi polished granite slabs

iii. Remaining portion is proposed to lay rough gobbles of various size for pedestrian and other vehicles traffic.

iv. Provision for proper and safer electric power supply.

v. PVC pipe laying for proper water supply.
