ORDER

The Managing Trustee, Sree Gokulam Educational & Medical Trust, Chennai, vide paper read as first, has applied for starting new self financing college namely Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur under A M Educational Trust, Pazhuvil West, Thrissur for the academic year 2016-17 & 2017-18 after remitting the required fee.

2. The District Level Inspection Commission(DLIC) after conducting inspection, vide paper read as second above, have submitted reports and recommending starting of new college for the academic year 2016-17& 2017-18, with self financing programmes of BA English Language &

Literature(24), BCom with Computer Application (40), BSc Chemistry(24) & BSc Physics(24).

3. The recommendation of the University was forwarded to Government of Kerala for concurrence, vide paper read as third above.

4. The Government of Kerala, vide U.O read as fourth above, have restricted sanctioning of new self financing colleges and programmes.

5. The resolution of the Syndicate to comply with the Government Order detailed in paragraph(4) was implemented vide U.O read as fifth above. Some educational agencies including A M Educational Trust, Pazhuvil West, Thrissur have approached the Honourable High Court of Kerala against this and the University was directed, vide paper read as sixth above, to reconsider the applications submitted by the petitioners and to pass appropriate orders within a period of one month.

6. The matter was placed before the Syndicate and the decision of the Syndicate to grant affiliation only on the basis of the recommendation of the District Level Inspection Commission(DLIC) and NOC from the Government, was implemented vide U.O read as seventh above.

7. Consequently, the educational agencies filed contempt of court against the University and the Syndicate reviewed the decision detailed in paragraph(6). The resolution, to consider applications for starting new colleges and programmes in accordance with the provisions contained in the University Statute and to constitute an academic expert committee to inspect the colleges was implemented vide U.O read as eighth above. Academic expert committee was also appointed vide this order, to verify the physical, instructional and infrastructural facilities available in the proposed new colleges including Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur.

8. Accordingly, the Academic Expert Committee has submitted the reports, vide paper read as ninth above recommending to start Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur with the self financing programmes BA English Language & Literature, BCom with Computer Application, BSc Chemistry & BSc Physics for the academic year 2017-18.

9. Subsequently, the report was placed before the Syndicate and the Syndicate decision to approve the academic expert committee report and to grant affiliation to new self financing colleges for the academic year 2017-18, subject to certain conditions was implemented vide U.O read as tenth above. BA English Language & Literature(24) & BCom with Computer Application (40) are the new programmes sanctioned to Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur.

10. The Principal, Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur, vide paper read as eleventh, has applied to grant provisional affiliation to the college with self financing programmes BA English Language & Literature(24) & BCom with Computer Application (40) for the academic year 2017-18. The college have remitted the affiliation fee of ₹.20,000/- (Rupees Twenty Thousand only) vide chalan No.1884940 dated 03.07.2017 and administration fee of ₹25,000/- (Rupees Twenty five Thousand only) vide chalan No. 1884943 & 18184933 dated 03.07.2017 through University chalan counter.

11. Notarized undertaking in stamp paper worth ₹500/- (Rupees Five Hundred only) duly signed

by the Principal of the college and the Chairman/Manager of the educational agency agreeing to carry out faithfully the provisions of the University Act, Statutes, Ordinance, Regulations and directions issued by the University from time to time was also submitted vide paper read as twelfth above.

12. Considering the matter in detail, the Hon'ble Vice Chancellor, vide paper read as thirteenth, has accorded sanction on 14.07.2017, to grant provisional affiliation to start new self financing unaided college namely Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur, with the self financing programmes **BA English Language & Literature(24) & BCom with Computer Application (40) for the academic year 2017-18**, under the management of A M Educational Trust, Pazhuvil West, Thrissur, **subject to the conditions as specified in the U.O read as tenth above, apart from the usual conditions in sanctioning the new programme.**

13. Provisional affiliation is therefore granted to start **Sree Gokulam College of Arts & Science, Pazhuvil West, Thrissur**, under the management of A M Educational Trust, Pazhuvil West, Thrissur with the following self financing UG programmes for the academic year 2017-18 based on the U.O read as tenth above, subject to the terms and conditions mentioned hereunder.

Since Centralised Admission Process(CAP) for undergraduate programmes has already been completed, the Principal shall admit students in conventional mode with necessary provisions for obtaining CAP ID. The Principal has to strictly comply with the Schedule of Admissions provided along with this order and to report accordingly.

15. Selection and admission shall be made only on the basis of rules and regulations of University/Government and on the basis of directions issued by University/Government from time to time failing which affiliation granted will automatically be cancelled.

16. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take stringent measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

17. The conduct of University Examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

18. A list of colleges which have renewed their provisional affiliation or applied for Continuation of

Provisional Affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for Continuation of Provisional Affiliation.

19. **Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation to the programmes for the ensuing years remitting the fee fixed by University from time to time.**

20. Admission to the next academic year shall be made only after obtaining prior permission from the University.

21. **Principal shall strictly follow the approved syllabus, which is available in the University website.**

The District Level Inspection Commission(DLIC) after conducting inspection, have submitted report vide paper read as second above recommending starting of new college for the academic year 2016-17& 2017-18, with self financing programmes B.Com Finance(40), B.Com Computer Application(40), B.A Economics(40)& B.A English(40).
3. The recommendation of the University was forwarded to Government of Kerala for concurrence vide paper read as third above.
4. The Government of Kerala, vide order read fourth above, have restricted sanctioning of new self financing colleges and programmes.
5. The resolution of the Syndicate to comply with the Government Order detailed in paragraph(4) was implemented vide University Order read as fifth above. Some educational agencies including Pantheerankave Education Society have approached the Honourable High Court of Kerala against this and the University was directed vide paper read sixth above to reconsider the applications submitted by the petitioners and to pass appropriate orders within a period of one month.
6. The matter was placed before the Syndicate and the decision of the Syndicate to grant affiliation only on the basis of the recommendation of the District Level Inspection Commission(DLIC) and NOC from the Government, was implemented vide University Order read as seventh above.
7. Consequently, the educational agencies filed contempt of court against the University and the Syndicate reviewed the decision detailed in paragraph(6). Accordingly, the report was placed before the Syndicate and the Syndicate decision to approve the academic expert committee report and to grant affiliation to new colleges for the academic year 2017-18, subject to certain conditions was implemented vide University Order read as tenth above. B.A English(24) and B.Com Finance(40) programmes were sanctioned to PVS College of Arts & Science, Pantheerankave, Kozhikode.
10. The Principal, PVS College of Arts & Science, Pantheerankave, Kozhikode vide paper read as eleventh above, has requested to grant provisional affiliation to the college with self financing

programmes B.A English(24) and B.Com Finance(40) for the academic year 2017-18. Affiliation fee ₹20,000/-(Rupees Twenty thousand only) and administration fee ₹25,000/-(Rupees Twenty five thousand only) was remitted at University chalan counter vide chalan numbers 1883002& 1883011, 1883014 dated 28.06.2017 respectively.



ORDER

Affiliation was granted to new colleges and new programmes in the existing colleges in view of the judgement dated 21.12.2016 on Writ Petition(C) No. 29761/ 2016 and connected cases, based on the academic expert committee report, vide University Order read as first above.

2. In compliance with the aforementioned University Order, permission was granted to Alphonsa Arts& Science College (existing Unaided college), Sulthan Bathery, Wayanad to start new programme B.A Economics and provisional affiliation was granted to start the following new unaided colleges during the academic year 2017-18, as detailed below:

(a). PVS College of Arts & Science, Pantheerankave, Kozhikode (District) under the Pantheerankave Education Society, Pantheerankave,Kozhikode with self financing programmes B.A English(24) and B.Com Finance(40) vide University Order read as second above.

(b). Luminous Arts & Science College, Vettichira, Athavanad, Malappuram (District) under Mayyeri Educational & Charitable Trust, Valakkulam, Malappuram with self financing programme B.Com Finance(40) vide University Order read as third above.

(c). Devamatha College of Advanced Studies, Kanjirappuzha, Palakkad (District) under Little Kingdom Educational & Charitable Trust, Kanjirappuzha, Palakkad with self financing programme B.A Economics(40) vide University Order read as fourth above.

3.The Manager, Pantheerankave Education Society, Pantheerankave, Kozhikode vide paper read as fifth above has informed that they had applied for two more programmes B.Com Computer Application and B.A Economics apart from the sanctioned programmes. The Academic Expert Committee have recommended all the four programmes they had applied for and the manager has requested to reconsider the case, with

special preference to B.Com Computer Application.

4. The Chairman, Little Kingdom Educational & Charitable Trust, Kanjirappuzha, Palakkad, vide paper read as sixth above, has informed that they had applied for three more programmes, B.Com Computer Application, B.A English & B.Com Finance besides the sanctioned B.A Economics and it is difficult to run new college with only single programme. The Academic Expert Committee have not recommended B.Com Computer Application, B.A English & B.Com Finance as there are no enough facilities in the college to conduct them. The Chairman has requested to take necessary steps for sanctioning other programmes in the college.

5. The Manager, Alphonsa Arts & Science College (existing Unaided college), Sulthan Bathery, Wayanad vide paper read seventh above, has requested to make arrangements to give permission to start more degree and postgraduate programmes. They had applied for BCA, B.Com Computer Application, M.Com & M.A English apart from the sanctioned B.A Economics. All the programmes were recommended by the Academic Expert Committee.

6. The Secretary, Mayyeri Educational & Charitable Trust, Valakkulam, Malappuram vide paper read eighth above, has informed that they had applied for B.Sc Psychology, B.A English, BCA & BBA apart from the sanctioned B.Com Finance. They have requested to sanction other programmes also recommended by the inspection commission. The Academic Expert Committee have recommended BBA & B.Com Finance.

7. Various requests with similar nature, received from the educational agencies/ colleges regarding enhancement of number of programmes for starting in the academic year 2017-18 are placed before the Syndicate vide paper read ninth above.

8. The Syndicate considered the matter, vide paper read tenth above and have **resolved to enhance the number of programmes, sanctioned to various educational agencies/ colleges vide Syndicate item no. 2017. 717 dated 20.06.2017, subject to fulfillment of the remarks furnished by the Inspection Commission as detailed below:**

17. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

18. The list of colleges which have renewed their provisional affiliation or applied for Continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for the same

19. In the light of the directions of the Supreme Court of India in WP (C)No.656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.



ORDER

The Managing Trustee, Lakshmi Narayana Educational and Charitable Trust, Palappuram, Ottapalam, vide paper read as first, has applied for starting new self financing college namely Lakshmi Narayana Arts and Science College, Mayannur, Kondazhi, Thrissur under Lakshmi Narayana Educational and Charitable Trust, Palappuram, Ottapalam, Palakkad for the academic year 2016-17 & 2017-18 after remitting the required fee.

2. The Managing Trustee, has requested to change one of the courses opted for in the application to start the new self financing college and they were preferred to change the course from BBA to BA Economics, vide paper read as second above.

3. The District Level Inspection Commission(DLIC) after conducting inspection, vide paper read as third above, have submitted reports and recommending starting of new college for the academic year 2016-17 & 2017-18, with self financing programmes of B.Com with Computer Application(40), BA English Language & Literature(24), BSc Mathematics(24) & BA Economics(40).

4. The recommendation of the University was forwarded to Government of Kerala for concurrence, vide paper read as fourth above. The Government of Kerala, vide U.O read as fifth above, have restricted sanctioning of new self financing colleges and programmes.

5. The resolution of the Syndicate to comply with the Government Order detailed in paragraph(3) was implemented vide U.O read as sixth above. Some educational agencies including Lakshmi Narayana Educational and Charitable Trust, Palappuram, Ottappalam, Palakkad have approached the Honourable High Court of Kerala against this and the University was directed, vide paper read as seventh above, to reconsider the applications submitted by the petitioners and to pass appropriate orders within a period of one month.

6. Legal opinion from the University Standing Counsel was sought for in the matter of taking further steps in the implementation of the Judgement and as per the Legal opinion received, vide paper read as eighth above. The matter was placed before the Syndicate and the decision of the Syndicate to grant affiliation only on the basis of the recommendation of the District Level Inspection Commission(DLIC) and NOC from the Government, was implemented vide U.O read as ninth above.

7. Consequently, some of the affected educational agencies and affiliated colleges filed contempt case against the University and the Syndicate reviewed the decision detailed in paragraph(5). The resolution, to consider the applications for starting new colleges and programmes in accordance with the provisions contained in the University Statute in the wake of the judgement of the Hon'ble High court of Kerala and resolved to authorize Vice-Chancellor to constitute an academic expert committee to inspect the colleges was implemented vide U.O read as tenth above. Academic expert committee was also appointed vide this order, to verify the physical, instructional and infrastructural facilities available in the proposed new colleges.

8. In the meantime, various other educational agencies and affiliated colleges who had submitted applications for starting a new college or for additional affiliation of new programmes obtained similar judgements from the Hon'ble High Court of Kerala with direction to consider their applications within the specified periods as specified in the Judgement. As ordered by the Hon'ble Vice Chancellor, the whole matter was placed before the Syndicate for consideration and appropriate action. The Syndicate meeting held on 20.06.2017 has resolved to conduct a fresh inspection at these colleges by an academic expert committee to be nominated by the Vice-Chancellor and authorized the Vice-Chancellor to take appropriate decision based on the report and the same has been implemented vide U.O read as eleventh above.

9. Accordingly, vide U.O read as twelfth, an Academic Expert Committee has been constituted to inspect the colleges for verifying the physical / instructional / infrastructural prerequisites for starting the college, who have received such judgements from the Hon'ble High Court of Kerala. Academic Expert Committee has submitted the reports, vide paper read as thirteenth above recommending to start Lakshmi Narayana Arts and Science College, Mayannur, Kondazhi, Thrissur with the self financing programmes B.Com with Computer Application(40), BA English Language & Literature(24), BSc Mathematics(24) & BA Economics(40) for the academic year 2017-18.

Remarks of the Academic expert committee

BCom Computer Application - Number of books in library to be increased, Multiple copies of text books to be purchased within 2 months & Infrastructural facilities to be improved within 6 months.

BA Economics - Library books selected to economics may be purchased, Journals & Periodicals subscribed may be done in future & Improvement of ICT facility to be ensured with immediate effect.
[The college has enough infrastructural facilities to accommodate students of the sanctioned course. But adequate changes and development have to be made in the near future.]

BA English Language and Literature - More books should be acquired & Academic journals should be subscribed as the programme progresses.

10. Subsequently, the reports submitted by the expert committee has been placed before the Syndicate, and the Syndicate vide resolution No.2017.837* dated 12.07.2017 considered the report and resolved to approve the reports of the Academic Expert Committee and to grant affiliation to the new colleges subject to fulfillment of remarks furnished by the Inspection Commission, was implemented vide U.O read as fourteenth above.

11. The Principal, Lakshmi Narayana Arts and Science College, Mayannur, Kondazhi, Thrissur, vide paper read as fifteenth, has applied to grant Provisional affiliation to the college with the self financing programmes BCom with Computer Application(40), BA English Language & Literature(24) & BA Economics(40) for the academic year 2017-18. The colleg have remitted the affiliation fee of ₹.30,000/- (Rupees Thirty Thousand Only) vide chalan No. 1892062 & 1892065 dated 18.07.2017 and administration fee of ₹.25,000/- (Rupees Twenty Five Thousand Only) vide chalan No.1892060 & 1892061 dated 18.07.2017 by University chalan counter.

12. At present, the College is functioning in a temporary building at Palakkad Dist. Further, the Managing Trustee has also informed that the temporary classes would be conducted in the proposed college for a period of two years at Palappuram, Ottapalam-679 103 (Palakkad District) and also requested to forward all communications to the said address. The Principal has also submitted an undertaking, vide paper read as sixteenth, to the effect that all relevent actions with regard to the remarks made by the Academic Expert Committee would be expedited based on the same.

13. Notarized undertaking in stamp paper worth ₹200/- (Rupees Two Hundred Only) duly signed by the Principal of the college and the Chairman/Manager of the educational agency agreeing to carry out faithfully the provisions of the University Act, Statutes, Ordinance, Regulations and directions issued by the University from time to time was also submitted vide paper read as seventeenth above.

14. Considering the matter in detail, the Hon'ble Vice Chancellor, vide paper read as eighteenth, has accorded sanction on 20.07.2017, to grant Provisional affiliation to start new self financing unaided college namely Lakshmi Narayana Arts & Science College, Mayannur, Kondazhi, Thrissur with the self financing UG programmes BCom with Computer Application(40), BA English Language & Literature(24) & BA Economics(40) for the academioc year 2017-18 under Lakshmi Narayana Educational and Charitable Trust, Palappuram, Ottapalam, Palakkad subject to the conditions (subject to fulfillment of remarks furnished by the Inspection Commission) as specified in the U.O read as fourteenth above.

15. Provisional affiliation is therefore granted to start Lakshmi Narayana Arts and Science College, Mayannur, Kondazhi, Thrissur under the management of Lakshmi Narayana Educational and Charitable Trust, Palappuram, Ottappalam, Palakkad with the following self financing UG programmes for the academic year 2017-18 based on the U.O read as fourteenth above, subject to the terms and conditions mentioned hereunder.

ORDER

The applications for new colleges and programmes from eligible agencies/ colleges, for the year 2016-17 and 2017-18 were called for, vide circular cited 1st and the applications so received are subjected to an inspection by the District Level Inspection Commission to verify whether the institutional and infrastructural facilities are sufficient to grant affiliation. The recommendations of the DLIC are then considered by the Syndicate and the proposal for starting a new college/ programme, as the case may be, as recommended by the Syndicate, was forwarded to the Government for the issuance of Administrative Sanction and NOC, vide letters cited 2nd and 3rd.

2. In the meantime, the Government, vide paper read as 4th, issued orders restricting the sanctioning of new self-financing colleges and programmes. The Syndicate at its meeting held on 29/08/2016, vide paper read as 5th, resolved to comply with the G.O.(MS) No. 178/2016/H.Edn dated 22.08.2016 with regard to the granting of affiliation to new colleges and programmes. In the event of non receipt of the Administrative Sanction and NOC from the Government, some educational agencies approached the Hon'ble High Court for favourable orders. The Hon'ble High Court of Kerala while allowing the petitions filed by the various educational agencies/ colleges (under various Universities) proclaimed Judgement WP(C) No.29761/2016 dated 21-12-2016, declaring the impugned Govt. order G.O.(MS) No. 178/2016/H.Edn dated 22.08.2016 are declared as unconstitutional and void. Hence, it is directed to reconsider the applications submitted by the petitioners and pass appropriate orders within a period of

one month.

3. The Syndicate meeting held on 27/01/2017 considered the whole matter in the light of the legal opinion received (vide paper read as 6th) and resolved, vide, paper read as 7th, to grant affiliation only on the basis of the recommendation of the DLIC and NOC from the Government and to submit the matter before the Hon'ble High Court of Kerala through the Standing Counsel. Consequently, some of the affected educational agencies and affiliated colleges filed contempt case against the University. The Syndicate meeting held on 06/05/2017 reviewed their earlier resolution No- 2017.093* dated 27.01.2017 (read as 7th) and resolved, vide paper read as 8th, to consider the applications for starting new colleges and programmes in accordance with the provisions contained in the University Statute in the wake of the judgement of the Hon'ble High court of Kerala and resolved to authorize Vice-Chancellor to constitute an academic expert committee to inspect the colleges. The Syndicate has further resolved to report the entire matter to the Government.

4. Accordingly, vide U O read as 9th, an Academic Expert Committee has been constituted to inspect the colleges for verifying the physical / instructional / infrastructural prerequisites for starting the college/ programmes. Considering the importance of the matter and to finalise the matter in a phased manner, the work of supervising and co-ordinating the inspection was assigned to a Syndicate member in each district. The reports submitted by the expert committee has been placed before the Syndicate and the Syndicate vide resolution No- 2017-717* dated 20/06/2017 considered the report (UO No-7892/2017/Admn dated 24/06/2017).

5. In the meantime, various other educational agencies and affiliated colleges who had submitted applications for starting a new college or for additional affiliation of new programmes obtained similar judgements from the Hon'ble High Court of Kerala with direction to consider their applications within the specified periods as specified in the Judgement. As ordered by the Hon'ble Vice Chancellor the whole matter was placed before the Syndicate for consideration and appropriate action. The Syndicate meeting held on 20/06/2017, vide paper read as 10th above, resolved to conduct a fresh inspection at these colleges by an academic expert committee to be nominated by the Vice-Chancellor and authorized the Vice-Chancellor to take appropriate decision based on the report and the same has been implemented vide U.O read as 11th above.

6. Accordingly, vide U O read as 12th, an Academic Expert Committee has been constituted to inspect the colleges for verifying the physical / instructional / infrastructural prerequisites for starting the college/ programmes, who have received such judgements from the Hon'ble High Court of Kerala. The reports submitted by the expert committee has been placed before the Syndicate and the Syndicate vide Resolution No- 2017-837* dated 12/07/2017 considered the report and resolved to approve the reports of the Academic Expert Committee and to grant affiliation to the new Colleges and new programmes subject to fulfillment of remarks furnished by the Inspection Commission. It is also resolved to seek legal opinion from the Standing Counsell for granting new self-financing courses in aided colleges.

7. Considering the matter in detail, in order to make the implementation of the above Syndicate Resolution comprehensive and complete and also to enable to implement the same scrupulously, the Hon'ble Vice Chancellor granted permission on 15/07/2017 to implement the Syndicate Resolution Item No. 2017-837* dated 12/07/2017 by incorporating the following items also.

1. To grant provisional affiliation to the new colleges/programmes for the academic year 2017-18.
2. Since the CAP for the UG programme has already been completed, to grant permission to colleges for admitting the students in conventional mode for UG programmes, from the candidates who are having current year CAP id and also as per the Schedule of Admissions as already approved from the Directorate of Admissions.
3. The DoA shall provide facility for generating CAP ids exclusively for the candidates to these programmes.

4. The whole process of action taken so far be reported to Legal Cell for onward transmission to the Standing Counsel, as the decision has been taken in the light of the Court decision and the cases are pending with the Court.
5. To inform all the decision to all concerned.
6. To conduct the admission to PG programmes through CAP process.


