In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) and in supersession of all the existing orders on the subject, the Government of Kerala make the following Special Rules for the Kerala Agricultural State Service, namely:-



RULES

- **1.** Short title and commencement :- (1) These rules may be called the Kerala Agricultural State Service Special Rules, 2021.
 - (2) They shall come into force at once.
- **2.** Constitution:- The service shall consist of the following branches and categories of officers, namely:-

- **6.** <u>Reservation of Appointment:</u> The rules relating to reservation of appointment contained in rules 14 to 17 of Part II of the Kerala State & Subordinate Service Rules, 1958 shall apply to the appointment by direct recruitment.
- **7.** <u>Probation</u>:- Every person appointed to any of the Categories shall from the date on which he / she joined duty, be on probation for a period as per conditions laid down in KS&SSR.

8. <u>Test qualification:-</u> Every person appointed to any of the categories mentioned in these rules shall within the period of probation pass the Account Test for Executive Officer or Account Test (Lower) unless he has passed the same.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Special Rules for the Kerala Agricultural State Service have not been issued so far. Government now proposes to issue the Special Rules for the posts included in the Service by prescribing qualifications, method of appointment etc. in supersession of all orders on the subject.

The notification is intended to achieve the above object.
