ORDER

Government are pleased to accord in-principle sanction for the construction of 39 Road Over Bridges/Road Under Bridges included in the various Railway Work Programmes and announced in the Budget Speech 2018-19 as detailed below for an amount of Rs. 878 crores by availing fund from Kerala Infrastructure Investment Fund Board (KIIFB). The Roads & Bridges Development Corporation of Kerala Ltd (RBDCK) is designated as the Special Purpose Vehicle (SPV) for executing these projects.

2. Minutes of the 19th Executive Committee Meeting OF KIIFB that held on 06.08.2021

Government, through the Budget Speech 2018 -19 had announced a main project "Construction of 42 Road Over Bridges/Road Under Bridges" and thus Administrative Sanction has been issued vide Government Order read 1<sup>st</sup> above designating Roads and Bridges Development Corporation Ltd (RBDCK) as the Special Purpose Vehicle (SPV) for executing the 39 Road Over Bridges / Road Under Bridges for a total cost of Rs.878 Crore.

Accordingly, the Detailed Project Report submitted for the 'Construction of ROB in lieu of LC 7 in between railway km 81/800 -900 Nalukody in between Changanassery & Thiruvalla RLY station in Kottayam district' which is one among the announced RoBs was verified for adherence to KIIFB stipulations and appraised for compliance, as per GO(Ms) No.315/16/Fin Dated 08.08.2016 and GO(Ms) No.69/2018/Fin Dated 24.02.2018 and was found satisfactory and compliant.

The 19<sup>th</sup> executive committee of KIIFB that met on 6<sup>th</sup> August 2021, after considering the proposal and appraisal report, has granted approval for the project. Accordingly, sanction is accorded for funding the Project **"TRAN-20 PWD011-29 "Construction of ROB in lieu of LC 7 in between railway Km 81/800 -900 Nalukody in between Changanassery & Thiruvalla RLY station in Kottayam district "**, to be implemented by Roads and Bridges Development Corporation of Kerala Ltd (RBDCK) at a total outlay of **Rs.39,09,40000/- (Rupees Thirty-Nine crore Nine lakh and Forty thousand only)**, (including land acquisition), subject to the following stipulations.

1. The project shall be considered for funding by KIIFB subject to the execution of Tripartite agreement.
2. The technical sanction by competent authority is mandatory before initiating tendering process. Technical sanction may be issued by SPV only after incorporating the suggestions indicated in detailed appraisal report and the compliance shall be communicated to KIIFB prior to issuance of tenders.
3. The detailed estimate shall strictly be reviewed and scrutinized by the TS authority. In order to avoid any ambiguity during execution, the TS authority should confirm that all the proposals are technically sound and also that the estimates are accurately prepared. Also, it should be ensured that the electrical estimate is as per PRICE mode.
4. The cost provisions earmarked against work alone shall be utilized for execution of work. The savings or anticipated savings from LA, QC, shifting utilities etc. shall not be re appropriated

for meeting expenditure of work proper.

5. A report of KIIFB premised on the technical appraisal of the project is appended for reference, which shall be taken into consideration by the TS committee while according TS to the project.
