02. A detailed proposal for opening a new Police Station at Paivalige, Kasaragod was submitted to the Government, vide letter cited 1<sup>st</sup>. Based on the same, Government have requested vide letter cited 2<sup>nd</sup>, to re-submit the proposal after finding out posts from the Police Stations from where the jurisdictional area is reduced & confirming the availability of building and other amenities. As suggested by the Government, the possibility of re-deployment of manpower has been explored and the same is detailed as below.

03. **Strength Required:** The following posts are required for the functioning of the proposed Police Station at Paivalige.

It may please be noted that one post of Inspector of Police only is required for the proposed Police Station through creation or up-gradation (Financial commitment statement is enclosed). The remaining 39 posts can be filled through re-deployment basis as follows.

**04. Details of Land and Building:** DPC, Kasaragod vide reference 3<sup>rd</sup> cited has informed that 0.30 acre of Govt land is available in Paivalige village and District Collector, Kasaragod has passed an order on 23.02.2023 transferring the Government land belonging to Resurvey No.493/Part of Paivalige village to the Home Department, retaining its ownership to Revenue Department for the purpose of



establishing Paivalige Police Station. It is also informed that a rented building can be arranged for housing the Police Station till a new building is constructed, in case of getting approval for the Police Station.

05. Under the above circumstances, it is requested that the proposed Police Station may please be sanctioned at the earliest.
