The Director, Bhavani Tea and Produce Company Limited, having its registered Office at Punalur in Pathanamthitta District and Administrative Office at "Nandagokul", R.S.Puram, Coimbatore-2 has filed a statement dated 15.12.1972 under section 85A, of the KLR Act before the State Land Board, Trivandrum. The statement was subsequently transferred to this Taluk Land Board for disposal. The statement was got verified through the Special Deputy Tahsildar (LR) Agali (Authorised Officer of the Taluk Land Board) who submitted his verification report dated 5.7.1981. After going through the relevant records, the Taluk Land Board, Mannarkkad in its order 2nd cited, found that the company is found holding lands, excluding the lands falling under the exempted category, within the ceiling area, decided to drop further action and

record the case. Thereafter the State of Kerala filed CRP No. 2012/82A before the Hon'ble High Court of Kerala against the order dated 16.7.81 of the Taluk Land Board, Mannarkkad. The Hon'ble High Court while disposing the said CRP No. 22.6.1988, set aside the order of TLB and remanded the case for fresh disposal. Then the case file in CC.158/74 of the Taluk Land Board Mannarkkad was taken by the State Vigilance Department, Palakkad for enquiry in connection with their file No.P/33/89 dated 5.1.89, as directed in Para 11 of High Court's judgment. Thereafter the Director, Bhavani Tea and Produce Company Limited, taken up the matter in Special Leave Petition (Civil) No.14292 of 1988 before the Hon'ble Supreme Court of India. The Hon'ble Supreme Court in its order dated 22.3.1990 in the above SLP, disposed of the case upholding the High Court's judgment in the matter of redetermination of the ceiling area after detailed further enquiries. Then the Vigilance Department returned the case file of the Taluk Land Board on 6.7.1990.

2. On receipt back of the file the Taluk Land Board issued individual notices of revised draft statement on 14.2.1991 posting the case to 14.3.91. On that date declarant filed counter statement, in which they have requested among other things for a fresh physical verification by the Authorised Officer. The Taluk Land Board directed its Special Deputy Tahsildar (Authorised Officer) to conduct fresh detailed enquiries and to submit report regarding the actual extent of land possessed by the declarant Company. The Authorised Officer in his report dated 6.4.91 requested for the services of a Surveyor in order to enable him to identify each sy.No. holding and identity, classification of the lands possessed by the Company.

Accordingly, the Taluk Land Board took up the matter with the District Collector and as per Collector's proceedings No.LR(A)4-22084/89 dated 18.9.91, Sri.K.P.Chandrasekharan Nair, First Grade Surveyor was deputed, for conducting the Survey work and also assist the Authorised Officer in this case. The Surveyor conducted detailed survey of the lands owned and possessed by the Company as per document Nos.2204/45, 5898/46, and 227/56 of SRO Mannarkkad, according to which the Total extent owned by the Company is 3273-72 acres. But, according to the Survey conducted, the actual extent possessed by the Company is 3407-01 acres and the Surveyor has also reported on 19.8.1992, that there is no "excluded tract" as stated earlier in the said documents and draft statement. For evidence to establish this point, he has copied a copy of sketch appended to Doct.No.812/1943 of the SRO Mannarkkad. On the basis of the survey conducted and arealist furnished by the Surveyor, the Authorised Officer conducted physical verification of the entire area involved in the ceiling case along with the Surveyor and submitted his report on 13.4.1993.

3. The Taluk Land Board met on 22.4.93 perused the records of enquiry, discussed the matter in detail and decided to issue revised draft statement. Accordingly individual notice of revised draft statement was issued to all interested parties on 22.7.93 posting the case to 26.8.93 directing them to produce evidence if any against the draft statement and calling upon them for a hearing before the Taluk Land Board. The individual notice of draft statement was duly published and served. On that day, Advocate K.S.R.Umni appeared for R.157 Sri.C.V.Mulk and filed vakalat -

On 17.2.94, Advocate A.R.Sahib filed Vakalath on behalf of R.138 and Advocate K.S.R.Unni appearing for R.157, stated that he proposes to file Vakalath for R.15, 40,41,42,43,47, 48,49,50,51,89,108,109,110,111 and 112 during next hearing which was fixed for 17.3.94. On that date R.52 and R.119 appeared in person and filed counter and copies of certificate of purchase to prove their title over the properties. Then the case was adjourned to several time and on 28.7.94, the Advocate K.S.R.Unni appeared and promised to file Vakalath and counter in respect of the above respondents ie. R.15, 40, 41, 42, 43, 47, 48, 49, 50, 51, 89, 108, 109, 110, 111 and 112. But he has not done so till date. On 28.7.94 Advocate A.R.Sahab appearing for R.138 requested time for counter. Sri. Poulose S/o Poulose, Thettikot, Kuravanpady, Sholayur (R.118) appeared in person and promised to file counter and documents during the next hearing. Advocate T.P. Haridas appearing for declarant Company filed Cardamom registration Certificate No.2/1967 dated 31.5.67 issued by the Sub Collector, Ottapalam and argued that exemption may be granted for additional 66 acres comprised in sy.No.1687 of Sholayur village covered by the above registration certificate, as the said plantation was in existence even prior to 1.4.1964, in addition to the exemption granted for 89-30 acres, as per revised draft statement. Advocate V.V.Thampi appeared for R.61 and R.76 and filed Vakkalath and counter with copies of document on behalf of the respondent 61. After several adjournment, Advocate Jose Joseph appearing for 45 numbers of respondents prayed for further time to file counter and documents. Again on 15.11.94, Advocate A.R.Sahib, filed vakkalath for R.137, R.139, and R.140 and counter for R.138 Sri. Tharakkunnel Baby Joseph S/o Joseph. After adjourning the case for a number of times; Advocate Jose Joseph appeared and filed counter for R.120, R.123, and R.44 on 27.4.1995. Again, he filed counter for R.30, R.47, R.57 and Vakkalath for R.16 with counter. The case was then posted to 18.5.95, 25.5.95, 8.6.95 and 15.6.95 and on that day counter statements have been filed for R.148, R.130, R.144 and documents in respect of R.120 and R.123. The respondents

The respondent No. 145 Sri. Valladan George expired and hence Vakka Lath and counter statement and impleading petitions have been filed by Advocate Jose Joseph on behalf of Smt. Leelamma, W/o the deceased Vallamadan George. The case was posted for argument on 22.6.1995. Sri. Jose Joseph Advocate appeared and stated that Sri. C.S. Philip R5 has no right over the property included in the draft statement and that his wife Smt. Philomina Philip is having title over the land of 5-00 acres and hence she may be impleaded as supplement respondent. The impleading petition was allowed and the Advocate filed counter and documents on behalf of Smt. Philomina Philip. As this is a long pending case, adjourning/postponing for evidence for many a time, the TIB decided to publish a notice on the notice Board of the Taluk Office directing the interested parties/ Advocates to file evidence if any on 29.6.95 as a last chance. Accordingly a notice was published.

5. On 29.6.95, Advocate V.V. Thampi appeared for R. 61 and R. 76 and prayed for time to file counter for R. 76. Hence the case was adjourned to 6.7.1995. On that day, Advocate V.V. Thampi filed counter with documents for R. 76. But the discussion could not be completed on that day (6.7.95) and the case was adjourned to 13.7.95.

The Taluk Land Board met on 13.7.95, perused all the relevant records, discussed the matter in detail and arrived at the following decisions.

6(i) The declarant company in its additional counter dated 17.3.1994 has stated that it is not correct to have been shown the classification of 66-00 acres of land in sy. No. 1687 of Sholayur village as OD and classifying an extent of 89-30 acres only as Cardamom plantation in the

revised draft statement issued on 22.7.93. They have also produced a photostat copy of cardamom registration certificate No.2/1967 dated 31.5.1967 issued by the Sub Collector, Ottapalam and stated that the total extent of 155-30 acres, including 66-00 acres of land shown as OD plus 89-30 acres classified and shown as cardamom ^{plantation} in the draft statement are to be classified and treated as cardamom plantations and may be exempted under section 81 of the Act. The Taluk Land Board perused the certificate and found that the contention of the declarant is correct. Hence it is decided to grant additional exemption of 66-00 acres comprised in Sy. No. 1687 of Sholayur Village being cardamom plantation.

6(ii) Claim of supplemental respondent (R-173) (Vide R5)

Smt. Philomina Philip W/o Chayarapuzha Philip, Kuravanpady Sholayur Village is discussed as under:-

Smt. Philomina Philip has filed impleading petition on 22.6.95 through Advocate Jose Joseph, stating that her husband Sri. C.S. Philip, ^(R5) Chayarapuzha, Sholayur, Shown as R5 in the draft statement has no right over the properties and that since the properties are in her name she may be impleaded as supplemental Respondent. Her request was allowed and she is impleaded as supplemental R.173.

Accordingly she has filed counter statement on 22.6.95, in which it is stated that her predecessor in interest, Sri. Kuravanpady Madathumpady Poullose S/o Paily, obtained lease hold right over 5 acres of land in prely. sy. No.1687 part of Sholayur village from the Jenmi Marmarkkad Moppil Nair during the year 1962 and subsequently he obtained certificate of purchase No.723/78 dated 8.5.1978 in SM.638/78 of the Land Tribunal Agali and that she purchased

 The land owner Smt. Poulose as per Govt. Doc. No. 522/1988 dated 10.9.80 of S.R.O. Mammakkad. She has produced attested copies of the certificate of purchase, Teer deed and the following Basic tax receipt obtained from the Village Officer, Sholayur.

1. Receipt No.65 of Book No. 147 dated 11.12.79 for Rs.80/- for the period from 1970-71 to 1977-78 in the name of Sri. Poulose, S/o Paily.

2. Receipt No.58 of Book No.77 dated 4.11.85 for Rs.141.50 for the years 1981-92 to 1985-86 in the name of Smt. Philomina Philip.

3. Receipt No.55 of Book No.232 dated 6.3.90 for Rs.181.00 for the years 1986-87 to 1989-90 in the name of Smt. Philomina Philip.

She has stated that there are Rubber, Coconut and Arcanuth trees, coffee, Pepper, Cardamom etc. aged over 33 years in the 5 acres of land in her possession and enjoyment and that she has availed loan from the S.B.I. Agali Branch for the improvement of the property and hence the property may be deleted/excluded from the ceiling area of the declarant in this case. The TIB perused the records in detail and found that there is no allegation against obtaining certificate of purchase in this case and no fraud or collection could be found out. Hence it is decided to accept the claim of the R.173 and an extent of 5 acres of land from sy.No.1687 part of Sholayur Village will be deleted from the account of the declarant.

(iii) R.15, Sri. Pookkunnel Mathai John, Kuravampadi, Karayil, Sholayur Village, in his counter statement dated 26.8.1993 filed in person has stated that he took lease hold right over 2 acres of land in sy.No.1687 part of Sholayur Village directly from the jenni Mannarkkad Moopil Nair as per M.R. receipt and that he has obtained certificate of purchase from Land Tribunal Agali and that he is residing in the land with family after constructing house. He has not produced the M.R. receipt and C.P. to prove his claim over the land and hence the TB decided to reject his claim.

6(iv) In the counter statement filed through Advocate Jose Joseph, R.16, Sri. Thomas Kakkomparambil, S/o Thoman Kuravampady, Chittur, Sholayur village, has stated that 5 acres of land in sy.No.1687 part of Sholayur village was obtained by him on lease hold right, directly from the jenni Mannarkkad Moopil Nair during 1960 and that he is residing in the property with family and have planted coconut, arecanut, Rubber, Pepper, Mango, Coffee etc. He also stated that he has obtained certificate of purchase No.1036/1978 dated 2.6.1978 in S.M.1021/78 of the Land Tribunal, Agali and hence the property may be →

deleted / excluded from the ceiling case of the declarant company. He has also stated that he had availed Agricultural loan facilities to raise plaintain cultivation in the land from the S.B.I. Agali during 1985. There is no allegation that the C.P. in this case was obtained on fraud or collusion and the TDS finds no reason to disbelieve the contention of the claimant. Hence it is decided to delete an extent of 5 acres in Sy.No.1687 of Sholayur Village from the account of the declarant company.

6. (v) In the counter statement filed on 4.5.95 by R.30 Sri. Kappalankkud Joseph, S/o. Joseph, through Advocate Jose Joseph, it is stated that he has 2.20 acres of landed properties in prely.Sy.No.1687 part of Sholayur Village and that 1.50 acres out of the 2.20 acres in his possession forms part of 8 acres of land taken on lease hold right by his father Joseph during 1959, directly from the Jenmi Mannaikkud Mooppil stanam. He has also stated that Pepper, Mango, arecanut, coconut etc were planted in the land while the land was in the possession of his father Joseph, and that he (R30) has obtained certificate of purchase No.1130/78 from the Land Tribunal, Agali. He has further stated that the improvements are still existing in the 1.50 acres of land and that he has availed agricultural loan facilities from the S.B.I. Agali during 1986, producing the said certificate of purchase. He has added that he has remitted Basic Tax for the land from 1978 onwards and has produced two receipts thereof. He has, in the above circumstances, requested to delete the above 1.50 acres of land from the ceiling case of the declarant. He has not produced the C.P.

As regards the balance extent of 70 cents, out of the total extent of 2.20 acres in his possession and enjoyment, R-30 said that he obtained title over the land as per Doct.No. 384/1988 dt. 10.8.1988 of S.R.O. Agali, as per which his predecessor in interest Sri. Pulayanparambil Babi, S/o. Augusti, Kuravampadi, obtained lease hold right over the property during 1969 directly from the jenni Mannarkkad Mooppil stanam. But according to R.30, it was Sri. Pulayan Parambil August, Father of Babi, who obtained lease hold right from Mannarkkad Mooppil Stanam during 1960. R30 has further stated that he along with his family is residing in the said land, in house No.119 of Ward I of Sholayar Panchayath and therefore the said portion of (70 cents) may also be deleted from the account of the declarant.

The TLB has perused the records and examined the contentions raised by R.30 in detail. The claim with regard to 1.50 acres of land in Prcly.Sy.No.1687 part of Sholayur Village is rejected since the Respondent No.30 has not produced certificate of purchase for verification. As regards the claim over 50 cents in the same Sy.No., it is also rejected in the absence of Certificate of purchase and also in view of the ^{de}cited in the Document No. 384/88 dt. 10.8.88 of S.R.O. Agali.

6. (vi) R.41. Sri. Vadakkedath Manuel George, S/o.

Varghese, Kuravampodi Karayil, Sholayur Village, filed his counter statement dt. 26.8.93 directly, in which he has stated that he is residing in the landed property with family in 2 acres of land comprised in prely.Sy.No.1687 of Sholayur Village, which was taken over by him with lease hold right directly from the jenmi Mannarkkad Mooppil Stanam. He has promised to produce the M.R. receipt and certificate of purchase obtained from the Land Tribunal Agali within 30 days, but he has not produced any records till date. Since the claimant has not proved his title over the land, the T.L.B. decided to reject his claim.

6. (vii) R.44, in his counter statement filed on 4.5.95 through Advocate Jose Joseph has stated that his correct name is V.D. Mathew and not P.D. Mathew as shown in the draft statement. He (Sri. V.D. Mathew, R.44, S/o. Devassia, Vadakke Malanhanal, Kuravampodi) has also stated that he obtained lease hold right over 5 acres (2.0234 Hectares) of land in prely. Sy.No.1687 part of Sholayur Village during 1959 directly from the jenmi, Mannarkkad Mooppil stanam and has planted Pepper, Rubber, coconut coffee etc. He has obtained certificate of purchase No.77/1978 dt. 21.3.78 in S.M.1372/1977 of the Land Tribunal, Agali. He has produced photostat copy of the certificate of purchase, Photo copy of B.T. receipt dt.3.4.95 for having remitted B.T. for the years 1993-94, Photo copy of Receipt dt. 29.12.1962 for having paid pattam to Mannarkkad Mooppil Stanam, and original copy of Rubber Board Registration Certificate No.237 Mannarkkad dt. 19.1.72 for an extent of 1.42 hectares in Sy.No.1687 part of ^{Sholayur} Agali Village and original Letter No.MGT.237/72 dt.2.2.72 of the Deputy Development Officer, Rubber Board,

Agricultural Office, Kozhikode to prove his contentions. He has stated that the property may be deleted from the ceiling case in this case.

The T.L.B. finds no reason to disbelieve the contentions of the claimant. There are no allegations that the certificate of purchase was obtained by the claimant on fraud or collusion. Hence the TLB decided to delete an extent of 5 acres of land in prely. Sy.No.1687 of Sholayur Village from the account of the declarant.

6. (viii): - R.47, Sri. T.D. Thomas, S/o. Devassia, Thundathil, Koruvampadi in his counter statement Dated 4.5.95 filed through Advocate Jose Joseph has stated that he obtained title over 1 acre of land in prely. Sy.No.1687 of Sholayur Village, as per Teer Deed No.433/1989 dt. 17.3.89 of S.R.O. Agoli, from Smt. Sali, W/o. Anakkalingal Sanny, who obtained the property as per settlement deed No.66/1988 of S.R.O. Agoli from her husband Sanny. Sri. Sanny obtained the land from Sri. Karunakaran, S/o. Elampurayidathil Kunhan, who has got certificate of purchase No.59/1978 dt. 5.1.78 in S.M.No.1494/1977 of the Land Tribunal, Agoli. Sri. T.D. Thomas has produced photostat copy of the Teer Deed No.433/89 ^{and C.P. No: 59/78} and has stated that he has planted Rubber, Pepper, Coffee etc in the land and has availed Agricultural Loan facilities during 1990 from the S.B.I. Agoli Branch. In the circumstances, he has requested to exclude the land from the ceiling case of the declarant.

The TLB has examined the claims in detail and found no reason to disbelieve the contentions raised by (R47). Accordingly it is decided to delete an extent of 1 acre of land in prely. Sy.No.1687 from the account of the declarant.

Sholayur Village, in his counter-statement dt. 4.5.95 filed through Advocate Jose Joseph, has stated that he obtained lease hold right over the land in prely. Sy.No.1687 Pt, with an extent of 4 acres directly from the jenmi Mannarkkad Mooppil Stanam since 1963 January and that he is residing in the land with family and cultivating Kodi (Pepper), arecanut, coconut, Coffee, Mango etc, and that he has obtained certificate of purchase No.846/1978 in S.M.No.742/1978 of the land Tribunal, Agali. He has also stated that he has availed Agricultural loan facilities from the S.B.I. Agali and the certificate of purchase and judgement in S.M.742/1978 of L.T. Agali have been filed in the S.B.I. Agali, but however, he has produced a photocopy of the judgement in S.M. 742/78 and State Tax receipt (photo copy) for the years 1988-89 to 1991 -92 and requested to exclude the said 4 acres of land from this ceiling case.

The TTB finds no reason to disbelieve the contentions of the claimant in this case. There are no allegations that the claimant obtained C.P. on fraud or collusion. Hence it is decided to delete an extent of 4 acres in Sy.No.1687 Pt. of Sholayur Village from the account of the declarant.

6. (xii):- R-61, Varkkoochan, (Varkey, S/o. Ouseph), Kulangara Veedu, Koravampody, Sholayur Village, filed Vakkalath name dt.13.11.1993 along with R.76 Karunakaran, through Adv.V.V.Thampy, on 27.10.94, and also filed on 27.10.94, counter statement dt.1.9.94 prepared by the Adv.on behalf of R61, with photo copy of jenmam Teer Deed No.2330/1986 dt. 2.5.1986 of S.R.O Mannarkkad., Photocopy of certificate of purchase No.967/1978 dt. 30.5.1978

in S.M.922/1978 of the Land Tribunal Agali, and Form T.R.5 receipt No.40 of Book No.2507 dt. 5.4.80 of the L.T. Agali. Again, counter statement dt. 5.7.95 along with copies of the above said documents was filed by R.61, on 6.7.95 in which it is stated that he purchased 1.50 acres of land with house and improvements in it, comprised in prely. Sy.No.1687 Part of Sholayur Village as per Teer Deed No.2330/1986 of S.R.O.Mannerkkad, from Sri. Gopi, S/o. Ayyappan, Kanamthottathil, Koravampady, Chittur, Sholayur Village, who (Sri. Gopi) obtained certificate of purchase No.967/1978 of Land Tribunal, Agali, Sri. 6 (xiii): - R.76, Sri. Karunakaran, Koravampady, Sholayur in his counter statement dt. 5.7.95, filed through Advocate V.V. Thambi on 6.7.95 has stated that the land belonging to him may not be included in the ceiling case of the declarant in this case, since he is in possession & enjoyment of the land for a pretty long time. He has not stated the extent of land in his possession and enjoyment, its Sy.No. etc, and also not produced any documentary evidence in support of his claim.

In the circumstances the TLR to reject the claim of R.76

6(XIV) :- R.109, Kuravanpadikarayil Thamasikkum Vadakke Mulanhanal Kunhouseph in his counter statement dated 26.8.93 filed in person stated that his name is shown against R-143 also in the draft statement; that he has got 4.50 acres of land in prely, Sy.No. 1687 pt of Sholayur Village, directly obtained by him on leasehold right from the jenmi Mannarkked Mooppil Nair for which he has obtained certificate of purchase also from the Land Tribunal, Agali; that he is residing in the land with family duly constructing house; and that the M.R. receipt in token of having obtained lease hold right and C.P. etc. will be produced within 30 days. Though this ceiling case underwent several adjournments, he has not produced any records to substantiate his claims.

In the above circumstances, the Taluk Land Board has no other go than to reject the claim of this respondent.

6(XV) :- R.110, Thayyil Babi (Devassia alias Augustian alias Sebastian alias Thayyil Babi Augustine) in his claim statement dated 6.7.95, filed through Adv. Jose Joseph has stated that he has 8 acres of land in Prely, Sy.No. 1687 pt. of Sholayur village, which was purchased from his father, Thayyil Augusty; his brother Thayyil Augustin; and Vadakke Mulanhanal George S/o Devassia; who obtained lease hold right over the properties during 1962 directly from the jenmi Mannarkked Mooppil Stanam and thereafter they got certificate of purchase from the Land Tribunal; Agali as shown below:

George S/o Devasia, Vadakke Mulanhanal to Rl. 110) and photostat copy of certificate of purchase No.889/77 dated 16.12.77 in SM. No.1416/77 of Land Tribunal Agali, issued to one Sri. Joseph Augustin, Thayyil, Kurayampady. He has also stated that the remaining documents are pledged with the Bank for having availed Agricultural loan facilities and will be produced later. He has further stated that he has raised cultivation in the 8 acres of land like pepper, Rubber, Coffee, coconut and Arecanut trees etc. and that the land may be excluded/deleted from this ceiling case.

The Taluk Land Board considered the claim raised by R.110 in detail. He has not produced the C.P. in respect of the 3 acres of land purchased as per Teer Deed No. 2x 394/1987, dated 29.5.1987 of SRO. Agali. So also he has not produced the Teer Deed in respect of the land shown in the certificate of purchase No.889/77 dated 16.12.77 of Land Tribunal, Agali. Jose Joseph in which he stated that 1 acre of land in Sy.No.1687 pt. of Sholayur village was purchased by him as per Jenmam Teer Deed No. 439/1985, dated 24.3.1985 of SRO Agali from Sri.Kunhappen S/o Madathi-parambil Kurakko, Kuravampady, who obtained certificate of purchase No.966/1978 dated 30.5.1978 in S.M. 921/1978 of the Land Tribunal, Agali, that he is residing in the land with family duly constructing house and cultivating coffee, pepper, areacanut, jackfruit tree; Mango tree etc. He has produced photo copies of the Teer Deed and certificate of purchase and requested to exclude the said 1 acre of land from the ceiling area in this case.

The Taluk Land Board finds no reason to disbelieve the contentions of the claimant. No fraud or collusions have been levelled against the documents produced in this

case. Hence it is decided to delete an extent of 1 acre of land in Prely. Sy.No.1687 part of Sholayur village from the account of the declarant.

6(XVII):- R.119, Attappat Thomas Joseph alias Babi, S/o. Joseph, Kuravampady, Sholayur village has filed counter statement dated 4.5.95 through Adv. Jose Joseph, in which he stated that he obtained jenmam right over 6.20 acres of land in Prely.Sy.No.1687 part of Agali Village, as per Teer Deed No. 384/1987 dated 26.5.1987 of SRO, Agali from Sri.Attappat Avira's Son Joseph, Kuravampady who has obtained certificate of purchase No.14/1978 dated 18.2.78 in SM 1308/1977 of Land Tribunal, Agali for an extent of 7 acres of land in Sy.No. 1687 part of Sholayur village. On a previous occasion he filed counter statement dated 17.3.94 directly, along with a copy of CP.No.14/1978 in which also he raised the same contentions. R.119 has also stated that he is residing in the land with family duly constructing house and cultivating the land with coffee, Pepper, Coconut, Arecanut, Teakfruit tree; Rubber etc. He has produced photocopies of the Teer Deed and C.P. and original Basic Tax receipts (5 Nos) for the period from 1969-70 and requested to exclude the above said 6.20 acres of land from the ceiling area of the declarant.

The Taluk Land Board finds no reason to disbelieve the claims put forth by the R.119 in this case. No allegations against the records produced to the effect that the CP was obtained on fraud or collusions have been brought to notice. In the circumstances, the Taluk Land Board decided to delete an extent of 6-20 acres in Prely. Sy.No. 1687 pt.of

6 (XVIII): - R. 120, Attappett. Xavier alias Appachen S/o. Mathai Koravampally, Sholayur Village, filed counter statement on 27.4.95, and documents in support of claims on 15.6.95, through Adv. Jose Joseph, in which it is stated that his father Mathai obtained lease hold right over certain lands in Prely. Sy.No. 1687 Pt of Sholayur Village during the year 1960 directly from Mannarkkad Mooppil Stanam and cultivated the land with cocobut, arecanut, Coffee, Pepper, Cardamom, Jackfruit and Mango Trees and during 1970 set apart 5 acres of land to R. 120, who obtained certificate of purchase No. 762/1977 dated 19.9.77 in S.M. 598/77 of the Land Tribunal No. II Agali and thereafter he is remitting Basic Tax for the land. He has added that after selling certain portion from the said 5 acres during 1986, he is now possessing and enjoying 4.10 acres in the above said Sy.No. and hence it may be excluded from the ceiling area of the declarant in this case. He has produced M.R. receipt No. 188 of Book No. 2 dated 10.2.1962 of the Mannarkkad Mooppil Stanam in original, Photocopies of C.P. No. 762/1977 and B.T. receipt (One No.) for the year 1986-87 and 1987-88. to substantiate his claims.

The Taluk Land Board finds no reason to disbelieve the documents produced by the declarant in this case. There are no allegations levelled against the obtaining of CP that it is obtained on fraud or collusion. Hence the Taluk Land Board decided to delete an extent of 4-10 acres in Prely. SY. No. 1687 pt. of Sholayur Village from the account of the declarant.

6. (XIX): - R-123, Kunnothasertil Kumaran S/o. Unnoora, Kurovampady, Chittur, Sholayur Village in his counter statement filed on 27.4.95 through Adv. Jose Joseph (and documents produced on 15.6.95) has stated that he obtained lease hold right over 4 acres of land in Prely.Sy.No.1687 Pt.of Sholayur Village; during the year 1960 directly from the Jenmi Mannarkkad Mooppil Stanam and he is continuously remitting Basic Tax for the land, and cultivating Coffee, Pepper, Coconut, Arecanut, Jackfruit and Mango trees etc. in the land and that he has obtained certificate of purchase No.969/1978 dt. 30.5.1978 in SM.924/78 of the Land Tribunal Agali. Hence it is decided to delete an extent of 4 acres of land in Prely.Sy.No.1687 pt.of Sholayur Village from the account of the declarant company.

6 (XX): - R.130, Mathachan, (Mathew) S/o. Joseph, Puthenpurayil, Chittur P.O. Kurovampady, Sholayur Village in his counter statement filed on 15.6.95 through Adv. Jose Joseph has stated that he obtained leasehold right over 5 acres of land in prely.Sy.No.1687 part of Sholayur Village, during the year 1962 directly from Mannarkkad Mooppil Stanam, that he is residing in the land with family after constructing house, cultivating

the land with Pepper, Mango trees, Jackfruit trees, Coffee, Cashew Trees etc., aged about 34 years and that he has obtained certificate of purchase No.1908/78 in S.M.1124/77 of the Land Tribunal, Agali. He has also stated that the C.P. has been pledged with the S.B.I. Agali Branch for availing Agricultural Loan facilities during 1984 and hence the patta could not be produced as evidence. - But he has produced T.R.5 receipt No.19 of Book No.1732 dated 22.2.1978. (in original) issued by the Land Tribunal Agali in token of having remitted the purchase price of Rs.45/- in SM.1124/77 and 3 B.T. receipts in original and requested to exclude the aforesaid 5 acres of land from the ceiling area of the declarant company.

The Taluk Land Board has perused the records and found nothing to disbelieve the contentions of the claimant. There are no allegations that the C.P. was obtained on fraud or collusion. Hence the Taluk Land Board decided to delete an extent of 5 acres of land in Prely, SY.No.1687 pt. of Sholayur Village from the account of the declarant:

6 (XII) - R.138; The rekkannei Ebbi Joseph S/o Joseph, Kuravempdy, Sholayur, filed counter statement on 12.1.95 through Adv.A.R. Sahib in which he has stated that 1-59 acres of land in Prely, Sy.No.1687 pt. of Agali Village was purchased by him as per jenman Teer Decd No.598/1987 of SRO Agali from ~~as per jenman Teer Decd No.598/1987 of SRO Agali from~~ Sri. In the absence of records to prove the claims, in the case of this Respondent, the Taluk Land Board decided to reject the claims.

6. (XIII):- R.144, Sebastian alias Devassis, S/o. Paul Vallanod, Kuruvampady, Sholayur Village, in his counter statement filed on 15.6.95 through Adv. Jose Joseph has stated that he has got title over 4.50 acres of land in Prely. Sy. No. 1687 part of Sholayur Village, that it is included in the 10 acres of land for which his father obtained certificate of purchase No. 961/1978 dated 30.5.78 in S.M. No. 913/78 of the Land Tribunal, Agali, who obtained leasehold right over the 10 acres of land, directly from the jehmi Mannarkkad Mooppil sthanam during the year 1962. R.144 also stated that as per the Avakasa Ozhimuri Deed No. 5475/1981 dated 16.10.81 of S.R.O. Mannarkkad, executed by his father Paul, 9 acres of land from out of the 10 acres came into the hands of himself and his brother George, and as per partition deed No. 208/1988 dt. 7.5.88 of S.R.O. Agali entered in to by R-144 and his brother George, 4 acres from out of 9 acres came in the possession of R.144. He is residing in the said property with family after constructing house and cultivating the land with Pepper, Coconut, arecanut, Coffee, Mango trees etc.

In addition to the above 4 acres of land, an extent of 10 cents in Sy. No. 1687pt. of Sholayur Village was purchased by R.144 from Sri. R.D. Antony -/o. R. theekal Devassia, Kuruvampady

As per Teer Deed No. 437 of 1989 dated 10.7.1989 of SRO, Agali
 but on a perusal of the photocopy of the said Teer Deed, it is
 seen that Sri. P.D. Antony has not obtained certificate of purchase
 for the said 10 cents of land, and hence his claim is
 rejected.

R 144 has produced photocopies of the above said 3 Nos. of
 documents, photocopy of C.P. No. 961/1978 and B.T. receipt (3 Nos)
 in original and requested to exclude 4-50 acres from the ceiling
 area of the declarant.

The Taluk Land Board has examined the records produced and
 found that the claims of the respondent with regard to 4 acres
 of land is sustainable, since there are no allegations levelled
 against the obtaining of C.P. that it was given on fraud or
 collusion. But his request to exclude/delete, 50 cents more
 from the account of the declarant has got no concrete footing and
 hence his claims with regard to 50 cents of land is rejected.
 His claims with regard to 4 acres of land in prely. Sy. No. 1687 pt.
 of sholayur Village is allowed and the same will be deleted from
 the account of the declarant company.

6 (XXIII):- R. 145, George Vallanadan, S/o Paul and brother of
 R-144 mentioned in para 6 (XXII) above, expired on 3.11.1993. His
 wife Smt. Leclamma George filed impleading petition on behalf of herself
 herself and as natural Guardian and next friend of her children
 larji (17 years old) and Babu Paul (15 years old) through Adv. Jose
 Jose Joseph on 15.6.95 which is admitted and they are impleaded
 as supplemental R. 174, 175 and 176 respectively. Smt. Smt. Leclamma
 George filed on 15.6.95 itself counter statement with documents,
 on behalf of herself

and her minor Children, through Adv. Jose Joseph. Her claims with regard to 4 acres of land in prely. Sy.No.1687 pt. of Sholayur Village is same as that of R.144 described in Para 6(XXII) above and hence it is not repeated here. Accordingly, the Taluk Land Board decided to delete an extent of 4^(four acres) acres in Prelu. Sy.No.1687 pt of Sholayur Village, from the account of the declarant company, since it is derived to the hands of her late husband George as per partition deed No.208/1988 dated 7.5.88 of SRO, Agali with jenmam right.

But as regards her claim for 50 cents over and above the said 4 acres; it is seen that Smt. Leelamma George (R-174) purchased it from E.K. Kuriakose S/o Ettupamkal Kuriakose as per Jenmam Teer Deed No.299/1988 dated 24.7.88 of SRO, Agali who is said to have obtained jenmam right over the said property assigned in his favour as per certificate of purchase no.1055/1978 dated 3.6.78 in SM.1027/78 of SRO, Agali. She has not produced the C.P. in support of her claims. Hence the Taluk Land Board decided to reject her claim with regard to the above said 50 cents of land.

6(XXIV):-R-157, C.V. Mulk, Sholayur (residing at Bharathi Park Road, Sai Baba Colony, Coimbatore II) filed counter statement through Adv.K.S.R.Unni, in which it is stated that the land in his possession extending to 300 acres belonged in jenmam to Mannarkkad Mooppil stannam, from where R-157 obtained lease hold right as per Registered lease deed No.244/1955 dated 17.2.1955 of SRO, Mannarkkad. He added that as per permit No.D.Dis.34324/54 dated 24.1.1955 obtained for lease; and as per D.Dis.No.88 No.9453/55 dated 12.5.1955 of the collector of Malabar for

clearfelling in 1955 for Cardamom, Sri.M.C. Chandi obtained licence for clearfelling and done the work without any allegations. As per the proceedings No.A3.2157/57 dated 26.2.1958 of the District Collector, Palakkad, R.157 obtained clearfelling permit for 50 acres from the lease hold property of 300 acres and after clearfelling, planted the land with Coffee, Cardamom etc. It is also stated that the property was subjected to litigation for arrears of rent etc., in the sub Court, Ottappalam, filed by Mannarkkad Mooppil Stanam and according to the judgement dated 17.4.1980 in OS.103/1976 of the Sub Court, Ottappalam, the leasehold right was upheld. R.157 has produced attested photo-state copies of the Registered lease deed; order of the Collector of Malabar; proceedings of the District Collector, Palakkad and judgement of the Sub Court, Ottappalam in support of his claims.

The total extent of land in the possession of R.157 as shown in the revised draft statement dated 22.7.93 after conducting details survey of the land and physical verification of the Authorised officer is 310 acres. The Taluk Land Board considered all the relevant records and claims of the Respondent and decided to delete an extent of 300 acres, shown in the Registered lease deed No.244/1955 from the Account of the declarant company.

As regards the remaining 10 acres of land, shown in the recised draft statement no records/proof have been produced by R.157 to substantiate that he is entitled to possess the same and hence that extent of 10 acres will be retained in the account of the declarant company.

The S.D.T. (Authorised Officer) of the Taluk Land Board will enquire and verify whether R.157 is holding the 300 acres of land as plantations and whether S.M. action will have to be initiated.

6(XXV):- R.158, Pathanapuram Thomas, Kozhikkodamkarayil, Sholayur village has filed counter statement on 26.8.93 in person, in which he has stated that 5 acres of land in prely. Sy.No.1724 of Sholayur Village is belonging to him in lease hold right directly from the Mannrakkad Mooppil Stanam, that he is residing in the land with family after constructing house and cultivating the land. He has added that he has obtained certificate of purchase for the land from the land Tribunal, Agali and that the M.R., receipt, C.P. etc. will be produced within 30 days. But he has not produced any records in support of his claims so far, though this ceiling case under went several adjournments. No land in prely.Sy.No. 1724 of Sholayur Village is shown as in the possession of others in the revised draft statement dated 22.7.93. Hence the Taluk Land Board decided to reject the claims of Rs.158.

6(XXVI):- R.159, Raman Maistry S/o Velayudhan; Kozhikkodamkarayil, Sholayur Village, filed counter statement on 26.8.93, stating that 3 acres of land in Prely.Sy.No.1687 pt.

of Sholayar Village came to his possession and enjoyment on leasehold right directly entered into by him with the Jami Mannarkkad Mooppil Staan, that he has constructed house in it and residing there with family and that he has obtained certificate of purchase from the Land Tribunal, Agali. He has promised to produce M.R. receipt, Pattayas etc. within 30 days, but has not done so far, though this ceiling case was adjourned to several times and the Respondent was given sufficient opportunity to produce the records, In the absence of relevant records, the Taluk Land Board decided to reject the claim.

6(KXVU):- Supplemental S.177 Smt. Lissy D/o Sottathode Maliyokkal Joseph, Poovarankarazhil, Meechil Taluk, Kottayam District, filed Vakalat and imploding petition; through Advocate Jose Joseph. The imploding petition is allowed and Smt. Lissy has been imploded as supal. S.177. In the counter statement filed on 6-7-95, she has stated that she obtained title over the land in Freely. Sy. No. 1687 Pt. of Sholayar Village, with an extent of 2 acres, as per Teer Deed No. 4934/85 dated 31-10-85 of S.R.C. Mannarkkad from Sri. Mathai S/o Chacko Attoppat; Kuravappady whose father Sri. Chacko obtained leasehold right over the land and ~~and~~ some other extent of land from the Jami Mannarkkad Mooppil Staan during 1962; that Sri. Chacko gave 7 acres of land to his son Mathai; and that Sri. Mathai obtained C.F. The Taluk Land Board has examined the claim of the Suppl. B-178 with reference to the documents produced and found no reasons to disbelieve the contentions raised by him. No fraud or collusion is alleged against the documents; C.F. etc. produced in this case. Hence it is decided to delete an extent of 4 acres in Frely. Sy. No. 1687 Pt. of Sholayur Village from the account of the declarant company in this case.

6 (XXIX):- Suppl. B-179, Sri. George Mathew S/o Mathew, Attappat Vettil, Kurayampady, filed vakalat and impleading petition on 6-7-95, through advocate Jose Joseph. The impleading petition is allowed and Sri. George S/o Attappat Mathew, Supplemental B-179 filed counter and document on 6-7-95 itself, in which he says that his father Attappat Mathew obtained leasehold right over certain portions of land in Frely. Sy. No. 1687 Pt. of Sholayur Village during 1962, directly from the Jemmi Mannarkkad Moopill Stana and

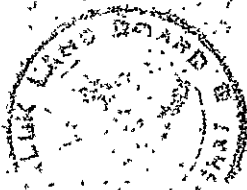


