ORDER

As per the Government Order read above, periodical surrender of Earned Leave during the current financial year was deferred till 31-05-2021. In view of the severe impact on the economy created by the second wave of Covid-19 and the need to conserve resources to fight against the pandemic, the periodical surrender of earned leave by employees and teachers including those on temporary appointments will be deferred for a further period of six months with effect from 01-06-2021.

2. This will apply to all bills pending with treasury as on the date of this order. Sanctions already issued, which are pending encashment will be cancelled and earned leave will be re-credited to the leave account of the respective employees.

3. This order will be applicable to the employees of various Universities in Kerala, Grant in Aid Institutions, Autonomous Bodies, Statutory Undertakings, Welfare Boards, Apex Societies and Public Sector Undertakings.

4. Last grade servants (including Office Attendants in Subordinate Services), Part-time Contingent Employees and Municipal Contingent Employees will be exempted from the operation of this order.

5. It is further clarified that this order will not affect admissible terminal surrender of earned leave.

6. All Heads of Departments / Drawing and Disbursing Officers and Treasury Officers will ensure strict compliance of this order.


