In Exercise of the powers conferred by sub-section (1) of section (2) of the Kerala Public Services Act, 1968 (19 of 1968), and in supersession of the Special Rules for the Kerala General Education (District Institute of Education and Training) State Service Rules, 2011 issued under G.O. (P) No. 57/11/G.Edn. dated 26th February, 2011 and published as S.R.O. No. 171/2011 in the Kerala Gazette Extraordinary No. 471 dated 28th February, 2011 and the Kerala General Education (District Institute of Education and Training) Subordinate Service Rules, 2011 issued under G.O. (P) No. 58/11/G.Edn. dated 26th February, 2011 and



published as S.R.O. No. 172/2011 in the Kerala Gazette Extraordinary No. 472 dated 28th February, 2011, the Government of Kerala hereby make the following Special Rules for the Kerala General Education (District Institute of Education and Training) State Service, namely:—

### RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala General Education (District Institute of Education and Training) State Service Special Rules, 2021.

(2) They shall come into force at once.

2. *Constitution.*—The service shall consist of the following categories, namely:—

*Category 1* — Principal, District Institute of Education and Training

*Category 2* — Senior Lecturer

*A. Pre-service Teacher Education and Teacher Professional Development Division*

(1) Senior Lecturer in Language

(2) Senior Lecturer in Science

(3) Senior Lecturer in Humanities

(4) Senior Lecturer in Commerce, Vocational Education and Foundations of Education

(5) Senior Lecturer in Physical Education and Art Education

*B. Planning, Technology and Assessment Division*

(6) Senior Lecturer in Educational Technology and Material Development

(7) Senior Lecturer in Planning, Assessment and Evaluation.

*Category 3* — Lecturer

(1) Lecturer in Malayalam

(3) Lecturer in Hindi

(4) Lecturer in Arabic

(5) Lecturer in Urdu

*Note 1.*—The ratio of Lecturers in the subjects Arabic, Urdu and Sanskrit in all the District Institute of Education and Training at a given time shall be in the ratio 6:3:5. Lecturers in the subjects Arabic, Urdu and Sanskrit shall be appointed in the manner that only one lecturer in any one of the subjects shall be appointed in one district at a time.

*Note 2.*—Lecturer in Kannada shall be recruited and appointed only in the Revenue District of Kasaragod and Lecturer in Tamil shall be recruited and appointed only in the Revenue Districts of Palakkad, Idukki and Thiruvananthapuram.

3. *Appointment.*—Appointment to the categories specified in column (2) of the Table below shall be made by the method of appointment specified against each in column (3) thereof:

*Note 1.*—Appointment to each of the sub-categories in category 3 (1) to (24) shall be in the ratio 1:1 by direct recruitment and by transfer through Kerala Public Service Commission. Appointment by direct recruitment shall be on State wise basis.

*Note 2.*—In the case of appointments by transfer, a ratio 2:1 shall be maintained from the following two units, namely:—

- (i) Appointed as Teachers in Government Primary School and continuing service as a Teacher.
- (ii) Appointed as Teachers in Government Higher Secondary School, Vocational Higher Secondary School, High School and Teacher Educators in the Institutes of Teacher Education and continuing service as a Teacher.

*Note 3.*—If qualified hands are not available in item number (i) of *Note 2* above, the vacancies shall be filled up from item (ii) and *vice versa*. In the absence of qualified hands in items (i) and (ii) above, the vacancies shall be filled up by direct recruitment.

4. *Appointing Authority.*—The appointing authority for all the categories shall be the Government.



5. *Qualifications.*—No person shall be eligible for appointment by promotion or by transfer or by direct recruitment to the categories specified in column (2) in the table below under the method of appointment specified in column (3) unless he possesses the qualification prescribed in the corresponding entry in column (4) thereof, namely:—

6. *Probation.*—Every person appointed to any of the categories specified in these rules shall from the date on which he joins duty, be on probation,—

(i) if appointed by direct recruitment or by transfer for a total period of two years on duty within a continuous period of three years; and

(ii) if appointed by promotion, for a total period of six months on duty within a continuous period of one year.

7. *Age limit.*—No person shall be eligible for appointment by direct recruitment if he has not completed 22 years or if he has completed 40 years of age on the first day of January of the year in which the applications for appointment are invited. Usual relaxations in upper age limit shall be allowed to candidates belonging to the Scheduled Castes/Scheduled Tribes and other Backward Classes. Upper age limit for appointment by transfer shall be 50 years as on the first day of January of the year in which the applications for appointment are invited.

8. *Reservation.*—The rules regarding reservation of appointment contained in rules 14 to 17 in part II of the Kerala State and Subordinate Services Rules, 1958 shall be applicable to appointments by direct recruitment to the sub-categories in Category 3.

9. *Savings.*—(1) Every person appointed as Principal or as Senior Lecturer or as Lecturer by the competent authority, to make such appointment in accordance with the rules or orders existing at the time of making such appointment, shall be regularized in the category of Principal, Senior Lecturer or Lecturer, as the case may be, from the date of such appointment in the Kerala General Education (District Institute of Education and Training) State Service.

(2) Existing employees to any of the categories included in these rules either by direct recruitment or by transfer or by promotion by the competent authority shall be exempted from acquiring the qualification and experience specified for that category of post specified in these rules.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The services in the District Institute of Education and Training in the State were governed by the Kerala General Education (District Institute of Education and Training) State Service Special Rules, 2011 and the Kerala General Education (District Institute of Education and Training) Subordinate Service Special Rules, 2011 issued under G.O. (P). No. 57/11/G.Edn. dated, 26th February 2011 and published as S.R.O. No. 171/2011 in the Kerala Gazette Extraordinary No. 471 dated 28th February, 2011 and G.O. (P) No. 58/11/G.Edn. dated 26th February, 2011 and published as S.R.O. No.172/2011 in the Kerala Gazette Extraordinary No. 472 dated 28th February, 2011 respectively. Complying with the guidelines issued by the Ministry of Human Resource Development (MHRD) and National Council for Teacher Education (NCTE), that Lecturer in District Institute of Education and Training have to be conferred the Status of Gazetted Officer and also considering the fact that the Lecturers in the District Institute of Education and Training have equivalent rank of Assistant Educational Officers in the State Service which is also a Gazetted post, Government have decided to frame Special Rules by creating District Institute of Education and Training as a State Service by including Lecturer, Senior Lecturer and Principal by superseding the existing Special Rules for State and Subordinate Services. Government have also decided to revise the qualifications for appointment to various categories in the District Institute of Education and Training in accordance with the guidelines issued by the Ministry of Human Resource Development (MHRD) and National Council for Teacher Education (NCTE) norms.

The notification is intended to achieve the above object.
